MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding ("MOU") is entered into on 1ST NOV 2024

Between:

Raydium Exchange, having its principal office at [St. Enoch Centre, Saint Enoch Square, Glasgow, UK]

And

[Universite de Paris], having its principal office at [85 boulevard Saint-Germain in the 6th arrondissement of Paris]

Collectively referred to as the "Parties".

1. Purpose

The purpose of this MOU is to establish a collaborative partnership between Raydium Exchange and [Universite de Paris] to:

- Provide internship and placement opportunities to students.
- Conduct workshops, training sessions, and industry-oriented programs in blockchain, cryptocurrency, and related technologies.
- Support mutual academic and professional development initiatives.

2. Scope of Collaboration

The Parties agree to collaborate in the following areas:

- 1. Internships & Placement
- Raydium will offer internships and placement opportunities to qualified students of the University.
- Internship duration, stipend, and post-internship opportunities will be defined in separate offer letters.
- 2. Training & Workshops
- Raydium may conduct workshops, webinars, and technical training sessions for students and faculty.

3. Research & Projects

- Joint research initiatives, capstone projects, and case studies may be undertaken for mutual benefit.

3. Responsibilities of Raydium Exchange

- Provide guidance and mentorship to students selected for internships.
- Evaluate student performance and provide feedback.
- Ensure compliance with all applicable legal and regulatory requirements in the execution of internships and placements.

4. Responsibilities of the University

- Identify eligible students for internships and placements.
- Facilitate communication between students and Raydium Exchange.
- Ensure students adhere to Raydium Exchange's rules, code of conduct, and policies during internships.

5. Duration and Termination

- This MOU shall be valid for [3 years] from the date of signing.
- Either party may terminate this MOU by providing [9 months] written notice.
- Termination will not affect ongoing internships or projects unless mutually agreed.

6. Confidentiality

Both parties agree to maintain the confidentiality of proprietary information shared during the course of collaboration and not disclose it to any third party without prior written consent.

7. Legal Status

This MOU is not a legally binding contract but serves as a statement of intent to collaborate in good faith. Any legal obligations shall be formalized in separate agreements or contracts.
