Our Projects

Digital Safety for Students in Tunisia

D4S project is a series of workshops dedicated to international students living in Tunisia aiming to raise their awareness about digital safety and the best tools to use. In addition to providing the space for a digital clinic for their connected devices to maximize safety.



Strengthening the Digital Space in Tunisia

This project consists of a series of interactive workshops addressed to civil society and public institutions in order to raise their awareness regarding digital security. It's also addressed to media outlets to help prevent cyber attacks on journalists and bloggers.



Salamat Helpline

In 2019 SECDEV launched Salam@ which helped over **11000** online users in the MENA region. As Digital Citizenship continues the legacy work of **Salamat**, we **helped over 200 cases**. Digital Citizenship is pleased to continue supporting online victims to report online violence and abuse and seek legal and psychological help. The Digital Citizenship helpline team is available on social media as well as via emails.



Digital Clinic Services

Digital Clinic Services aim to help entities and groups **ensure their online security and the online security of their clients and members**. The Digital Clinic Services team includes **experts in cyber security** and online safety who deliver training sessions on how to safely and responsibly use social media and digital work tools. Our team works closely with tech companies such as META (Facebook, Messenger, Instagram), X/Twitter, and TikTok for smooth reporting and support.



Advocacy

Osama Khalid and Ziyad Al Sufiani Release movement

Joining ventures with international organizations, Digital Citizenship is advocating for the release of Osama Khalid and Ziyad Al Sufinai, the online freedom of expression detainees in the Kingdom.



Support to Farah Jack Mustkalem

We issued a statement of support to Farah Jack Mustaklem, Digital Citizenship advisory board member, in his fight against disinformation in the Wikimedia projects. Mustaklem has been subject to hatred attacks since the beginning of the war on Gaza. The attacks increased following his candidacy to join the Wikimedia Foundation Board of Trustees in the summer of 2024.



Tell social media companies: improve your content moderation practices for SRHR content

Digital Citizenship joins SMEX and other organisations in the call on social media companies to enforce all necessary measures to ensure that SRHR content is protected online. This includes in particular performing human rights due diligence including examining their policies' and practices' impacts on SRHR, as well as addressing reports of bias toward the MENA region and its languages and dialects. Platforms must also increase their transparency regarding all issues related to SRHR, including how they moderate SRHR-related content.

Call for Immediate Ceasefire in Lebanon - [Joint Statement](#)

Digital Citizenship along with 30+ national and international organizations issued a call to request immediate ceasefire in Lebanon. Shortly after the statement was released, a cease-fire deal was sealed.



Advocacy

Joint statement: Civil Society Demands Action Ahead of Internet Governance Forum

Joining human rights organizations to urge the Kingdom to release people imprisoned for their online expression and foster transparency and accountability ahead of the Internet Governance Forum (IGF) 2024.

Open Letter from Salama Group

Digital Citizenship signed the Salama Group's Open Letter urging to develop, test, adopt and govern AI for the benefit of humanity



100 days of tech platforms failure

Digital Citizenship, an active member of the Global Coalition for Tech Justice along with other NGOs, urged tech platforms to adopt and apply comprehensive measures to safeguard people and elections during the 2024 election cycle and into the future, applying principles of global equity.

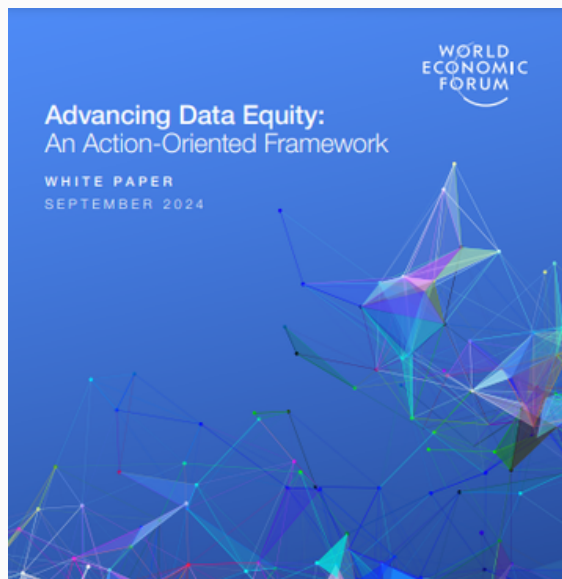
