

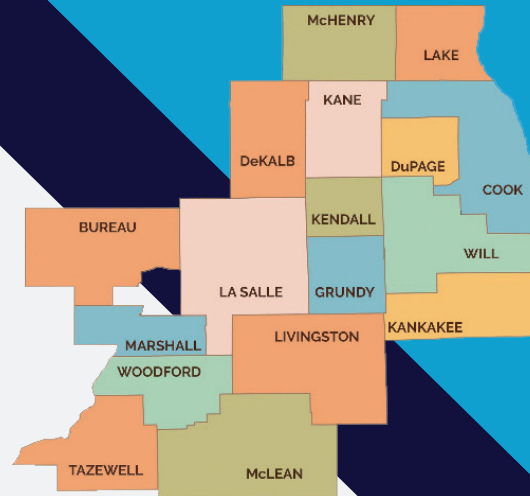

**Reduction of Hospital Readmissions.** When providing home health to a patient who has recently returned home after a hospital stay, we use a multi-pronged approach to successfully transition patients to the home.
