("Bylaws") to correct all references to 'Red Oak Ranch' and instead replace same with 'Northcrest Ranch,' recognizing that this was most likely a ministerial error made by the original drafter(s) of the Bylaws; and

WHEREAS, pursuant to Article X of the Bylaws, the Bylaws may be amended at a regular or special meeting of the Board by an affirmative vote of a majority of a quorum of the directors present in person; and

WHEREAS, a quorum of directors was present in person at the board meeting to vote on the proposed amendments; and

WHEREAS, during the course of business, an affirmative vote of the directors was taken approving the proposed amendments to the Bylaws, pursuant to Article X of the Bylaws;

NOW, THEREFORE, BE IT RESOLVED, that the Association, acting by and through its Board of Directors, hereby adopts this Amendment of the Bylaws of Northcrest Ranch Property Owners' Association, Inc. as follows:

Article II, Section 10(i) is hereby amended to read:

"Section 10. Powers and Duties. The Board shall have the following powers and duties:

(i) to collect all assessments and charges provided for in any covenants and restrictions imposed in the Northcrest Ranch Subdivision at such time as Developer assigns said right to the Association pursuant to the restrictions, and to use the proceeds therefrom for the purposes set forth in such covenants and restrictions and in the Articles of Incorporation of the Association;"

Article II, Section 10(j) is hereby amended to read:

"Section 10. Powers and Duties. The Board shall have the following powers and duties:

(j) to enforce all covenants and restrictions imposed in the Northcrest Ranch Subdivision;"


