Instructions for use



1. Wash your hands before touching the mask.



2. Ensure the colored side of the mask faces outwards, the nose clip upwards, and secure the ear loops on each side.



3. Bend the nose clip to match the shape of the nose.



4. Pull the bottom of the mask under your chin to ensure a secure fit.



Do not touch mask once in position. Discard mask if wet or soiled.

Storage	Store the mask in the original package, away from contaminated areas, dust, sunlight, extreme temperature, moisture and harmful chemicals. Store between -20°C and 30°C (-4°F and 86°F) with relative humidity below 80%.
