1. The decision to accept the application of a potential member shall be at the sole discretion of SENUKCHAM. SENUKCHAM reserves the right to verify or require proof of all information given in order to obtain membership and any fraudulent or wrongful information given in order to obtain such membership could result in the cancellation of all membership rights and lead to the repayment of all monies due to SENUKCHAM.
2. The acceptance by SENUKCHAM of an application for membership of the Chamber shall constitute a legally binding agreement between the member and SENUKCHAM. The member hereby agrees also to be bound by the rules of the Chamber which are in force at the time.
3. Completion of your details implies acceptance of the provisions contained within the Data Protection Act.
4. All business opportunities and information provided by the Chamber remains confidential to SENUKCHAM members unless otherwise stated and may not be shared with any organization outside of the chamber membership.
5. Member agrees that all rights in any rules, codes, papers, reports, training materials, or other works produced by SENUKCHAM commissions, task forces or other groups are collective works initiated by the chamber in which SENUKCHAM holds all rights. I/my organization further agree(s) that any individual contributions that I/any representative of my organization may make to such works will not give rise to any rights in such collective works.
6. Members cannot sell, assign or transfer their membership.
7. Membership of the Chamber shall be for a 12 months period running from 1 January until 31 December each year.
8. All types of membership shall be subject to these Terms and Conditions of Membership.
9. Other categories of membership may be stipulated by SENUKCHAM from time to time.
10. SENUKCHAM reserves the right to change the benefits of membership at their discretion.
11. All members shall pay an annual subscription fees which shall accrue from the date of joining and on 1 January each year thereafter. The subscription shall be payable within 30 days from receipt of an invoice, which shall not be presented earlier than 1 November of the preceding year. The rights and privileges of membership shall be dependent upon receipt of payment of the annual subscription fee.
12. Non-payment of the subscription fees may result in suspension and/or termination of membership at the discretion of SENUKCHAM board.

18. The member can terminate their membership by giving one month's written notice to SENUKCHAM, to expire at the end of the relevant twelve months period.
19. The directors of SENUKCHAM may terminate the membership of any member: without notice and with immediate effect if the member's conduct, whether or not such conduct is the subject of a complaint by another member or group of members, is such that the reasonable opinion of SENUKCHAM, it may be injurious to the character, name or interests of the Chamber or is such that it renders the member unfit to associate with other members of the Chamber; forthwith and without notice if the member shall have committed any material breach of these Terms and Conditions; or without notice and with immediate effect if the member commits an Act of Default.
An Act of Default is:
for a Large Corporate or Small Corporate member: appointment of administrators or receivers; commencement of insolvency or winding up proceedings, voluntary or otherwise; or any proceeding or step taken or any court order in any jurisdiction made which has a substantially similar effect to any of the foregoing;
for an Individual member: declaring bankruptcy; or being convicted of an offence punishable by imprisonment.
20. A member whose membership is terminated by SENUKCHAM shall forfeit all the privileges of membership with immediate effect without an entitlement to any claim for any refund of their membership fee.
