#### **OUR 10 SEPTEMBER GUEST SPEAKER**

#### Lane County Commissioner Pat Farr

**Pat Farr** has a long history of service in Lane County and in Oregon, having held executive management positions in private, nonprofit and public sectors.

Pat and his wife Debi recently celebrated their 50th wedding anniversary, having met while both were students at the University of Oregon. They have three sons: Paddy Farr, a behavioral health therapist; Dr. Evan Farr, a curriculum director for U of O students; and Loukas, a business manager in private industry in San Francisco.

He served in the Oregon Army National Guard as a commissioned officer in the 2nd Battalion 162d Infantry.

He is serving in his fourth term as Lane County Commissioner from North Eugene. With the distinction of being one of only two Commissioners to have also served on the Eugene City Council

(ten years) and one of only two Commissioners to have served in the Oregon Legislature (House of Representatives, District 14) and having served on the Bethel School Board, Farr brings a broad range of experience and multi-jurisdictional public service to his work.

He left the Oregon Legislature in 2005 to become Executive Director of FOOD for Lane County, a

strong local nonprofit that was suffering from diminished public image and fundraising ability following a series of management issues. Under his guidance the nonprofit retained valuable staff and regained its powerful position in service to vulnerable populations. In his first year FFLC distributed over 6 million pounds of food to Lane County families and households. In October 2006 he received Congressional acclamation and was recognized on the Floor of the US Senate for "Having dedicated himself to bettering the lives of Oregonians."

His private industry work includes nearly two decades of executive management with Jerry's Home Improvement Centers, where he helped the small hardware store become an industry

giant. He was General Manager of the All-In-One True Value chain of Hardware Stores and of Gray's Garden Centers.

- 1. Nominating committee progress
  - John Toensing, Michael Kennedy and Jim Brann (if available) will meet to determine which officer and board member positions need to be filled for 2026, then start soliciting members to fill them. The committee has until 12 October to build the slate.
- 2. Discounted annual dues if paid before 1 January 2026 (i.e., \$30, \$25)
  - A motion was made by Scott Sandgathe to offer a five-dollar (\$5.00) discount on the 2026 annual dues of \$35.00 for anyone paying before 1 January 2026. 2nd VP Dick Kimbell seconded and the motion carried unanimously.
- 3. Luncheon leftovers; we provide to go boxes Pat.
  - Mac's says that our members can take home any leftovers from the buffet at the end of our meetings, but only if we provide the boxes. The Board directed the House Committee to provide take-away boxes.
- 4. Website issues
  - A. The website has had significant increase in visits in the last part of the summer. From 7/23 through 8/23 we had 180 visits. I can only attribute this to the new rolling slides of members that support our community section on the "About Us" page (see article page 6).
  - B. Finally, in review of the data for the website I see that there are hits from MOAA headquarters (just 2)... nonetheless we are being visited by a number of folks for a variety of reasons. We continue to see requests from organizations to include a link on our Veteran Resource page that offer "resources for veterans" which end up being For Profit Businesses or Attorney-based websites that capture visitors information in hopes to bring business their way rather than offering unbiased help. My focus for the Resource page is that we DO NOT offer any resources that are out of our local area; only verified government-related sites or for organizations that serve our veterans as non-profits. As Pat Harris can attest, I am non-negotiable with this requirement.
- 5. Seven members of the Board volunteered to help at the Lane County Stand Down on 11 and 12 Sep. More volunteers would be appreciated. See poster on page 2.

#### **Greetings from MOAA Government Relations:**

The Major Richard Star Act (H.R. 1282 / S. 344) would fix this inequity by allowing combat-injured servicemembers medically retired with fewer than 20 years of service to receive both their retirement pay and VA disability compensation.

You've already shown your commitment to supporting our nation's servicemembers and their families. Please take one more step today and urge your lawmakers to cosponsor the Major Richard Star Act.

**OREGON INCOME TAX EXEMPTION UPDATE:** Though the Senate and House bills floundered during the 2025 legislative session, Senator Manning still plans to reintroduce the \$17,500 tax exemption for military retirement in the next long session; 2027. With federal funding in flux, the senator is looking to revise the number of Oregon Veteran Retirees to exclude those retirees who already have their military pay exempt.



#### **Veterans History Project**

The Library of Congress has instituted a program to capture the recollections of U.S. military veterans who served from World War I through more recent conflicts and peacekeeping missions, so that future generations may hear directly from veterans and better understand what they saw, did and felt during their service. These personal stories will then be curated and available to anyone, either by visiting the Library of Congress or by accessing the collection online.

The process of conducting the interviews and collecting and submitting the documents and photos (optional) is not overly complicated, but can be so much simpler if someone walks you through it. Hence, Chapter Board member LTC Joe Snyder, PMS of the U of O ROTC, will rouse his Cadets to master the process and help Lane County Veterans prepare their stories for inclusion in the collection. Interviews will start this fall.
