## OLD BUSINESS:

1. ROTC update, Veterans History Project - LTC Joe Snyder  
25-27 Oct fall FTX for ROTC cadets at Camp Rilea; includes CH-47 lift to training sites and orientation over Oregon coast, rappelling, obstacle course, land navigation, engagement skills and hand grenade Assault Course.  
11 Nov, Veterans Day Ruck. 0900 start at ROTC, ruck to Skinner Butte and return; Ruck weight is to be donated food which will later be donated.  
27 Nov CadetGiving event for cadets not going home over Thanksgiving break; 1300 at Agate Auditorium; MOAA invited, bring a holiday-themed dish.  
6 Dec annual Chili Cook-Off at Agate Auditorium, 1200.  
17 Dec fall Commissioning for Cadet Jacob Cahuantzi; details to follow.
2. Dues deadline and luncheon payment status - Elaine Callahan and Ken Evens  
Only four members have not paid their 2024 annual dues.
3. 501(c)3 status - Eric Watkins and Ken Evans  
Eric not available; documents, including MOAA Foundation bylaws, are in progress.
4. Travel reimbursement for 1<sup>st</sup> VP Floyd Bard to attend Regional Workshop was authorized, but no amount was set. MOTION: That a \$1000 maximum travel allowance be authorized for 1<sup>st</sup> VP Bard to attend the regional workshop. So moved by Frank Balazs, seconded by Joe Snyder. Passed unanimously.
5. Bottle/can return program update: Ken Evans prepared an instruction sheet which will be attached to the next newsletter distribution email.
6. Stand Down, report - Floyd Bard  
Lane County Stand Down was bigger than last year. They spent \$15K. Even though they are well funded, they can always use more money.
7. Electronic payments for chapter dues, meals, donations, etc. - Elaine Callahan and Pat Harris  
The idea to use Zelle or Venmo was explored and abandoned as Zelle cannot be used on our bank's business account and Venmo charges fees to use.
8. Veteran Service Fund – Elaine Callahan  
Our Treasurer strongly suggested we start spending some of our accumulated funds, keeping at least \$2000 in reserve for emergencies. A request for ideas raised the following possibilities:  
Housing Our Veterans: Lorie Perkins states a need to repair/replace the laundry facilities at one of the women's facilities. MOTION: Donate \$1500 to Housing Our Veterans to go toward their laundry facility and other housing incidentals. So moved by Floyd Bard and seconded by Ken Evans. Passed unanimously.  
Southern Willamette Valley Honor Flights: Honored Veterans go on the flights for free, but the required "Guardian" must pay \$1200 to accompany them. Though the organization has many volunteer Guardians signed-up, sponsoring one would allow someone to travel who didn't have the necessary funds. MOTION: Donate one Guardian fee of \$1200 to Southern Willamette Valley Honor Flights to allow a person who did not have the funds to travel with a Veteran. So moved by Pat Harris and seconded by Michael Pace.

## BOARD OF DIRECTORS MEETING (Continued)

Passed unanimously.

MOAA Foundation's Crisis Relief Program: Since we had previously donated to this fund, and since it doesn't meet one of our key elements of benefiting local Veterans, the Board declined any action at this time.

Oregon State Military Relief Fund: Since this fund does not meet one of our key elements of benefiting local Veterans or their families, the Board declined any action at this time.

Veterans Memorial Association (VMA) Building Wi-Fi Upgrade: Since the VMA has notoriously weak Wi-Fi throughout the building, it was proposed to donate \$540 to pay Hunter Communications (under contract to maintain the current system) to upgrade and maintain a system that allows Internet access and streaming throughout the VMA property. Ken Evans said he had a working relationship with the company and would explore further before we decide on an amount.

9. MOAA National staff visit to our chapter: President Kennedy is still working on it.

10. MOAA attendance at the 11 Nov Veterans Day parade in Albany – Floyd Bard

The parade is set to have five Veteran units participating, so no formal MOAA contribution is required.

### NEW BUSINESS:

**CHRISTMAS PARTY THURSDAY, 5 DECEMBER**

1. Approve 2025 slate of officers and board members:

A discussion was held on the merits of a Saturday versus Sunday picnic and Saturday was selected. The Board preferred Saturday, 7 June to ensure no conflicts with families' Fathers Day plans.

4. Meal prices increase – Pat Harris

Due to rapidly rising food costs, Mac's Custom Catering is forced to raise our luncheon prices from \$18 to \$20. Anecdotal information noted that Mucho Gusto has raised their catered meals to \$23 per person, and the Eugene Elks are now charging \$20 plus an 18% gratuity. Our Christmas dinner price will also increase one dollar to \$36.

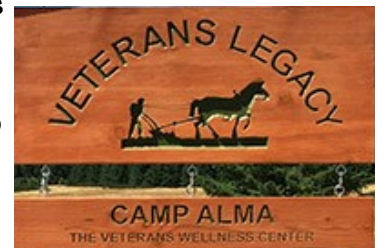
**Steve Yamamori, CEO and President of Reveille Foundation**

## THOUGHTS FROM THE BOARD

---

### Musings from the desk of the Personal Affairs Officer

**H**ello again from Michael Pace, Personal Affairs Officer. Let me ask you some questions. Are you a teen-ager? In your twenties? 40 years old? 60? 80? Over 90? Are you married? Children? Do you belong to any organizations? A church, perhaps? Still employed? Any hobbies that you are absolutely passionate about? Pets? Ok. Enough of that.

Look at your life and the eras that you have lived through. I propose that you may have not looked at each of these facets with this in mind:

All the questions I have asked should have been thought of one way. Have you lived and seen these benchmarks as a “comma” or a “period?” In our teens, many of us might have thought we were invincible and we would wait for life to turn a page and we would just go where it led us. If you do not have access to an old directory and have changed any contact info in the last couple of years, please send that info to Pat.

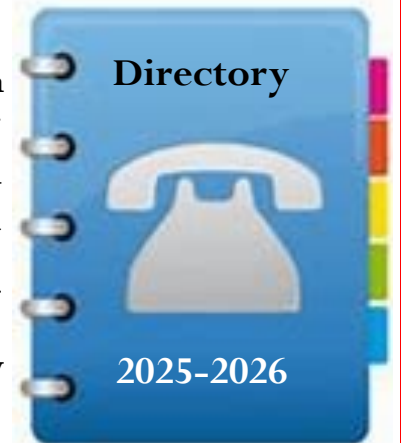

Floyd Bard and Jim Brann report of another excellent Lane County Stand Down that helped Veterans, focusing on those that are homeless.

The year 2024 saw a +24% increase in attending Veterans, including one WWII Veteran and an +45% increase of female Veterans. While not quite up to the pre-COVID numbers (456), the last three years have all seen increasing attendance (271, 285, and now 352). 2025 should continue this amazing trend.

In addition to the overall numbers, there were 20 employers at the Job Fair who referred five Veterans for employment. Four barbers cut hair for over 65 Veterans. The Dental Van saw ten Veterans for 38 dental procedures at a savings of over \$5,000. Massages were available and thousands of items were available in the "candy store."



**Dick and Barbara Heyman** flew to Washington DC on Monday, 7 October, where Colonel Richard M. Heyman, USAAF/USAF (Ret), was inducted into the Royal Air Force Hall of Fame for his exploits as a fighter pilot during World War II. Barbara said they spent three days in DC in the "best suite in the hotel."



They flew on Alaska Air on the way home and, once they were at altitude, the Captain came into the cabin and introduced Dick to all the passengers, saying that he flown in three wars and had just been inducted into the Hall of Fame. And as Barbara said, "The crowd went wild."

They took pictures which they plan to share at the 13 November luncheon. Hopefully we will be able to convince Dick to share that experience when we next see him... as if we could stop him.
