PAST PRESIDENT'S CORNER

Would like to draw your attention to a very interesting two-page article in the October issue of the Military Officer magazine. At the end of our luncheon on the eighth of Octo-

ber, I quickly shared the article, but now I would like to reflect with you on that article.

The article is about Chaplein Emil Kapaun who was in Korea in 1950 and 1951. He was

The article is about Chaplain Emil Kapaun who was in Korea in 1950 and 1951. He was active, helping the wounded and those who were overwhelmed being in a heavy combat area. At the Battle of Unsan, Chaplain Kapaun was captured when he stayed behind during the withdrawal to assist the wounded soldiers.

It was noted in the article that the chaplain appeared to be more pirate than a man of the cloth. "He had a shaggy beard ...and a stocking cap made from a sock." He would steal food to give to the more seriously injured troops. "He defied rules banning religion, praying with soldiers and holding an Easter service...he just continued to give them hope, and that made a huge difference."

In May 1951, Chaplain Kapaun died after "seven months of protest, prayer, and pilfer-age for fellow soldiers. He was 35." After the war his body was returned to his hometown in Kansas. Studies of the survival rate of soldiers showed that the troops Chaplain Kapaun tended "had a significantly higher survival rate then other surrounding camps."

Chaplain Kapaun received a posthumous Medal of Honor, a Bronze Star, and a Purple (Neart for his service in Korea.

As members of the military, we know the significance of a Medal of Honor. Some of us have even been able to talk with those who received that highest medal. The interesting part of this story of Chaplain Kapaun is that earlier this year the Roman Catholic Church declared him "venerable", which is the first step to becoming a saint. This recognition of his ministry and sacrifice is in keeping with the highest tradition of the military in the awarding of the Medal of Honor. In the same way, his religious tradition, in being of service to his fellow soldiers, is leading him to sainthood.
