### OLD BUSIINESS:

- 1. Awards Ken Evans is still working on them.
- 2. House Committee Chair Dick Norton Volunteering Calling Committee has been reconstituted. All previous callers are remaining and some new ones have been added. John Toensing recommended that we need to stay in touch with members and check on their welfare and such, more than once a month. Dick stated this is already being done.
- 3. Re-energize Members: Contact with Habitat for Humanity, others? Dick Kimbell has been in touch with Habitat for Humanity.
- 4. <u>Veteran's Appreciation Golf Tournament</u> Update, Needs, Support Floyd Bard presented an extensive update including budgeting for both revenue and expenses, members of committees he has formed, initial contact with Pine Ridge Golf Course, and must meet deadlines of March 1st for our Golf Committee Chairman (TBD) to meet with Pine Ridge and March 15th for signing of a contract. He will provide written copies of all he discussed to be attached to the minutes.
- 5. Lunch meeting resumption? Veteran's Building is re-opening Saturday, February 27<sup>th</sup>. Ken Evans recommended that maybe we can shoot for April after waiting a few weeks to see if there are any changes to the State's dining-in criteria.

### **NEW BUSINESS:**

- 1. Website Platform Update, Cost, Needs Ginger Banks reported that GoDaddy has a new platform and she must migrate our website to the new one before March 12<sup>th</sup>. It will all be encrypted and should cut down on unwanted visitors. There were 606 visits to the website this past month.
- 2. Golf Tournament Initial Funding pre-authorize an amount? Questions were asked about the purpose of the tournament. This would be a combined event for our Veterans and Military members currently serving, to include the Guard and Reserve. The size of this event would be worthy of media exposure and would really place MOAA in the forefront of being an organization that supports our Military. It has the potential to raise funds that we can feed to Vets in Lane County. Profits could go to our Special Projects Funds and the tournament could possibly help us increase membership in Emerald Empire MOAA. We need to identify who the benefits would go to. We can take past plans to help answer that. Working with other groups will help too. Ken will meet Floyd to discuss the issues and the board will hold a Zoom meeting on March 3<sup>rd</sup> to discuss funding and other questions.
- 3. Corvallis Chapter Active Status and Future? Dick Norton reported that the Corvallis Chapter is no longer valid and would be very difficult to revitalize. There is a lot of money left in their scholarship funds. Maybe we can contact ROTC there and provide assistance with the situation.
- 4. ROTC Awards difficulty through national MOAA. MOAA cannot procure those awards at the moment. We may have a couple of medals and certificates on hand. Chris Warren was asked if they have found a new training area. They are still seeking and only have 4 daylong training labs scheduled in Spring. They do have an FTX this weekend for cold weather training. We may have one scholarship application coming in May. Graduation exercises are in May and that is when we usually have the ROTC dinner.

81st OREGON LEGISLATIVE ASSEMBLY--2021 Regular Session

### **Senate Concurrent Resolution 2**

Sponsored by Senator MANNING JR

### **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

In memoriam: Patrick James Simpson, 1940-2019.

### CONCURRENT RESOLUTION

Whereas Patrick James Simpson was born on August 3, 1940, in Ashland, Oregon, along with his identical twin brother, Donald Alexander Simpson, to Alexander I. Simpson and Patricia Whitney Simpson; and

Whereas Patrick Simpson graduated from Ashland High School in 1958 and the University of Oregon in 1962; and

Whereas Patrick Simpson and his brother participated in the Reserve Officers' Training Corps and were commissioned in the United States Army in 1962 as infantry officers; and

Whereas in July 1966, Patrick Simpson was assigned to the 1st Cavalry (Airmobile) Division in the Republic of Vietnam, where he served for five months on the division staff before assuming command of C Company, 2nd Battalion, 12th Cavalry, for nearly seven months until completion of his tour of duty in July 1967; and

Whereas after serving at Fort Polk, Louisiana, Patrick Simpson returned for a second tour of duty in Vietnam in October 1968 with the Americal Division, where he served as an assistant battalion operations officer and on the division staff; and

Whereas after earning a master's degree at Indiana University, Patrick Simpson served as a physical education instructor at the U.S. Military Academy at West Point, New York, from 1974 to 1977, where he taught boxing and, in 1976, was involved in the integration of women into the Corps of Cadets; and

Whereas Patrick Simpson retired from the Army in November 1988 with the rank of lieutenant colonel after 26 years of distinguished service; and

Whereas Patrick Simpson earned numerous medals and commendations, including the Silver Star, Legion of Merit, four Bronze Stars (two for valor and two for meritorious service), Purple Heart, Meritorious Service Medal, two Army Commendation Medals, Air Medal, Combat Infantryman Badge, Expert Infantryman Badge, Ranger Tab and Parachutist Badge; and

Whereas following his retirement from the Army, Patrick Simpson and his family moved to Eugene, Oregon, where he spent a year at the University of Oregon updating his teaching credential; and

Whereas Patrick Simpson then began his second career as a popular substitute teacher for 20 years, primarily at Cottage Grove High School; and

Whereas Patrick Simpson was active in the West Coast Airborne Association, the Emerald Empire Chapter of the Military Officers Association of America and the Cottage Grove Elks; and

Whereas in 2016, Patrick Simpson was instrumental in bringing the Moving Wall Vietnam Veterans Memorial to Eugene for four days, an event attended by more than 18,000 veterans and members of the public that raised awareness of post-traumatic stress disorder; and

Whereas Patrick Simpson was active with his graduating class at Ashland High School, and he man-SIMPSON, continued on page 8

### **LEGISLATIVE AFFAIRS**

### **MOAA Accomplishments**

"MOAA engages with Congress on all manner of issues related to the uniformed services community." A statement not made lightly to our benefit, whether a MOAA member or veteran with no affiliation. We all benefit. Originally named "The Retired Officers Association of America", later changed to our present name. They have been our advocate storming the hill for over ninety years (1929).

I thought I would thumbnail a list of what our MOAA leadership has accomplished through the years, along with active MOAA Chapters such as ours, and individual members willing to take part in this important mission to the lives of so many veterans.

- Repealing the Widows Tax, saving up to \$12,000 yearly for about 67,000 surviving spouses.
- A game plan for the oversight of DoD's healthcare, protecting continued access to quality healthcare.
- Securing comprehensive privatized military housing reform. This will improve housing, establish a Tenant Bill of Rights, and Congressional oversight.
- Lessening the impact of TRICARE fee hikes. So important at the age of many in our own group.
- Protecting TRICARE for Life (TFL) five consecutive administration budgets have proposed TFL enrollment fees. At this point there are still no fees for TFL.
- Maintaining pay raise comparability. Keeping pace with civilian sector increases.
- Providing Wounded Warrior protections and caregiver enhancements, thus securing multiple improvements in VA healthcare programs.
- Defeating COLA Minus one percent, ending Congressional attempts to reduce retired pay.
- Securing major GI Bill upgrades include transferability, as well as improving benefits for National Guard on Title 32 orders.
- Boosting compensation significantly for retirees with fifty percent VA disability (still fighting for the rest to include those medically retired).
- Improving Guard and Reserve TRICARE coverage, and securing a premium cut.
- Ensuring Guard and Reserve retirement age credit for active duty service. Allowing ninety days to stretch over two consecutive years. Example, active duty of ninety days November through January. At 1 January time would start over again.



A little capsule of MOAA and the work done all over the country, by leadership, chapters, and individual members for the benefit of those who have served in uniform - no matter when or where. I'm happy to say, this is only a short list, so much has been done. If you check out the "Advocacy" section of the National MOAA website (that's where this article came from) you will find this and much more to stay informed.

Pray you are all doing well getting through our time of being home more than out. Stay well; hopefully we will be able to reunite in the near future.

### PRESIDENT'S CORNER

Did February seem to be a short month to you? I guess it is good for CO-Vid impaired days to go by quickly.

The Governor on Tuesday February 23<sup>rd</sup> lowered the health risk status in Lane County to High Risk from the previous Extreme Risk. This allows a number of things to happen such as restaurants opening to 25% capacity and gyms and related venues to have up to 50 persons depending

on space, spacing and arrangement. This is definitely a move in the right direction. However, the Governor will be making another assessment on Monday and will follow up with changes in status the following Monday. It is a time to be hopeful but not necessarily a time to take action. It is possible that there could be a downgrade in status one day prior to a lunch meeting which would cause all kinds of difficulties for the caterer, the Vets Club and for us in contacting you. Even though we like to meet, we think it's prudent to have two or three report periods in which either the high or lessor risk ratings before we arrange



a meeting. So what does all that mean? It looks like we will begin preliminary preparation for a lunch meeting for April. Our normal scheduled time would be 14 April 2021 Wednesday with socializing at 11:30 am and meeting beginning at Noon. Please keep eyes and ears open for updates as we get closer.

In the meantime a quick summary of the workings of the Board of Directors is:

- Keeping close tabs on restrictions, relaxation of lockdowns and willingness of members to return to in-person meetings.
- Special Projects. The chapter has not had any special projects recently so the Board is looking at a project or activity that can contribute to good in the Lane County area.
- Should a project be found the chapter may resurrect the Mini Newsletter to better share information in a timely manner.
- Membership. The Board is renewing its energy to investigate what it will take to increase chapter membership. A new membership chairman, Michael Kennedy, has jumped into the committee module and is looking at MOAA resources that can help.
- ROTC: the board continues to work with the Benton Community Foundation to build up a growing endowment to help fund most if not all scholarships currently provided. If successful in investing the scholarship program may be able to grow.
- The Board is working to keep up on national MOAA news and activities, local ROTC activities and needs, and in the connection of members with one another.

In the meantime continue to stay healthy and as active as possible.

### SURVIVING SPOUSE CORNER

You don't know how inspiring it is to sit down each month and write something that we all do not enjoy thinking about. However, here goes:

Let's try to accomplish as much as we can prior to our passing so as to not impact the family as much as possible. If you want something specific to happen at your funeral or memorial service, it's a good idea to get it in writing, and let your family know your wishes. Doing so gets rid of the headache of planning for your family, and ensures you get what you want. You don't need to go in and plan everything out, but here are a few things worth considering:

- \* If you want a burial, you need to find a grave plot. You'll need to contact a local cemetery and purchase a plot. If you want a specific cemetery or plot, the earlier you do this step the better.
- \* If you want cremation, you'll work with a funeral director, so contact a local funeral home and arrange any details with them.
- \* Decide if you want to pre-pay for any arrangements so you don't have to worry about your family having to pay these expenses up front. Since the average funeral is around \$6,500.00, it might be helpful to pay ahead of time.

At this time, you can also decide if you want anything specific in a memorial service, how you want it handled, etc. It's also common to add these details to the will if you want to make sure your wishes are followed. Obviously this is a very personal event, and what you want depends a lot on your religious and social background. It's a good idea to make your wishes known to family members to take the pressure off them when the time comes. Children have a tendency to not want to present their concerns about your passing and will be relieved you brought up the subject.

I am certain that many or most members of our Chapter have already made all of these arrangements including knowing that the funeral director will make arrangements for a Military Burial Service. However, there are a number of you that may have procrastinated. It's easy to do. Call me or e-mail me if you need assistance.
