



DOOLITTLE RAIDER PRINT PRESENTATION

The presentation of the signed Jimmy Doolittle Print "I Could Never Be So Lucky Again" to the Pendleton Air Museum would not have happened without Tom Stewart's donation of his print to the MOAA December luncheon raffle. Tom received this print from LTG Jimmy Doolittle when he was at the Pentagon. Michael Kennedy and his wife Connie, Ken Evans, Michael Pace, and Floyd Bard made the trip to Pendleton to attend the 81st Annual Recognition dinner of the Doolittle Raid on Japan on April 18, 1942. The importance of Pendleton Air Museum to receive this print was due to 28 of the "Doolittle Raider" pilots that came from the 17th Bombardment Group station at the Pendleton AirField.

On March 28th, four chapter members testified in front of the State Senate Committee on Veterans, Emergency Management, Federal and World Affairs supporting Senate Bill 178 to assign the Oregon

Department of Veteran Affairs to conduct a study on the state's policy on the tax treatment of military pensions. On April 4th the committee referred the bill to the Senate floor with a "Do Pass" recommendation. The passing of this bill will be the first step in making sure that those military members who retire now can enjoy some of the tax relief enjoyed by those who served before 1991. The TCI was designed, built, supported, and staffed by native Americans, one of the first museums with this background in the United States to do so.
