

NOTES: The Jasper Park picnic was cancelled due to the smoke from local forest fires. The expenses have not yet been recorded and reimbursed to the contributing members. We are seeking a refund for the reservation.

NEW BUSINESS:

ROTC: LTC Snyder reported they are in the first week of school and started 62 students in PE today. They are preparing for Veterans Day. Branch Assignment Day is 30 Nov and they want to make that a significant event; more on that as plans develop. The Chili Cookoff is 2 Dec; we have been challenged. There will be a commissioning ceremony for some winter graduates on 14 December.

Ron Sticka announced a PTSD seminar on 15 Oct. He is also looking for a chapter coordinator for the local chapter of Guitars for Vets. Details on the symposium will be attached to the newsletter email.

Floyd Bard announced that the Lane County Stand Down set-up is tomorrow with the actual event on Friday, 30 Sep. This will be the first full-sized stand down in three years and they are expecting about 500 veterans. They have 50-55 exhibitors and volunteers but would really appreciate set-up help on the 29th.

John Toensing announced that he has found a beautiful American flag that he would like our members to purchase and sell to neighbors. The cost will be about \$75 for a 4' X 6' and about \$55 for a smaller flag. The chapter would receive about \$15 for the sale of each flag. Pole kits are also available. The flag was on display. John also mentioned that he would be taking all the returnables brought in to the BottleDrop. He also made collection bags available to the members.

COMMENTS FROM NATIONAL MOAA SPEAKER

At the 28 Sep Board Meeting, CAPT Frank Michael, USN (Ret), Program Director of national MOAA's Council and Chapter Affairs, addressed the 25 members in attendance about their three main areas of effort: Membership, Grassroots Advocacy and Community Engagement. He congratulated our chapter on its Five-Star achievements in the Levels of Excellence and Communications awards (both newsletter and website).

<u>Membership</u>: He asked if we realized that of the 356,000 national MOAA members, there are only 40,000 members in the nearly 400 chapters. He further noted that the average age of all MOAA members is 63 years old, but in the chapters the average is 75. That is why they are concentrating on recruiting in the 40-60 year age group... those who are transitioning from the military into the civilian sector. They are also trying to find ways to better help the chapters recruit that 89% of national members who are not chapter members.

<u>Grassroots Advocacy</u>: This area of concentration used to be called "Storming the Hill" and entails meeting personally with members of Congress and their staffs. Though it has been done remotely for the last two years due to covid, they hope to perform in-person visits this year.

<u>Community Engagement</u>: CAPT Michael commended us on our close relationship with the U of O ROTC program. He is also aware of our contributions to Habitat for Humanity and St. Vincent de Paul veterans programs.

LOE Changes: MOAA has made some changes on how chapters and councils are graded for the Levels of Excellence award. The award criteria established a new level 3 award to recognize the efforts of chapters who are working well but have not yet reached the 4- or 5-star level. The new criteria will now take into consideration the evaluations of national MOAA and council visits, and will rely more heavily on subjective evaluation topics.



<u>Virtual Chapters</u>: MOAA currently has six virtual chapters that meet electronically and connect members who share common interests. The current chapters are Nurses, Surviving Spouses, USPHS, Chaplains, Women and Families. Learn how to join or start a virtual chapter in the Councils and Chapters pages of the national MOAA website.

<u>MOAA Board</u>: National is currently running a "Board School" for the 12 new board members recruited this year. National changes out a third of the board's members every year, so opportunities are available every year.



The list of candidates for 2023 officer and board member positions on page 7 of this newsletter is just a proposed list of those who have raised their hands and said they would be willing to take on those responsibilities. That list is not final, which gives any other member the opportunity to raise their hands or to be nominated by someone else. The list will be finalized and published in the November newsletter, which according to our By-Laws, must be published at least ten days prior to the Annual Meeting; scheduled for 9 November. So, if you would like to stick your toes in the water and re-ignite your leadership skills, pick up the phone and call Dick Norton (listed on the cover page).

For example:

T've Done This Already': Many military retirees have used VA loans to purchase one or more homes and feel comfortable with the process. However, the benefit has changed in recent years, with new fee structures, a new loan limit setup, and additional provisions for Purple Heart recipients. The webinar will cover all of the above in detail.

'My Realtor/Adviser Will Handle It': While many Realtors, lenders, and financial professionals are very familiar with the VA loan process, some may deal with it infrequently, especially those in areas with a small veteran population. The Sept. 20 webinar will get you up to speed on all the details, including ways to make your VA-backed offer more competitive.

Annual Summit Connects Military Families With Lawmakers, DoD Leaders; By: Jen Goodale

"The strength of our military is drawn from the strength of our military families," said Rep. Cathy McMorris Rodgers (R-Wash.) when announcing the 2022 Congressional Military Family Summit. This in-person event aboard Fairchild Air Force Base, Wash., was livestreamed Aug. 17 – and MOAA was tuning in. The Congressional Military Family Caucus sought to educate members of Congress and their staff on resources the military has for families, specifically in the areas of education, child care, health care, spouse employment, and the effects of multiple deployments. Since 2009, the caucus has hosted the annual Military Family Summit to connect servicemembers and their families with DoD leaders and military family support organizations to collaborate on ways to address the top issues affecting military family well-being.

BIO OF OCTOBER MEETING SPEAKER

Sean Furney, US Air Force Veteran Veterans Employment Services for Easter Seals Oregon

Sean is a relative newcomer to his role advocating and helping veterans. As an Air Force veteran, he wanted to do it starting in 2021 with an opportunity to plan a fundraising event for a local non-profit that supports veterans with PTSD, Dogs of Valor. Through that event he connected with St. Vincent DePaul's Supportive Services for Veterans Families housing program and Easter-seals Oregon's Homeless Veterans Reintegration Program.

Luck would have it that shortly after that, Easterseals Oregon was hiring which gave him the

opportunity to start working daily with veterans in need in our community. In this role, he had the opportunity to utilize his business networking skills to improve visibility of the HVRP program in the community and start making new connections with businesses, governmental and other non-profit organizations to reach more veterans in Lane County.



During this time, he also supported a non-profit, the Ohana Homefront Foundation, as PR director. This newly formed organization is focused on creating a national network of counselors for military members, veterans, their dependents and caregivers. This network brings volunteers together to provide these services for free to those in need.

Additionally, he has been consulting with the Reveille Foundation who is working on bringing veteran housing to Eugene and Lincoln City. This housing will provide on-site behavioral health support, case management, work opportunities on the property, career training and job placement support.

Whether it is going into homeless camps to find veterans in need or meeting with government and business leaders in the community, Sean and the team at Easterseals is doing everything they can to connect veterans in need to the resources in the community. There are two phrases that lead his mission, "We might not know them all but we owe them all" and "No man left behind."

This year's theme was "Military Families are Mission Critical." Rep. Sanford Bishop (D-Ga.) joined McMorris Rodgers to discuss issues including pay and benefits, community integration and transition, and the health and well-being of families and children. The event featured panels addressing education and the Exceptional Family Member Program, as well as economic security, to include food security, military spouse employment, housing, and child care. Panelists such as Olivia Burley (Military Spouse Liaison, Washington State Department of Veterans Affairs) and Tammie Perreault (Northwest Regional Liaison, Defense-State Liaison Office) provided insights into the status of state-level initiatives underway to address these issues. This was an excellent opportunity to hear from stakeholders and bring back ideas to your community to enhance the quality of life for military families.
