OLD BUSINESS:

- 1. ROTC update, Veterans History Project LTC Joe Snyder and Pat Harris
 - 12 Seniors this year, 10 at UO and 2 at SOU. All successfully completed Cadet Summer Training 2024.
 - Robert Doughtery's Internment is 13 OCT at Sunset Hills Cemetery. Bob was a key figure around the Veterans Memorial Building for years and helped keep the city from putting it under their jurisdiction.
 - UO ROTC has welcomed three new Cadre:
 - ♦ MSG Jonathan Jimenez, Senior Military Science Instructor
 - ♦ SFC William McDunn, Military Science Instructor
 - ♦ Mrs. Jenny Owen, Human Resources Assistant
 - UO ROTC has bid farewell to CPT (Ret) James Miller as he has retired but remains in the local area.
 - CadetsGiving will be on the Wednesday before Thanksgiving in Agate Auditorium (27NOV24).
- 2. Dues deadline and luncheon payment status Elaine Callahan and Ken Evens
 - We were short 4 diners at the last luncheon meeting: notices were sent for reimbursement.
 - Seven members have not paid 2024 dues. A new notice, in large print, will be sent shortly.
- 3. Cut-off date for dues non-payment
 - The board discussed when it would be appropriate to remove non-paying members from the roles and a general consensus was that we should advise them after six months that their membership was suspended, but that we would keep them on the roles for an additional 12 months, though they would not be allowed to vote.
- 4. 501(c)3 status Eric Watkins and Ken Evans
 - Some forms have been submitted online. Draft bylaws have been distributed for review, expecting a near-final draft by next week.
- 5. Floyd Bard attendance at Regional Workshop Michael Kennedy
 - A discussion was held on funding prospective chapter president Floyd Bard to attend the MOAA Western Regional Workshop in Reno on 15-16 November. Funding would cover at least transportation and 1-2 additional nights at the conference's hotel. The MOTION was made by Elaine Callahan and seconded by Michael Pace. It was approved unanimously.
- 6. The Veterans' Café is a program by the Roseburg VA to provide a catered meal for any veteran, including ROTC cadets, to get together and socialize. The event is planned for 19 Oct, 1100-1400 at Eugene Elks.
- 7. Bottle/can return program update. Ken taking over from John T.
 - Ken Evans briefed that he has relieved John Toensing of the bottle and can recycling program. He will plan to brief the members and have the new blue bags and stickers at the next luncheon. More details will be in the newsletter.
- 8. Stand Down Floyd Bard
 - Set-up for the Lane County Stand Down starts tomorrow and volunteers are requested to show up around 1000. Pizza and drinks will be provided. The actual Stand Down is Friday the 27th with registration starting at 0630 and closing at 1500. Two meals will be served, and the ceremony will be at noon. Floyd further mentioned that he would like us to consider manning a table at the next stand down to get our name out in front of the veteran population and possibly gain some membership.

VETERANS HISTORY PROJECT

Your military journey documented in the Library of Congress

The Library of Congress has instituted a program to capture the recollections of U.S. military veterans who served from World War I through more recent conflicts and peacekeeping missions, so that future generations may hear directly from veterans and better understand what they saw, did and felt during their service. These personal stories will then be curated and available to anyone, either by visiting the Library of Congress or by accessing the collection online.

The process of conducting the interviews and collecting and submitting the documents and photos (optional) is not overly complicated, but can be so much simpler if someone walks you through it. Hence, Chapter Board member LTC Joe Snyder, PMS of the U of O ROTC, will rouse his Cadets to master the process and help Lane County Veterans prepare their stories for inclusion in the collection. Interviews will start this fall.

THOUGHTS FROM THE BOARD

Emerald Empire Chapter Scholarship Fund


Then I first became a member of the Emerald Empire Chapter in about 2002, we would "pass the hat" at luncheon meetings to help fund one \$250 ROTC scholarship! During Charlie Cole's Presidency, we started the "Booster Fund." At that time we asked members to chip-in \$25 to the fund annually. Soon we were awarding one \$1000 scholarship. By 2010 the Board had completed the documents to establish the Chapter as a nonprofit veterans organization... 501(c)19. The Chapter Scholarship fund gathered momentum with significant donations. With the continued support of the Boosters at \$50 annually, the ROTC fund grew to two \$1000 individuals, and currently three \$1000 individual scholarships. By 2017 the fund had a sufficient balance to meet the minimum requirements to establish a donor advised fund (DAF). The Board chose the Benton Community Foundation to administer the Chapter Scholarship Fund. Today the DAF balance is about \$59,000 and pays for two of the three \$1000 scholarships. When the scholarship endowment fund reaches \$80,000, it will pay for all three scholarships with no loss of principle. Currently your Chapter Board is completing the documentation to convert the Chapter Scholarship Foundation to a 501(c)3 nonprofit. This will facilitate the transfer of funds from personal DAFs and RMDs (required minimum distributions). We will advise the members of the new EIN and certification in the near future.

On behalf of your Chapter Board and the University of Oregon ROTC program, I wish to thank every member and associate member for their support. Your participation over the years has made this scholarship program viable and important to the cadets.

New Telephone Listings in the Directory

With many people dropping their landlines and having two or three cell phones in the house, we've noticed that it may be better to list phone numbers in our directory as either PRIMARY or SECONDARY. So, ask yourself, "What number do I want other MOAA members to call to reach me?"



- If the answer to that question is the cell phone listed in the directory, tell me you want that to be your PRIMARY number and I will make that happen. I will list your other number as SECONDARY.
- If the answer is the HOME number listed in the directory, you don't have to tell me anything. I will just make that your PRIMARY number and any other number SECONDARY.
- If you now only have cell phones and no landline, just tell me which phone you want listed as the PRIMARY; others will be SECONDARY.
- If I don't hear from you, your current HOME phone will be listed as PRIMARY and any other phone will be listed as SECONDARY.

VETERANS STAND DOWN, Roseburg VA Campus, 9/11

PATRIOT DAY, SEPTEMBER 11TH, 2024

District 13, Color Guard

Very early on Patriot Day, September 11th, Color Guard members from Coos Bay, Eugene, Florence and Albany switched off their alarms, secured uniforms and gear, and then drove into a stormy early fall day that featured heavy rains. Their goal was to provide a Color Guard for the



Roseburg Veteran's Affairs (V.A.) Veteran's Stand-Down event held at the V.A. complex. This was a well-publicized event that planned to host almost 50 vendors to provide mostly free goods and services to Veterans. The rain caused some consternation as the event was planned to take place in an outdoor location.

Coast Guard Auxiliary Color Guard members; Doug Wisman, Miyasha Hilliare, Steve Shallenberger, and Bill Malone were joined by program manager, Norm Hoffman for the occasion. Members of the Color Guard had trained the week before so they would be sharp and at their very best for this event.

So, on they drove, and...upon arrival in Roseburg, the

rain suddenly stopped.

The team hit the ground, running. They first met with the event master of ceremonies to coordinate details, then they discussed the order of events with the singers who would perform the Star-Spangled Banner anthem. Next, they picked out their marching route and did a final rehearsal. At that time, the M.C. was reading the notifications of the 9-11Twin Towers attack to the crowd in real time.

But promptly at 0900, she announced (from a preprinted Color Guard format);

"Ladies & Gentlemen, please stand for the presentation of our Nation's Colors & remain standing for our National Anthem. Today the Colors are presented by the United States Coast Guard Auxiliary."

The large crowd was very grateful for the Color Guard's efforts and many people, mostly Veterans, stopped by to say thank you to the Color Guard members.
