THE DISPENSATION FROM THE OBLIGATION OF ATTENDING SUNDAY MASS - ARCHDIOCESE OF HARTFORD

As of Saturday, May 22, 2021, the general dispensation from the obligation to personally attend Mass on Sundays and Holy Days of Obligation will cease to be in force. Therefore, there is an obligation to participate once more in the Mass except those who suffer from serious pre-existing conditions, the homebound, those who have contagious diseases, and people who care for or reside with people in quarantine.

Our churches will reopen at 100% capacity on May 19, 2021 with no specific social distancing. Masks are still required for all who enter. For more information visit our website.


Live the Gospel of Life

Question:

Why do we celebrate Pentecost when we do?


Answer:

The book of Acts unpacks the events immediately following Jesus' ascension into heaven. The Apostles and other disciples were told to pray in Jerusalem and await another outpouring of the Holy Spirit. As the weeks ticked on, the Jewish Festival of Weeks approached. This festival took place 50 days after Passover and celebrated the giving of the law on Mount Sinai. The Festival of Weeks (or "Pentecost" in Greek) was a great pilgrimage feast, with Jews from all over the ancient world convening on Jerusalem for the celebration.

It was on Pentecost that God chose to send the Holy Spirit. Here, the new law of love was etched into the hearts of the disciples. As he burst out onto the balcony above the multinational crowd, Peter proclaimed the message of the resurrection, and the Holy Spirit enabled every listener to hear in their native language. 3,000 people were baptized that day! The disciples — and every baptized person — receives the gifts and zeal necessary to bring a new message of salvation to the people of God.

Domingo de Pentecostés

Cada año, la Iglesia se engalana y celebra por todo lo alto la Solemnidad de Pentecostés. Es tiempo de pasar del miedo de estar encerrados, a la alegría de recibir el soplo del Espíritu liberador. Todos estamos expectantes para recibir sus siete sagrados dones. La narración del Evangelio nos dice que Jesús se presentó a sus discípulos y les dijo: “¡La paz esté con ustedes! Como el Padre me envió a mí, así los envío yo también”. Dicho esto, sopló sobre ellos y les dijo: “Reciban el Espíritu Santo” (Juan 20:21-22). Ahora, el turno es nuestro, es el tiempo de la comunión que nos trae el Espíritu. El deber de la Iglesia, que somos todos los bautizados, es siempre de diálogo y de comunión.

La gran variedad de todos es una fuente de enriquecimiento. El bien común es para todos y el Espíritu Santo está vivo en cada uno de nosotros. No desaprovechamos, más bien demos gracias al Padre por el don del Espíritu Santo a su Iglesia. Este Espíritu es el que nos une en la diversidad de razas y culturas. También, pidamos al Padre que seamos humildes servidores de su Espíritu, especialmente en este tiempo tan complicado, para llevar a cabo su misión. Oremos, para que las familias sean verdaderas Iglesias domésticas, donde se practique la paz y la justicia entre cada uno de sus miembros. En su Homilía en Pentecostés, el Papa Francisco nos ayuda a comprender que: “El Espíritu Santo es la unidad que reúne a la diversidad; y que la Iglesia nació así: nosotros, diversos, unidos por el Espíritu Santo”. ¡Ven, Espíritu Santo!




