TRUTH AND RECONCILLIATION DAY 2025

Truth and Reconciliation; An **Unfinished Promise**

On September 30th, Canada observes the National Day for Truth Reconciliation and Orange Shirt Day. This day honors the children who never returned home from residential schools, and stands with the survivors, their families, and their communities who continue to carry the weight of that legacy. It is not just a day of remembrance, but also a call to action, because healing cannot happen once a year; it must be carried in our words, our choices, and our actions every day.

For over 100 years, residential schools operated as tools of forced assimilation, removing Indigenous children from their

families and communities, with the intention of removing language, culture, tradition, and identity. Many endured abuse, neglect, and profound loss. Thousands never came home. This truth cannot be ignored; it is part of Canada's history and its present.

In 2008, the Truth and Reconciliation Commission (TRC) was created to document these experiences and chart a path forward. In 2015, the TRC released its final report along with 94 Calls to Action, laying out a blueprint for governments, institutions, and citizens to address both the harms of the past and the inequities that persist today (Government of Canada, 2025).

Unfortunately, reconciliation in Canada remains an unfinished promise. Of the 94 Calls to Action, less than half have been completed. Many of the most urgent reforms remain stalled: protecting Indigenous languages, ensuring equitable healthcare and education, reforming child welfare, addressing over-incarceration, and respecting land and resource rights (The Assembly of First Nations, 2025). Each year that progress lags, survivors and communities are asked to carry the burden of waiting for justice that is long overdue.

The TRC directly challenged the justice system to confront its failures: the over-incarceration of Indigenous peoples, systemic discrimination in policing and courts, and the lack of recognition for Indigenous legal traditions (Government of Canada, 2023). Laws like Bill 5, which enables the government to push through environmental projects like mining, highways, and industrial zones without consulting with Indigenous communities, shows how colonial patterns continue (Chiefs of Ontario, 2025).

Truth and Reconciliation Day is about responsibility.

The responsibility to acknowledge how colonial systems, including the law, cause harm, and the responsibility to transform those systems so they can serve justice rather than deny it. As treaty people, we need to uphold Indigenous rights, honor treaty obligations, and ensure Indigenous voices are at the center of decisions that shape their lands and futures.

Reconciliation is not someone else's task, nor tomorrow's work; it is ours, and it is now.

Every Child Matters.


