CHARGES:

- 1. Contrary to the UN International Convention for the Suppression of Terrorist Bombings 1997 and the Terrorism Act 2000 did attempt to cause and did cause explosions in the City of London on the 7 July 2005 acting as a "joint principal in a joint enterprise" with agents and enemies of foreign governments, knowing before hand the day of the intended bombings.

- 5. Treason Felony contrary to the Treason Felony Act 1848 in that he lied to Parliament and the people.
- **6.** Conspiracy in Common Law-to defraud, to corrupt public morals and offend public decency, in that he has deliberately and systematically conspired with John Stevens the former Chief Commissioner of the Metropolitan Police to subvert the cause of justice and pandered to those in higher constitutional positions.
- 7. State Sponsored Terrorism against the citizens of Great Britain contrary to the S.59 Terrorism Act 2000 and The International Convention for the Prevention of Terrorist Bombings 1997 for offences in the United States of America and crimes against humanity in conspiracy to release H5N1/Scotland/1957 "bird flu" virus into UK mainland depositories constituting an act of biological war against his own people acting as "joint principal in a joint enterprise."
- 8. Perjury contrary to S1(1) of the Perjury Act 1911 in that he did lie.
