CHARGES:

1. Treason and treacherous conduct contrary to the Treason Felony Act 1848 towards the Citizens of the United Kingdom, its Armed Forces, its Officers and service personnel, in that he/she did enter into an secret arrangement in a *private capacity* with a foreign power, namely the United States of America, to submit the United Kingdom and its subjects to a "war of aggression," for his/her private gain.
2. Murder and crimes amounting to crimes against humanity, illegal war of aggression, genocide and war crimes in contravention of The Universal Declaration of Human Rights, The Geneva Conventions, The 1998 Rome Statute of the International Criminal Court.
3. Torture contrary to the 1984 Convention Against Torture and Other Cruel and Inhuman Punishments, The Atlantic Charter, The Geneva Conventions and Geneva Protocol 1 of 1977 and Common Article 3 of the Geneva Conventions.
4. Statutory Conspiracy/ incitement to murder contrary to Section 1(1) of the Criminal Law Act 1977 (as amended) - Dr David Kelly.
5. Conspiracy to murder and treason contrary to the Treason Felony Act 1848 and contrary to the 1997 International Convention for the Suppression of Terrorist Bombings and the Terrorism Act 2000 did allow enemy agents of the people enter upon it's sovereign territory to cause explosions - namely the 7/7/2005 London bombings.
6. Contrary to the UN International Convention for the Suppression of Terrorist Bombings 1997 and the Terrorism Act 2000 did attempt to cause and did cause (respectively to Convention and Act) explosions in the continental USA between 26-29th May 2006 and in the City of London on the 7 July 2005 acting as a "joint principal in a joint enterprise."
7. State Sponsored Terrorism against the citizens of Great Britain and the USA contrary to the S.59 Terrorism Act 2000, the International Convention for the Prevention of Terrorist Bombings 1997 and the 1998 Rome Statute of the International Criminal Court for crimes against humanity in conspiracy to release H5N1/Scotland/1957 "bird flu" virus into UK mainland depositories constituting an act of biological war against his/her own people and acting as "joint principal in a joint enterprise."
8. Perjury contrary to S1(1) of the Perjury Act 1911 in that he/she did lie.
9. One count of Pre-Crime, in orchestration with the United States Presidency and in full knowledge of "Presidential Determination 99 -37" that he/she carried out acts with "*malice a forethought*" to endanger *the future lives* of planetary citizens (and the planet itself) by facilitating and encouraging the building of repositories, namely nuclear power generating facilities, for the future time, inter-dimensional dumping of photonic waste materials along 4th density time-line corridors into these earth based reactors causing massive planetary grid failure and loss of life - known as an Extinction Level Event (E. L. E.).
