- **CHARGES:**1.Treason and incitement to commit treason (with Baroness Morgan and Lord Goldsmith and others) and as a co conspirator with Tony Blair and as an "accessory before the fact" did pervert the cause of justice before the Invasion of Iraq and therefore as "joint principle in a joint enterprise: the charge of "Treason and treacherous conduct contrary to the Treason Felony Act 1848 towards the Citizens of the United Kingdom, its Armed Forces, its Officers and service personnel, in that he did enter into an secret arrangement in a *private capacity* with a foreign power, namely the United States of America, to submit the United Kingdom and its subjects to an illegal "war of aggression" against another sovereign state, Iraq.

- **4.** Incitement to murder Dr David Kelly, July 17, 2003 and those killed in the London bombings on 7 July 2005, and as Secretary of State for Constitutional Affairs and Lord Chancellor did appoint Lord Huttton, (co-conspirator), to cover over the facts of Dr. David Kelly's murder.
- **5.** Treason Felony contrary to the Treason Felony Act 1848 and "malfeasance in public office" at common law, in that he lied to Parliament and the people of the United Kingdom and did not act in "utmost good faith" in his capacity as government advisor and Secretary of state for Constitutional Affairs and member of the Privy Council and Lord Chancellor.
- 6. Conspiracy in Common Law to defraud, to corrupt public morals and offend public decency Cash for honours saga.
- 7. Perjury contrary to S1(1) of the Perjury Act 1911 in that he did lie.
