Murder and crimes amounting to crimes against humanity, illegal war of aggression, genocide and war crimes against the sovereign states of Iraq and Afghanistan in contravention of The Universal Declaration of Human Rights, The Geneva Conventions and the 1998 Rome Statue of the International Criminal Court: Causation in fact then in law to establish the following:
 Under Section 8 of the Accessories and Abettors Act 1861 then states, "Whosoever shall aid, abet, counsel or procure the commission of [any offence], shall be liable to be tried or indicted and punished as a "principal offender."

- 6. Conspiracy in Common Law to defraud, to corrupt public morals and offend public decency Cash for honours saga.
- 7. Perjury contrary to S1(1) of the Perjury Act 1911 in that he did lie.
