## CHARGES:

1. Treason and treacherous conduct and "malfeasance in public office" at common law contrary to the Treason Felony Act 1848 towards the Citizens of the United Kingdom, its Armed Forces, its Officers and service personnel, in that he did as Foreign Secretary, then Leader of the House of Commons and Lord Privy Seal and member of the Privy Council, knowing the fullest consequences of his actions, did accede to the incitement of the then Prime Minister Tony Blair and others, and lie to both Houses, Commons and Lords and misdirect the people of the United Kingdom and "conspired to take the country to war illegally" against another sovereign state, namely Iraq. Causation in fact then in law to establish the following:-  
*Under Section 8 of the Accessories and Abettors Act 1861 then states, "Whosoever shall aid, abet, counsel or procure the commission of [any offence], shall be liable to be tried or indicted and punished as a "principal offender."*
2. Murder and crimes amounting to crimes against humanity, illegal war of aggression, genocide and war crimes against the sovereign states of Iraq and Afghanistan in contravention of The Universal Declaration of Human Rights, The Geneva Conventions and the 1998 Rome Statue of the International Criminal Court.
3. The 1984 Convention Against Torture and Other Cruel, Inhuman and Degrading treatment or Punishment, The Atlantic Charter, The Geneva Protocol 1 and Common Article 3 of the Geneva Conventions for the torture of British and other citizens.
4. Statutory Conspiracy to murder contrary to Section 1(1) of the Criminal Law Act 1977(as amended), of Dr David Kelly, coalition forces, Iraqi police military and civilians and Saddam Hussein.
5. Conspiracy to cause explosions in London 7 July 2005. contrary to the Terrorism Act 2000 and also the 1997 International Convention for the Suppression of Terrorist Bombings.
6. Conspiracy in Common Law to defraud, to corrupt public morals and offend public decency – Cash for honours saga.
7. Perjury contrary to S1(1) of the Perjury Act 1911 in that he did lie.
