#### **CHARGES:**

1. Treason Contrary to United States Code Title 18, Part 1 Chapter 115 at para. 2381:

"Whoever, owing allegiance to the United States, levies war against them or adheres to their enemies, giving them aid and comfort within the United States or elsewhere, is guilty of treason and shall suffer death, or shall be imprisoned not less than five years and fined under this title but not less than \$10,000; and shall be incapable of holding any office under the United States".

- 2. Murder and conspiracy to murder and crimes amounting to crimes against humanity, illegal "war of aggression", genocide and war crimes against coalition forces, Iraqi and Afghan police military and civilians and Saddam Hussein in contravention of The Universal Declaration of Human Rights, The Geneva Conventions, The 1998 Rome Statue of the International Criminal Court.
- **3.**The 1984 Convention Against Torture and Other Cruel Inhuman and Degrading Punishments, The Atlantic Charter, The Geneva Protocol 1 and Common Article 3 of the Geneva Conventions, for the torture of British citizens namely "The Tipton Three" and Ex parte. Abbassi and citizens of other countries.
- **4.** Contrary to the UN International Convention for the Suppression of Terrorist Bombings 1997 and the Ss.59-62 Terrorism Act 2000 did attempt to cause and did cause (respectively to Convention and Act) explosions in the continental USA between 26-29th May 2006 and in the City of London on the 7 July 2005 acting as a "joint principal in a joint enterprise."
- 5. Incitement to murder British subjects Dr David Kelly, July 17, 2003 and those killed in the London bombings on 7 July ,2005.
- **6**. State Sponsored Terrorism against the citizens of Great Britain and the world, contrary to the 1998 Rome Statue of the International Criminal Court for <u>crimes against humanity</u> in that he acted as "joint principle in a joint enterprise" and did organise and authorise the release of the H5N1/Scotland 1957 "bird flu" virus into UK mainland depositories, constituting an act of attempted genocide against UK subjects and biological war against global populations, said virus being "accidentally" sent to 4,000 labs worldwide from a CIA sourced laboratory within the USA., contrary to the Terrorism Act 2000 S. 64(3) (ii) section 1 of the [1974 c. 6.] Biological Weapons Act 1974 (biological weapons).
- 7. One count of <u>Pre-Crime</u>, in orchestration with the United States Presidency and in full knowledge of "Presidential Determination 99-37" that he carried out acts with "<u>malice a forethought</u>" to endanger <u>the future lives</u> of planetary citizens (and the planet itself) by facilitating and encouraging the building of repositories, namely nuclear power generating facilities, for the future time, interdimensional dumping of photonic waste materials along 4<sup>th</sup> density time-line corridors into these earth based reactors causing massive planetary grid failure and loss of life (and soul identity fragmentation) known as an Extinction Level Event (ELE).
