Cost: ----- **\$60.00 per space - Electric \$8.00 additional.**

1 – 8ft table per space will be provided. Chairs will also be provided. Extra tables for your space will be available for a \$10.00 fee. (This does not include extra space.)

Show Setup: Friday Nov. 2 (11AM to 3 PM) and Saturday Nov. 3 (7 AM to 9 AM)

Hall will open at 8AM on Sunday - Free Parking.

Food: ----- A cafeteria is available serving meals snacks and cold drinks.

(There will be volunteers coming around at lunch time to take your order if you can't get away from your area).

Security: ---- There are 50 plus cameras videoing the show at all times.

If you have exhibited at our show before and want to be in the same general area as before, your application MUST BE RECEIVED NO LATER THAN August 15, 2017.

All applications received after this time, will be placed as space permits. *So please send your application in as soon as possible.*

By reserving a space, you agree to the following stipulations:

1. To remain setup at the show from Saturday 9:00 AM *till closing on Sunday at 4:00 PM.*
2. That the Midwest Woodcarvers aka Belleville Holzschntizers and Belle-Clair Exposition Hall will not be held liable for any loss sustained by the exhibitor in any way.
3. All Exhibitors are subject to the following:
 1. All tables **must** be covered top and front to floor.
 2. All displayed work **must** be exhibitors own work.
 3. Wood must be the main source for all artwork on sale.
 4. No cast reproduction carvings. (This does not include study casts.)
 5. No commercial venue or advertising will be permitted which does not pertain to woodcarving or handmade wooden items.
 6. No loud equipment is permitted.
 7. You may not sublet or reassign your space.
 8. Any photo taken by the committee can be used for promotional purposes.
 9. By city ordinance - No Pets are allowed.

(On all issues pertaining to the show, the Show Committee will have the final decision.)

We will have a judged competition plus a people's choice with cash awards. Rules for the competition will be sent with the confirmation letter in your (SASE). We will also have daily demonstrations.
