Price revisions, schemes, or offers may be changed at the Company's discretion.

4. Payment Terms

Supplies are on advance payment.

Payments accepted via NEFT / RTGS / IMPS / Cheque

5. Orders & Supply

Orders must be placed through authorized channels only.

Supply is subject to availability and order acceptance.

Delivery timelines are indicative.

6. Returns & Claims

No returns without prior written approval.

Manufacturing defects must be reported within _ days of receipt.

Transit damages must be reported immediately with proof.

7. Marketing & Branding

Distributor shall promote products ethically and professionally.

Use of Company brand, logo, and materials is permitted only for approved activities.

Misrepresentation or false claims are prohibited.

8. Compliance
