### CLC Fundraiser: Helping A Family In Need

Jodi is a 47 year old, loving mother of 6 children, who is no stranger to pain and loss. Jodi lost her 14 year old son, Noah, to homicide in 2012. In 2013 Jodi gave birth to a son, Loki, who was born with several severe birth defects which required 24/7 care. The doctor's told Jodi that Oskar would not live more than 3 years at best. She dedicated herself to helping Oskar live his best life as long as he was here. Oskar passed away in December 2017. Faced with the struggle of nurturing and healing herself, her 3 daughters and son through their tragic losses, Jodi remained as strong as possible.

On November, 2017, Jodi was diagnosed with ovarian cancer. Jodi's family has a genetic defect that is labeled BRCA2+, and it is extremely fast growing and virulent. Jodi worked with integrative medicine doctors for several months and made some progress in holding the cancer at bay. Difficulties arose

that caused continued alternative measures to be unavailable and the cancer worsened.

Jodi is now undergoing chemotherapy, with other treatments being considered if the chemotherapy is deemed to be successful. Jodi's spirit is strong and she is fighting to continue to be a mother to her two grown daughters, Kyli and Mallori, and to her children Loki (11 years old) and Lilith (aka Bee – 9 years old).

Jodi is currently separated from her children. They have no home, Jodi is unable to work because of her illness and has very limited resources.
Currently surviving on the kindness of friends, Jodi and her children are in need of clothing, housing, food, transportation and financial assistance in caring for Loki and Bee for those who have opened their homes to them.

CLC is reaching out to all of you for help on Jodi's behalf in hopes that we can bring Jodi and her children back together under the same roof and provide some relief so Jodi can concentrate on her fight and healing.
