In years past on the Tour, some teammates and patients blew me away by the compassion of complete strangers. The Tour DaVita has raised 6.1 million dollars since its inception 14 years ago to benefit DaVita Village Trust organization. The Kidney trust program was created to benefit the more than 20 million American adults living with Chronic Kidney Disease as well as 506,000 Americans with kidney failure. DaVita Village Trust's philosophy, is that everyone should be empowered to take a proactive role in their health. Toward the end, the trust seeks to reduce the progression of Chronic Kidney Disease through free, rapid screenings in non-medical settings.
