

Connor's Journey Blessed By CLC

"Sunday Aug 14, 2022 at 4:15 a.m. we were notified that Connor was seriously injured in a head on collision and being life-flighted to OSU Trauma Center. We arrived at the hospital at 5:25 a.m. when the trauma doctors explained that Connor had suffered life threatening injuries and needed to be rushed to the OR. Connor had a massive brain injury, multiple fractures, and lacerations and needed his skull plate to be removed to make room for the brain swelling.

Surgery took close to 3 hours. The surgeon came to tell us that the right skull plate was removed, and that Connor had a fist size blood clot deep in his brain along with swelling. He had no injuries to spine and that he would be in a medically induced coma for 7-10 days. The next few days were critical.

He had a broken nose, no other facial fractures, a large laceration through left nostril and roof of mouth, fractured ribs, and multiple fractures to right ankle. Once in SICU after surgery, ENT (ear, nose, throat) team came in to repair laceration to nostril/mouth, Ortho did a closed reduction (setting of) right ankle, surgery to repair at a later date. The monitor (I called it his martian probe) that measures his intracranial pressure (ICP) needed to be adjusted. His ICP continued to increase, so we started hypertonic solution (super salty) to help pull the fluid off of the brain.

Day 2 Mon. Aug 15: Central line placed in right neck. ICP numbers start to even out with the hypertonic solution, BP starts to rise. CT scan to see if blood clot shifted due to last 3 Neuro checks were a little different. Up to this time, Neuro checks have been good and reactive x4, meaning that all 4 limbs are reacting to stimulus.

Day 3: Tues. Aug 16 ICP went through the roof, BP still high, had to have martian probe removed and an EVD put into place, this is a larger drain system along with measuring ICP. After EVD in place, numbers came down, still concerned about high BP.



Day 4: Wed Aug 17 Started nutrition through tube, BP still high, working on finding the right combination of meds to get that regulated. Running low grade temp, on cooling blanket to keep temperature down. Blood cultures done. Reacting to stimulus on right side only. Tolerating nutrition.

Day 5: MRI done, just working on getting numbers to a stable level.

Have no idea what day it is: MRI showed that Connor had a stroke in the "already damaged part" of brain which effected his left side. We moved from SICU to NCCU, critical care unit on neurology floor. We called it his apartment in the castle!

Please forgive me, but I stopped taking really good notes once we moved. A couple days into the new move, the sedation that was keeping him in coma was being lowered. As it was completely out of system, Connor was reacting to stimulus about 50% of the time with right hand, then one day...we got a squeeze and a thumbs up! (continued on pg 3)

our Facebook page. Watch from the comfort of your own home or in your council meeting. You control the environment!



Connor has received nothing but phenomenal care by compassionate, skilled, knowledgeable staff, from the trauma team, Neuro team, critical care team, and nursing staff!! The Lord has truly blessed us multiple times over! He continues to touch our boy and answer prayers!"

Imagine this being a week in your life. This was a life changing week for Connor and his family. The story above are the words Connor's mother posted on a blog where she kept friends and family updated on his condition as so many were praying for his healing.

Though Connor has made great strides over the past year, his recovery is far from over. CLC donated money to help with the purchase of an UpWalker to assist with his continuing physical therapy and learning to walk again. A few days after Connor received the check he had a set back and was life flighted back to the hospital. The

picture on the left is Connor using his UpWalker only days after that setback. Seeing this young man's journey and fight is something to revel in.

Connor's mother started a second job to help pay medical bills, add the needed equipment at home and make up for the time she misses at her daily job in order to make all of his doctor and PT appointments. With the donation from CLC, Connor's mom was able to purchase the equipment he needed immediately as it helped get the fundraising goal for the UpWalker to the needed amount. Connor will be able to continue his work at home, in addition to the rehabilitation facility, in hopes he will gain his independence once again. Please keep Connor in your heart and in your prayers for continued health gains. We wish Connor and his family healing and strength from the CLC family.
