<u>Health Card info for Handbook</u>: Discussed changes to the employee handbook. Add to handbook page 8: Motion by Supervisor Forsman change to a <u>medical</u> physical examination <u>and DOT physical exam</u> arranged for and paid by the township upon hire and every two years thereafter or as determined by the Board. <u>Any further testing requested beyond this is the employee's responsibility to pay for</u>. Second by Supervisor Heikkinen. Motion carried 4-0-1 abstained Chris Klein interested party.

Motion by Supervisor Ness to change performance evaluation paragraph 3 to: All employees will be compensated a minimum of 1 hour of their wage for the performance evaluation or the duration of the evaluation. Second by Supervisor Forsman. Motion carried 4-0-1 abstained Chris Klein interested party.

Budget: Discussed budget items. Reviewed employee wages.

<u>Motion</u> by Supervisor Ness to increase office staff 2% for 2020. Top maintenance employee increase to \$30.00 per hour. 2nd full time maintenance employee \$26.00 per hour. Part time maintenance employees stay at current rate \$20.00 per hour for 2020. Second by Supervisor Heikkinen. Motion carried 4-0-1 abstained Chris Klein interested party. Increases to start January 1, 2020.

<u>Motion</u> by Supervisor Ness to put as a line item on first meeting in June 2020 a discussion regarding a handbook policy for ongoing wage management. Second by Supervisor Heikkinen. Motion carried 4-0-1 abstained Chris Klein.

<u>Motion</u> by Supervisor Klein to call for gravel hauling quotes. Second by Supervisor Ludenia. Motion carried 5-0.

Misc.: Discussed annual meeting topics.

Adjournment: Motion to adjourn at 9:45pm by Supervisor Heikkinen second by Supervisor Forsman. Motion carried.
