Maintenance Report:

Trainings for their employment position: Motion made by Supervisor Helman to approve the March 23rd training for Gravel Road Maintenance, to be available for both maintenance staff and also the March 29th Gopher State One training, in the event of severe weather they are not to go. On the April meeting come back with the cost for the other three trainings, is to be presented to the board, not to exceed \$75.00 per person; Seconded by Supervisor Nelson. Carried 5-0. - b) Policy/Resolution Review and Updates: Board Meeting on April 18, 2023 to discuss policies from the Board and Planning and Zoning.

New Business:

- a) Gavin Woodland, Wright County Public Health presented information on Radon Awareness; Gavin spoke regarding Radon in MN and explained what safe levels are in a home indicating that 2 in 5 homes have high radon. You can purchase radon tests at the Wright County Health and Human services office.
 - b) Quotes for gravel crushing, dust coating and gravel hauling:

Dust Coating: Central Minnesota Dust Control. 33% Dustgard PLUS Liquid Magnesium Chloride. Price is \$1.10 per gallon and includes product and application. Supervisor Helman made a motion to accept the bid from Central Minnesota Dust Control for up to 40,000 gallons for amount stated. Seconded by Supervisor Forsman. Carried 5-0.

Gravel Crushing & Stripping:

Johnson Crushing Inc. Quote #358 from Johnson Crushing Inc. Crushing & Stockpiling ³/₄" CL1 Base: \$3.05/Ton or \$4.27/Yd3, Material testing 2x per day, Fuel Surcharge \$.04 per ton for every \$.25 per gallon increase over \$3.05 per gallon for off road diesel. Availability as of 3/21/2023 is July-October 2023. Johnson Crushing also gave a quote for Stripping only: \$185.00 per hour; Customer would designate and maintain dumping area. Motion made by Supervisor Geyen to accept Johnson Materials for the crushing at \$4.27/yard, up to 10,000 yards, according to quote #358; Seconded by Supervisor Helman. Carried 5-0

<u>Johnson Crushing, Inc.</u> Quote #359 from Johnson Crushing, Inc. Proposal & Quote for Stripping only. Motion made by Chairman Newman to go forward with Johnson Crushing, Inc. for stripping only, for \$212.75 per hour, not to exceed \$25,000.00 for reclamation; Seconded by Supervisor Forsman.

After discussion, Chairman Newman rescinded his motion.

Motion made by Supervisor Helman to accept Johnson Crushing's proposal for stripping at \$212.75 per hour and not to exceed \$5,000.00; Seconded by Supervisor Forsman. Carried 5-0.

Gravel Hauling:

Bjorklund Companies. Gravel hauled to Twp roads: 5,000-7,000 yards at \$4.27 per yard. Gravel Loading with a 950 Cat Loader: 5,000-7,000 yards at \$1.00 per yard. Recommendation to have Bjorklund load it because other companies don't have the quantity of trucks to haul. Motion made by Supervisor Helman to accept Bjorklund Companies' quote for gravel hauling up to 7000 yards at \$4.27 and Cat front end loader up to 7000 yards at \$1.00 for a total not to exceed \$40,000.00. Seconded by Supervisor Nelson. Carried 5-0

Crack Filling:

Motion made by Supervisor Helman to accept the proposal from Bertram Asphalt Company. In discussion. Supervisor Helman rescinded his motion.

Motion made by Chairman Newman to accept Bertram Asphalt Company for crack filling to not exceed \$30,000.00 of material. Seconded by Supervisor Geyen. Carried 5-0

- c) Maple Lake Library Supervisor Forsman talked about the Library and checked to see if we could give the Library \$1,500.00 to help them out. After discussion, the decision to wait until the fall.
