Chair Sandy Forsman called the meeting to order at 7:00 p.m. There were 7 people in the audience at the start of the meeting plus 2 attending on Zoom. Roll call was taken.

Motion by Supervisor Ludenia to approve, clerk/treasurer report, second by Supervisor Heikkinen. Motion carried 5-0.

**MAINTENANCE REPORT:** Supervisor Ludenia reported that the inslopes are done; they will be starting the overlay project Monday, did some chloride on the pit road. On the overlay project there are 8-10 mailboxes that should be replaced with swing away structures; do we want to replace them? It was decided not to. They did seeding on our lawn. Should we put granite instead of mulch around the trees? Will check on prices. Will be working on grading if we get rain. Will be shouldering when overlay is done.

## Old Business:

<u>Gravel Pit Moratorium</u>: We are requesting that the P&Z committee should have some ideas for people to work on the committee. Supervisor Klein asked where we are with the Townships gravel pit and our ability to crush and expand our pit. Supervisor Heikkinen said there is no change, we are not expanding the pit we are digging gravel out of our current pit. Will bring to next P&Z meeting.

Handbook Changes: continue to next meeting for Attorney input.

<u>Social Media Changes</u>: Discussed changes. With the changes made there was a motion by Supervisor Ness to adopt the social media policy for Silver Creek Township on this day 05-18-2021. Second by Supervisor Heikkinen. Motion carried 5-0

## **New Business:**

<u>Temp. Speed limit for Meridian/Appleton</u>: Discussed lowering speed on the road during the I-94 project. Will check with the Sheriff about getting a speed trailer sign put on the road.

<u>Up the Creek Liquor License:</u> Motion by Supervisor Klein to approve Up the Creeks liquor license, second by Supervisor Ludenia. Motion carried 5-0.

Attorney-Discuss when to call: Normally we contact our Township Attorney when the Board approves. There has been times when that has not happened. Motion by Supervisor Klein that the Board agrees that before the Attorney is contacted it has to be agreed upon by a majority of the Board, second by Supervisor Ludenia. Motion failed 2-3. Sandy will pay the Attorney \$220. Motion by Supervisor Klein to approve to pay check 16913 to Couri & Ruppe for \$1870.00, second by Supervisor Ness. Carried 5-0. Motion by Supervisor Ness to pay check 16914 for \$770.00, second by Supervisor Heikkinen. Motion carried 4-1. (Amended 6-1) Supervisor Klein is opposed because he feels there is personal stuff involved & the moratorium was not discussed & approved by the Board.)

Midco would like storage on our property: They would like to leave equipment in our lot this summer for 4 months and 6 months next year for \$300 per month. Motion by Supervisor Ness to accept agreement as written for 2021 for 4 months with pending

review and a new lease agreement for 2022. Second by Supervisor Heikkinen. Motion carried 5-0.
