Noah Fisher for Hoffman Construction, 14650 CR 75: Petitions for an amended Conditional Use Permit for a time period from March 15- August 1, 2020 to extend the night hauling of material from the pit to include Sundays with the hours to start at 6 p.m. Sunday through Saturday at 6 a.m. Also requests hauling of materials on Saturday during the 2020-2021 seasons starting at 6 a.m. to 7 p.m. Mr. Fisher was on the phone to explain the request. They want to change the hauling permit to start it on Sunday night 6:00 pm until Saturday at 9 a.m. Second item would be hauling Saturdays without interfering with Jeff Johnsons 10 Saturdays. Hoffman's would be the only contractor hauling in or out of that pit. The job will get done quicker with these changes. He did not ask about this at the March meeting because he did not know Jeff Johnsons pit hours at that time. The State mandates when you need to work to get the job completed. Traffic counts are lower, so they are working days now. If traffic gets back to normal they will have to work nights. With high traffic counts they cannot work in the median. I-94 project will continue into 2021. They have 15 miles of road Monticello to Clearwater. They are working in the median now and will switch to the outside and that would be more than likely day work if the State allows because there is more clear room. Question asked why work Sunday night. He stated he wants the night crew to work 6 days as well as the day crew. The Township has not received any complaints or comments about the new proposal. Motion by Supervisor Ludenia, seconded by Supervisor Ness that we approve the Hoffman Construction request as written with the approval of the County. Motion carried. 7-0-1 abstained, Mark Egge.
