New Business:

Olson's Truck Stop 4101 148th St NW Internal review of current CUP No one was present from Olson's. We have not received any complaints. Motion by Supervisor Klein to approve the review of the CUP and bring it up for review in 2 years 2023. Second by Supervisor Ness. Motion carried 8-0-1 Sandy abstained because she works there.

Johnsons Material/Martie Pit 14650 CR 75: Jeff Johnson was present, he was asked about the maintenance of the berm such as week abatement, planting of native grasses by Supervisor Heikkinen. He said they seeded last fall so assuming the grass will take over if it gets enough moisture. He was asked about the berm along Hwy 75 because along Curtis Ave that seems to be taken care of. Mr. Johnson said there was not a requirement on his permit for a berm along 75 because the trees were the barrier. The cuts trees that are along 75 will get ground up at some point, but they were not trees removed from the area along Highway 75. (Richard Chwalek joined the meeting). Mr. Johnson said they could replace the dead trees. They will mow more frequently until the grass gets more established. They can mow when they do the ditch out in front of the pit. Motion by Supervisor Heikkinen to approve Johnsons CUP as written with a one year renewal. Second by Richard. Motion carried 9-0. Gravel pit moratorium committee members: The Supervisor Board had decided that the P& Z committee would work on finding member for this new committee. Discussed who would be on the committee. Supervisor Forsman, P&Z committee member Dan Mielke and Richard Chwalek and pit operator Jeff Johnson will be on the committee and will find some Township residents that will be willing to work on it. The members will come up with recommendations and present it to the Township Board for approval. The committee will meet again on June 24th at 7pm and will find additional people to participate.
