- 6. Maintenance done on grader. (Grader control)

- 8. Will start shouldering on 150th St.
- 9. Some reclamation needs to be done in the pit.

Old Business

<u>123rd St Resolution</u>: Resolution was recorded August 19, 2010. Waiver of damages were mailed to residents on 08/08/2019

150th Ave Update: We are doing the inspecting on the road, ITT came out and verified that the work was being done. Sub base was verified. Depending on weather road could be black by end of next week. Gravel cost may come in a little under estimate. We are doing the driveways ourselves. Seeding has been done.

<u>Junk Vehicles</u>: Supervisor Heikkinen & Ness will go out and talk to the property owner this Friday.

<u>Hard surface road preservation maintenance plan</u>: The maintenance department has compiled a list of our hard surfaced roads and the years they were completed. Total asphalt roads is 22 miles, chip sealed roads 8 miles. Today's price for a 2" asphalt overlay is \$100,000 per mile. Chip seal price is \$28,000 per mile. Board will need to decide when to replace or reclaim and put on new asphalt. We will start getting traffic counts done on the roads. Our gravel reserves are down to 3 to 5 years, when they are gone we will spend twice as much for gravel. Will continue to the October 15th meeting to gather more information.

New Business:

<u>Water Heater</u>: Discussed the need for a new hot water heater. Motion by Supervisor Heikkinen to spend up to \$1500 for a single element 30 gallon water heater, with the upgrade on the electrical panel and the water heater installation. Second by Supervisor Ludenia. Motion carried 5-0.

<u>District Meeting:</u> Meeting this year was at Big Lake Township. The district meeting next year will be here.

Misc.:

Discussed the crack filling machine that is for sale on MN Bid. Motion by Supervisor Heikkinen to spend up to \$1200 for the crack filling machine. Second by Supervisor Ludenia. Motion carried 5-0.

<u>Mack Truck 2</u> The issue is that it is not holding air over night. Talked to the service manager of Nuss Truck and he feels that they should be able to find the problem. It was taken to them last Friday. We have over 2000 miles on the truck... We will talk to them about getting some extended warranty on it if they are not able to get it corrected this time.
