#### **MAINTENANCE REPORT:**

Supervisor Ludenia reported that all the salt is in, mowing about done, traffic counters are out, got 2 new tires for one of the trucks and tree cutting should be starting soon.

### **Old Business:**

<u>Items in right of way</u>: Sent out 16 letters requesting that items be taken out of the right of way. Have received a couple calls about people wondering why they have to remove the items.

<u>Culvert prices</u>: New prices for culvert were presented \$11.10 per foot, aprons \$57.75 each and bands \$33.15. Motion by Supervisor Ludenia to adopt new prices, second by Supervisor Klein. Carried 5-0.

<u>Budget 2022</u>: Supervisor Ness talked about what the money from ARPA could be by the end of 2024. Amount gained in the fund can be used to replace general government services. We could save money for chip seal & overlay if we do not gravel next year. Discussed other items for the budget and made some changes. Will clarify some of the line issues for the next meeting.

Culvert issue of 155<sup>th</sup> St: Not sure it was corrected. Will check it out.

#### **New Business:**

Supervisor Ness wondering if we want to get a committee together to start working on getting broadband in the Township using the ARPA funds. Will see what the County is working on for using ARPA funds.

**Misc.:** Supervisor Klein suggested a resolution requesting that Wright County share in some of the money to be used for Townships that are received from the local option sales tax proceeds. Motion made by Supervisor Ness to adopt Resolution 2021-10-19, second by Supervisor Ludenia. Motion carried 5-0.

**Adjournment**: Motion by Supervisor Heikkinen to adjourn, second by Supervisor Ness. All present in favor. The meeting adjourned at 9:10 pm.
