MAINTENANCE REPORT

Supervisor Ludenia gave report

- 1. They have been plowing snow.

- 3. Front tires will be put on the grader.
- 4. Mowing tractor has an oil leak and HVAC issue will need to go to Buffalo for repair.
- 5. Residents are pushing snow across the roads. We will print some notices to leave them, asking them not to do it. There is also an issue with people leaving trash cans in the road.

Old Business

<u>CMRP</u>: Discussed who will attend and report to our Board the information received at the CMRP meetings. Supervisor Heikkinen will be the primary voting member and Supervisor Klein will be the alternate. The road boss will approve PTO time as needed for Chris to attend the meetings depending on the maintenance work load at the time. We cut the check for \$15,000 to the CMRP and invoiced Wright Co for half of the membership. Supervisor Heikkinen will take the check and paperwork to the meeting.

New Business:

<u>Appoint Road Boss</u>: Motion by Supervisor Forsman to nominate Mike Ludenia for the Road Boss second by Supervisor Heikkinen. Motion carried 4-0, 1 abstained Chris Klein interested party.

<u>Audit Firm info</u>: Clerk has contacted a couple firms. Will need to budget \$7000.00 to 8,000 for an audit.

<u>Budget 2020</u>: Reviewed income and expenses from 2018 and 2019. Discussed our needs for 2020. Will review the preliminary budget figures and discuss at another meeting.

RESOLUTION NO. 2019-12-17 RESOLUTION AUTHORIZING CONTRACT WITH INTERESTED OFFICER UNDER Minn. Stat. § 471.88, subd. 5.

WHEREAS, the Board of Supervisors ("Town Board") of Silver Creek Township ("Town" or "Township") rely on a Town Supervisor to perform various tasks for the Town that the Town does not otherwise have adequate staff to perform on its behalf, including, but not limited to, the following:

- 1. Miscellaneous items of work to keep the Town's roads and right of ways free from debris and fallen limbs, etc.: and
- 2. Inspection of roads; and
- 3. Grading, snowplowing, and general maintenance of roads; and
- 4. Equipment operation, maintenance, repairs, grounds and building maintenance and repairs and general labor required for the position.

WHEREAS, Minn. Stat. § 366.01, Subd. 1, reflects the broad roles that Supervisors play in the functioning of a Township by stating that Supervisors shall have charge of "all town affairs not committed to other officers by law"; and

WHEREAS, Silver Creek Township wishes to retain the services of the Supervisor Chris Klein to perform various maintenance work on behalf of the Township.

NOW, THEREFORE, BE IT RESOLVED that the Town Board, upon a unanimous vote of the Supervisors with the interested officer abstaining, finds that the hourly rate of \$\(\frac{25.00}{25.00} \) plus full time benefits plus overtime as accrued in the Employee Policy Handbook that Supervisor Klein receives for his work performing road maintenance and general public works duties for the Township public works department as assigned by the Township Road Boss is as low as, or lower than, the price at which the services he provides could be obtained from other sources.

BE IT FURTHER RESOLVED, that this resolution shall be effective from January 1, 2020 until December 31, 2020.
