Resident came in and he thinks he has the Townships old type grader is in his wood grove and

he wants to donate to the Township. Supervisor Nelson, Supervisor Geyen and Maintenance employees to go look at the grader.

Old Business:

- a) Town Line Road Resolutions Update wording on the Resolutions to say: "Cost share shall be 50% of all other agreed upon Maintenance repairs required. Supervisor Geyen made a motion to approve the updated wording; Seconded by, Supervisor Nelson. Carried 5-0.
- b) All Elements Had an update on the roof, they're going to reduce the size, cost came down to \$4,360.00.
- c) Road Supervisor Inspection of Gowan & Crofoot Maintenance & Supervisor Forsman went over to Gowan Ave and noticed the water is flowing well, looks like the Beaver Dam is broken up. Fence will be replaced in the spring. The grate in front of the culvert works great to keep any debris coming in.

Crofoot – Drain Tile put in looks and works really well.

New Business:

a) Commissioner Darek Vetsch -

TST grant Township Surface Transportation Grant – Discussed the requirements on the project and how it can be accomplished with the dollars.

Broadband – There is one more round that will be happening where ISP providers that will be applying for the next years Border to Border grant allocation and will be doing a match that. Recycling & Compost facility – Over the last couple of years the County has put some money aside to work on demolishing and reconstruction of the site. The goal is to get a drive thru operation to be open more hours for residents. Hours this summer of 2024 should be Tuesday, Wednesday, Thursday and Saturday's until noon. Drive thru and drop your stuff off.

In 2022 there were 7074 visits made out to the site to drop items off.

In 2023 the amount of visits were 7596. Of those stops they shipped 1,363 appliances, 6,604 light bulbs, 66,866 or 99,000lbs of electronics, 1,162 Tires, 186 Styrofoam boxes, and 90 tons of metal.

MPCA – Might be changing the program that when we recycle we get a portion of dollars back from the County and now the change might be that we have to apply to get the dollars back from MPCA.

Planning & Zoning 101 – Annual Training for Township Supervisors & Clerks on P&Z and walking through the whole system on how it works.

- b) Annual Polling Place Resolution Designating Annual Polling Place. Board says only if we move polling places.
- c) MNDOT Certification & Recertification Courses Already covered in the Maintenance section.
- d) Administrative Policy Resolution 4th Whereas This Resolution will replace the other Policy the document that has been noted Silver Creek Township Personal Communication and Social Media Policy. Motion made by Supervisor Geyen to approve the Resolution as read. Seconded by Supervisor Forsman. Carried 5-0. Adopted on the 19th day of December 2023.
- Chairman Newman would like to make the Resolution part of the record of the minutes, so it can also be posted and part of public record in it's form; Seconded by Supervisor Helman. Carried 5-0
- e) Emergency Snowplow Driver Supervisor Nelson would like to be a backup Snowplow driver, he would need to be formally trained. He has his MNDOT Cert & A class. Make it part of the Conflict of Resolution.
- f) Employee Review-Closed Supervisor Helman made a motion to have the Road Authority and one additional supervisor performs the Employee Maintenance review, at a time you can meet. Seconded by Supervisor Geyen. Carried 5-0.
