150<sup>th</sup> St Update: Talked with the engineer on the project. They have done soil borings. They should have the back slopes lines to us so we can start talking to some of the residents. Will send a letter to the residents on 150<sup>th</sup> St letting them know what will be done.

Maple Lake Library thank you letter: They send a letter of thanks for the donation.

Maple Lake Town Lines: A couple of the Supervisors talked to Maple Lake about an agreement with them on work on the town line roads. What happens if other Townships do not want to participate? We will work on a written agreement and have our attorney write up the agreement. Will work with Monticello Township also.

### **New Business:**

Shop Heater: There have been problems with the heater on the west wall, they have had to replace some parts, but they are having trouble getting the correct parts to do repairs. The cost for a new radiant tube heater is \$3450. Will check on the price for a forced air heater.

Right of Way encroachment 107<sup>th</sup> St: There is a snow fence that has been put up in the right of way. We will be sending a certified letter to let them know that the township will not be responsible for any damage and that they should remove the fence.

Illegal Driveway 10589 Amery Ave: Will send a letter letting them know they have an illegal driveway along with a copy of the ordinance.

Hall Cleaner: The lady that is cleaning the hall has requested an increase to \$200.00 per month. Will check with her to see if she has liability insurance for her business. Will try to find what other cleaners are getting for cleaning service.

**Misc.:** The drain in the shop is bad and will need to be fixed.

**Adjournment:** Motion to adjourn by Supervisor Forsman. Second by Supervisor Ness. All present in favor. Motion passed. Adjourned at 8:45 pm.
