**Quarterly Billing**

First 900 Cubic Feet per quarter \$ 68.90  
 In excess of 900 Cubic Feet per quarter \$ 5.02 per 100 cu. ft.

If billed monthly, consumption steps and the Minimum Charge will be one-third of the quarterly charges.

**Minimum Charge**


The minimum for different sizes of meters will be billed on a quarterly basis in accordance with the 'Utility's billing procedure and these minimums will apply:



**Rates:**


Each private hydrant furnished, installed and maintained by the user \$ 1,147.00  
for private fire protection, per year.

Private fire service for automatic sprinklers, standpipes, or hose \$ 191.00  
connections to be used only for fire protection inside of buildings, a  
charge per inch of service pipe diameter, per year.

**Terms of Payment:**

The above rates are net, and billed quarterly in arrears.

To the Town of Southwest Harbor for Municipal Fire Protection.


**Rates:**
