Now, therefore, for and valuable considerations, the parties to the Agreement Agree as follows:

1. Adopter shall be asked to make a non-refundable donation of \$ \_\_\_\_\_. The donation shall be used to help Pawsitive Life offset the expenses incurred in medical, foster-care, and rescuing of these animals. \_\_\_\_\_
2. Pawsitive Life makes no representations or warranties concerning the health, temperament, and/or previous ownership of the pet, other than expressly stated herein. Adopter understands that Pawsitive Life shall not be liable for any further medical care or treatment of the pet after adoption. Outside of what the foster and adopter has agreed upon for medical, all health care and medical care shall be the adopter's responsibility. \_\_\_\_\_
3. Adopter understands that pets typically need time to adjust to their new home, yard, and surroundings. Adopter acknowledges this and will contact Pawsitive Life if further assistance is needed in helping the pet adjust properly. Typically, a new pet might not eat or drink for a couple of days which is normal. Its housebreaking routine has changed and will have to readjust to your sleeping and household schedule. Dogs typically need supervision when coming into a new yard. It is advisable to be with your pet at first to watch its habits and insure it does not get out. \_\_\_\_\_
4. Adopter shall not transfer the pet to any other person. If Adopter no longer wants or can no longer care for the pet, Adopter shall contact Pawsitive Life and a representative will discuss options and help to relocate the pet. \_\_\_\_\_
5. Adopter shall not keep the pet outdoors for extended periods of time in extreme weather conditions. Adopter shall not chain or tie the pet for an unreasonable period of time and never leave the pet alone if traveling. Adopter shall not use shock collars or perimeter fencing. Cats are INDOORS ONLY and shall not be declawed. Animals shall not be altered in anyway which includes tail docking or ear cropping. \_\_\_\_\_
6. Adopter shall provide vaccines appropriately, have a rabies tag current, and keep their adopted pet healthy. \_\_\_\_\_

In the event Pawsitive Life determines, in its sole discretion, Adopter is not providing proper care, or did not have what was stated in the application or is otherwise in breach of any of its obligations herein, Pawsitive Life shall be entitled to take the pet back and the donation made by the Adopter shall be forfeited. \_\_\_\_\_
- 8. If Adopter resides in a rented home, Adopter shall provide Pawsitive Life with a copy of the lease approving pets in rental housing prior to final placement of the adopted pet. \_\_\_\_\_
- 9. Adopter agrees to indemnify and hold harmless Pawsitive Life, the officers, board members, agents, and representatives, for and against any and all manner of actions and causes of actions, suits, debts, dues, accts., bonds, covenants, agreements, judgments, claims and demands whatsoever arising out of or relating to the adoption, placement and/or possession of the pet. \_\_\_\_\_
