- Payment processors (for transaction confirmations).
- Publicly available sources, for verification or security.

2. How We Use Your Information

We use the information we collect for:

- **Service Delivery** Creating accounts, processing transactions, providing resources.
- Community Engagement Enabling discussions, collaborations, and mutual aid connections.
- Improvement and Development Enhancing features, content, and user experience.

- Security and Compliance Fraud prevention, dispute resolution, enforcing policies.
- Outreach Sending updates, newsletters, event notices (with your consent).

We will never sell your personal information to advertisers or third parties.

3. Sharing of Information

We share your information only when necessary:

- With Service Providers Payment processors, hosting providers, analytics services.
- For Legal Requirements When required by law, subpoena, or to protect rights and safety.
- With Your Consent If you explicitly authorize sharing (e.g., collaboration requests).
- In Community Features Information you post publicly (forums, profiles) will be visible to others.

4. Data Storage and Retention
