

Annual Election - December 5th!**

The Election will take place the day of the **December 5th** meeting at the Gerry. **Polls will open at noon and close at 8:00 p.m.** Ballots are being mailed to all members and will also be available at the Club the day of the election. Please complete your ballot and return it to the Club during the voting period to cast your ballot.

Only absentee ballots may be mailed! Absentee ballots **must be RECEIVED by 6 p.m., December 5, 2018.** The ballots must be filled out by the absentee, placed in a sealed envelope with the member's name and address on the outside, placed in a second envelope and mailed to the club with the words "ELECTION BALLOT" on the outside. The inside envelope shall contain the completed ballot along with the reason for the mailed ballot. A legitimate reason must be made for the absentee ballot.

Write-in or sticker candidates must present a written notice of intention to the President prior to the start of voting on Election Day in December.

Please cast your ballot carefully, remembering the duties required of each position, and make **your** selection for the person best qualified for the position.

Also, remember we have a "no campaigning" rule. No campaigning of any sort may take place on Club property. All positions should be elected on merit. We thank you for your participation and support.

Members are reminded that nominees must possess the skills, knowledge, and abilities to serve in the position for which they are nominated.

"The **President** shall be the Chief Executive of the Corporation and shall preside at all meetings, when present. The President shall perform all duties incident to this office and shall perform such duties as the Board of Directors shall from time to time designate." The President is not responsible for daily club operations.

"The **Vice President** shall preside at all meetings in the absence of the President and shall have such other duties as the Board of Directors may from time to time designate." Traditionally, the Vice President manages the kitchen as an ad hoc duty.

"The **Board of Directors** shall have the entire management of the business of the Corporation." The Board of Directors is required to perform their duties in good faith, with ordinary care (the use of good judgment and common sense), and in the best interest of the Club, displaying loyalty and obedience of the Club laws. Directors are required to attend Board meetings twice a month and special meetings as necessary.

"The **Foreman** shall have the custody of and control over the hand engine, truck, bus, and any other and all property used or to be used at musters. The Foreman shall have control of the use of all property of the Corporation at musters and parades."

"The **Assistant Foreman** shall perform all the duties of the Foreman in the absence of the Foreman and shall, under the direction and control of the Foreman, assist the Foreman in the performance of the Foreman's duties."

Amended By-Law Changes – December 5th Vote

The following changes to By-Laws Article XVIII

Membership, Article XIX Dues, Article XXVII Amendments and introduction of a new Article XX Assessments were proposed at the October meeting upon the recommendation of the Board of Directors. Discussion of the proposed changes and amendments occurred at the November meeting.

The proposed revisions are as stated below (***bold italics*** indicates the change). They are also posted in the Clubroom and on the web site under Business Documents on the Library page (www.gerry5.com/library.)

These will be voted on at the December meeting via paper ballot. Every vote counts! **PLEASE ATTEND THE DECEMBER 5TH MEETING TO VOTE ON THESE CHANGES.**

ARTICLE XXVII – Amendments: These By-Laws may be amended, altered, repealed, or revised annually. ***By-Law amendments will be presented at October member meeting. The amendment will be posted and discussed at the November member meeting. The amendment(s) will be voted upon using paper ballots at the December member meeting. Any amendment changes will take effect immediately, unless stipulated otherwise, but no later than on January 1st of the New Year. By Law amendments must be approved by a two-thirds (2/3) majority vote of the members present.***

The Secretary shall notify each member at the address provided by the member, at least seven (7) days before the next meeting, of the proposed By-Law change ***via email or regular mail if no e-mail available***. The By-Law change will be voted upon at that following meeting.

ARTICLE XIX - Annual Dues: The annual dues shall be ***one hundred dollars (\$100.00) per year***, payable on or before the first WEDNESDAY of February of each year, unless an extension has been granted by the BOD

Any member 75 years of age or older shall pay annual dues in the amount of ***fifty (\$50.00)***.

ARTICLE XVIII – Membership: An Applicant for membership shall post ***the sum of the administrative fee plus the first year's dues with their application. Fifty dollars (\$50.00) of this sum is the administrative fee for membership in the Association.***

Those applicants re-applying after a lapsed membership may not be required to attend orientation.

ARTICLE XX – Assessments: From time to time, financial emergencies arise that must be dealt with to assure continued viability of the Corporation. It is appropriate to deal with those situations via an assessment. Such assessment would be proposed by the Board and presented to the membership at the next regular monthly meeting. The Secretary shall notify all members via email (or regular mail if no e-mail). The assessment will be voted upon at the following regular monthly meeting. A two-thirds (2/3) majority of those voting will determine acceptance or rejection.

Collection of the assessment shall be done in a finite period as determined by the Board. Failure to pay the assessment may result in loss of membership privileges until paid. All members, including Life and Honorary Members, shall be subject to all assessments levied by the Corporation, unless the assessment is dues-related.

Annual Dues/Membership Renewals Deadline is March 6th!

Due to the possible dues increase being voted on at the December Annual meeting, renewal forms will NOT be mailed to members until after the results of the vote. Members should expect to receive the renewal form by mid-December 2018. Forms will also be available at the Club at that time. The normal due date is January 2019 but no later than the February 6th meeting. But, due to the possible change in annual dues, **the Board of Directors is extending the payment deadline until NLT March 6, 2019.** Membership Renewals requesting dues payment will be mailed to each member following the December member meeting.




