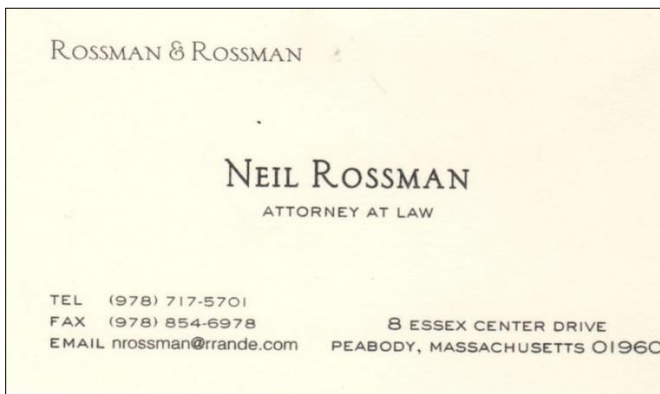

Nominations for Officers and Directors – November Meeting

New Business at the November 6th member meeting will include

nominations of Officers and at least three Director positions. The



Offices of President, Vice President, and Foreman are available for nomination. There are **at least three** Director positions up for nomination, each to serve a two-year term.

Nominations must be made from the floor. The person being nominated must be present to accept the nomination. If the nominee is not present, the member making the nomination must present a written acceptance letter by the nominee to the Chairman of the meeting. No name will be placed on the ballot unless the nomination has been accepted.

Write-in or sticker candidates **must** present a written notice of intention to the President prior to the start of voting on Election Day in December.

Members are reminded that nominees must possess the skills, knowledge, and abilities to serve in the position for which they are nominated.

Also, all nominees and members please remember we have a no campaigning rule. All persons must be elected on merit and not popularity.

Reminder of the responsibilities of each position:

"The **President** shall be the Chief Executive of the Corporation and shall preside at all meetings, when present. The President shall perform all duties incident to this office and shall perform such duties as the Board of Directors shall from time to time designate." The President is not responsible for daily club operations.

" The **Vice President** shall preside at all meetings in the absence of the President and shall have such other duties as the Board of Directors may from time to time designate."

"The **Board of Directors** shall have the entire management of the business of the Corporation." The Board of Directors is required to perform their duties in good faith, with ordinary care (the use of good judgment and common sense), and in the best interest of the Club, displaying loyalty and obedience of the Club laws. Directors are required to attend Board meetings twice a month and special meetings as necessary.

"The **Foreman** shall have the custody of and control over the hand engine, truck, bus, and any other and all property used or to be used at musters. The Foreman shall have control of the use of all property of the Corporation at musters and parades."

By-Law Changes Introduced – Discussion Nov 6th, Vote Dec 4th

The following changes to By-Laws Article III Regular Meeting of Members and Article XIX Dues, were proposed at the October meeting upon the recommendation of the Board of Directors.

Discussion of the proposed changes and any proposed amendments to these will take place at the November meeting. These changes affect ALL MEMBERS. Please read these carefully and plan to attend the November meeting. The Board needs your feedback regarding these proposed changes. The Board encourages all members to participate in order to make this a collaborative effort and decision.

The proposed revisions are as stated below (the proposed change will be added to the end of the existing By-Law if accepted.). These are also posted in the Clubroom and on the web site under Business Documents on the Library page (www.gerry5.com/library.)

| ARTICLE III |
| Regular Meeting of Members |
| The Board of Directors may reschedule this meeting as deemed necessary in response to emergencies and acts of God. |
| RATIONALE – Gives Board the ability to change meetings due to emergencies at the Club or in general and in response to weather situations that could put the safety of members at risk by trying to attend. |
| ARTICLE XIX |
| Annual Dues |
| Members may Resign their membership at any time. Resignations are a conscious decision on the part of the member that personal circumstances do not allow them to continue their membership at this time. The intent is to return as a member in the future. All resignations must be tendered in writing or via e-mail. Members who resign remain in good standing with the Corporation and may attend periodically as guests. When Resigned members decide to return to paid, active status, they must pay the current rate for dues and provide their current contact information to the Corporation. |

RATIONALE – The resignation process has been long established. This clarifies the difference between Read Out (someone who lets their dues lapse and is not a member in good standing) and Resignation (informs Club they will not be renewing for a period of time due to personal reasons but remain in good standing). It also simplifies the reinstatement process for Resigned members. The Resigned member will pay current rate of dues only (no processing fee) and provide their current contact information. They do not have to go through the voting process.

Yes, we're doing it again! Last year's raffle was a success and helped the Gerry raise funds for general operating expenses. This year we are focusing on raising funds toward painting the outside of the building.

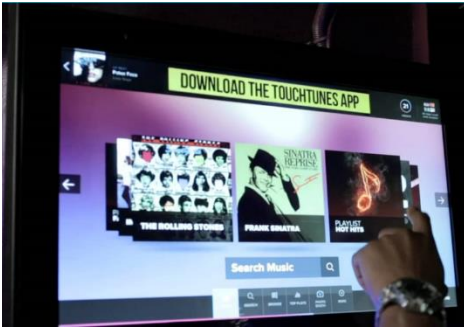
