It is here fore order, adjudged and decreed that the water district be, and hereby is, authorized to install and maintain a water pipeline in and along the public roads described in the first paragraph hereof, subject however, to the following rules and regulations:

- That said water district repair and restore said County Road to its original condition following the installation of any maintenance work on said water pipe line:
- 2. That such installation and maintenance be conducted and preformed in such manner and at such time as not unreasonable to interrupt or interfere with the normal flow of traffic upon said County Road:
- 3. That such water pipe installed in said road at a sufficient dept as not to interfere in any way with the maintenance thereof:
- 4. That such water pipe be installed on County shoulder, and not in the traveled portion of road, except to cross road to get to the other side.
- 5. It is to be fully understood by both parties, that during construction and until the road is duly repaired, Ralls County is not to be held responsible.
