August 14, 2014


Whereas, the Conflict of Interest for Pike County, Missouri must be renewed no later than September 15<sup>th</sup>, 2014, in order for the ordinance to remain in effect; the Pike County Commission meets today, August 11<sup>th</sup> to renew this ordinance as follows:

Only the Chief Purchasing Officer ( County Clerk), the Chief Administrative Officer ( Presiding Commissioner) and any elected official or employee who has had a transaction of more than \$500.00 with Pike County are required to complete the Personal Financial Disclosure to be sent to the Missouri Ethics Commission.




