

Commission in session pursuant to adjournment at the Courthouse
in Bowling Green, County of Pike, State of Missouri;

Bill Allen called the meeting to order at 9:00am and moved to accept the agenda as presented. Brock Bailey, seconded. Vote 3-0

The Commission met with Tracy Foster for clarification on a local apartment complex appraisal. The appraisal is required due to potential appeal to State Tax Board.

The Commission met with Billy Orf, R&B Supervisor:

- *Discussed grader schedules
- *Discussed Pike 225
- *Billy requested improvements to the shop, including a lift for making repairs and general maintenance. He will seek specifications for the improvements.

Commission discussed solar projects and potential future sights that are being considered.

The Commission met with Olivia Ledford, Treasurer. Olivia was wanting clarification on a bill that she had received and confusion surrounding payment. The bill will be paid for the appraisal request from the Assessor's Office.

Commission met with Sheriff Korte about some local issues.

Commission prepared a support letter for a sidewalk grant for Louisiana to be located in front Louisiana R-II along Georgia St. The project includes the Twin Pike YMCA, City of Louisiana, Louisiana R-II, and County of Pike. The letter states that the county will support the project at a 25% match, not to exceed \$15,000.

Commission met with Carolyn Wisecarver, PCDA:

- *Commission signed a letter for George Fantz for a temporary easement and staging area for the Bowling Green walk bridge project.
- *Pike 227 bridge is waiting for Cochran Engineering report.
- *Documents were signed for Louisiana walk bridge project.
- *Discussed several pending projects.
- *Promotion of the Internet Use Tax issue will be done by PCDA, since the commission can't legally do so.

Commission reviewed the budget and budget reports for a mid-year analysis.


