#### **Preface**

ur understanding of the realms of Heaven is extremely feeble. If you have read my other books, you will notice that I don't try to persuade you of this concept or that concept. I won't bother with that. It takes a tremendous amount of energy to debate and "prove" things to someone who does not have hearing ears. Jesus over and over used the phrase, "He that has ears, let him hear." If you do not have a hearing ear, I cannot help you. If you are under the illusion that you can and should understand all about God and how things work in the world around you, particularly if you tell yourself, that "unless I can understand it (or prove it), I won't embrace it," then you will be disillusioned.

You will be sitting in the dark because you cannot really understand how electricity works or any of a host of other things. If you genuinely feel that way you will be disillusioned. It is inevitable. To think that I am actually smart enough to understand everything is rather arrogant. The Bible warns us not to think of ourselves more highly than we ought.

To help us learn the Court System of Heaven, the Just Judge has provided a straightforward means of aiding us—a Help Desk. As we are learning to maneuver in the courts, we can just step up to the help desk and describe the issue to the attendant. Then we can ask, "Where should I go to deal with this?"

In Hebrews 4:16, we read:

### Chapter 1 Katherine's Adventure

y friend Katherine had just been informed of the availability of the Help Desk within the Courts of Heaven. After I explained this scenario, she immediately began to engage the Help Desk. She stepped into the realms of Heaven and walked up to the Help Desk. She described her situation to the attendant and asked for aid.

The assisting angel then took her by the hand and escorted her down a large corridor. They chatted as they walked. The ceiling was quite high, and large rooms were on either side of the corridor. This complex is was and is quite majestic. It speaks of power. The angel brought her into a room that was on the right side. Through the doorway, she could see lots of books in the place. I asked her to look above the door for the sign that would tell her where she was. It read, "Court of Records."

She stepped in, and another angel immediately asked, "May I help you?" Again, she explained that she needed to see inside her book for help as to where she

was in her life right now. The angel escorted her down an aisle and stopped at a shelf with some books and a large box. Katherine intuitively knew this was information for her.

She took the box down from the shelf and saw in it what appeared to be something like USB or memory sticks that you would use with a computer. She merely touched one and a video began to play. She saw that it had a Fast Forward button, a Rewind button, and a Play button just like a DVD player might have. She could also pause the video to get a closer look at something or someone in the video if she needed to.

She was drawn to one particular memory stick.

When I say she was drawn to one particular memory stick, it is as if she were looking at a row of light bulbs and one was brighter than the others. To that one, she paid special attention. You will find this is often the case in the realms of Heaven. You will see something that you are particularly drawn to and this is typically because it contains something you need to know at that time.

As she played a particular video, she recognized someone and knew instinctively she was to meet with them and share some things about the Courts of Heaven. She had been hesitant to share things with them before because she felt she lacked enough understanding. Yet

with the experiences she had this particular day she felt more competent to share her experiences with the Help Desk. This was an instructional visit to the Court of Records and showed her a present assignment.

When she felt she had seen what she needed to see, the angel took the box and put it back on the shelf. They walked back outside whereupon the first angelic escort was waiting for her.

Previously I shared about seeing the clock that moved forward rapidly for an extended period of time. This clock involved a man who had made some poor decisions years before which had affected his life and his family. In working with his wife in the courts, we accessed his book regarding the time in his life when the events first occurred. We had already been in the Court of Titles & Deeds and gotten proper ownership re-established in his life and we were now requesting to see his book regarding where he was in his life now.

As his wife saw his book, she saw pages and pages of adverse events being erased. She had a knowing that even events where they as a family should have had great times of joy but hadn't would be times that God was going to restore.

In his case, the books were being erased all the way back to the time of the first wrong decision. The times were now being re-written for his life and his family. The joy that came forth from the knowing that the Lord was erasing the past and granting a new future was immense. Only the Lord can delete our history and give us new

futures. He can make situations that have been bad as if they had never existed.

The implications for this occurring in people's lives are immense. Your past does not have to dictate your future. It is as if He has taken a video of your life, cut out the bad parts, and re-rendered the footage in such a way that you don't even have memories of the bad times. Or if you can recall them, the sting or pain in your heart caused by the bad times is gone.

<sup>18</sup> Do not remember the former things, nor consider the things of old. <sup>19</sup> Behold, I will do a new thing, now it shall spring forth; shall you not know it? I will even make a road in the wilderness and rivers in the desert. (Isaiah 43:18-19)

Then He who sat on the throne said, 'Behold, I make all things new.' (Revelation 21:5)

He can place you exactly where you need to be at precisely the right time so you can move forward with your life.

Redeeming\* the time, because the days are evil. (Ephesians 5:16)

Walk in wisdom toward those who are outside, redeeming\* the time. (Colossians 4:5)

\*The word translated "redeeming" means to "rescue from losses," or "to buy back." The Lord is able to cause this to be so in our lives.

On another occasion, we were given access to someone's box and in it were file folders. One was

marked "Outstanding." We felt instructed to take it out of the box. We were then told by our assisting angel in that court to bring it to the Court of Appeals because it contained some false judgments that needed to be dealt with by that person.

Also, we were told to take out a Requisition Form. It was a requisition for finances, and it had the current date written on it. We were instructed to complete it and submit it with the "Outstanding" folder in the Court of Appeals.

We completed our work in the Court of Records and took the "Outstanding" folder with us and were escorted to the Court of Appeals.

We found the court ready for our appearance. The man with the folder walked up to the Judge's bench and handed the folder to the Judge. The Judge opened the folder and began to read through it. He looked up from the paperwork and asked what the man wanted the court to do about the items in the folder. The man requested that the false verdicts be overturned and replaced with righteous verdicts and that restitution be made where appropriate. He also asked for extra help for his wife about a situation.

The Judge nodded and said, "Petition granted." We handed him the requisition form also and thanked him for his help. He, after stamping and signing the papers, handed them off to the bailiff for recording and dispatch by the angels, and we left the courtroom.

In all these events we were aware that we were working within the realms of Heaven. In the next chapter, I will talk about learning to access these heavenly realms to maximize your work in the Courts of Heaven.

## Chapter 2 Engaging Heaven

ngaging anything within the realms of Heaven requires a willingness to see, hear, or at least perceive. Some are very adept at seeing or hearing in the realm of the Spirit while others struggle with being able to do so. Often I am asked how people in this situation can clear that up.

In my experience, the inability to see is often the result of covenants we have made with ourselves not to see. This could have resulted from having seen something earlier in your life in the form of a vision or dream which so disturbed you that you decided that you would shut that aspect of your life down and not allow yourself to see anymore.

In other cases, you may have heard that seeing or hearing was "dangerous" and that you should not do it. Again, you made a covenant of some sort with yourself to be obedient to the person who told you it was bad, and you shut down that capability. Many of us were told that imagination was bad. You may have had someone tell

you the old adage, "The idle mind is the devil's workshop." It should read, 'The idolatrous mind is the devil's workshop.' With that, you find a great deal of difference. The Bible does speak of vain imaginations, but it also tells us this:

And it shall come to pass afterward that I will pour out My Spirit on all flesh; your sons and your daughters shall prophesy, your old men shall dream dreams, your young men shall see visions. (Joel 2:28)

Peter quoted this passage<sup>1</sup> in his first sermon on the Day of Pentecost after Holy Spirit had been poured out. God did not do away with our imaginations, and we are also told that:

For who has known the mind of the Lord that he may instruct him? But we have the mind of Christ. (1 Corinthians 2:16) (Emphasis mine)

What will we be ruled by? Others opinions, or the instruction of the Word of God? I recommend the Word of God.

If you find yourself identifying with the scenarios I have presented, then our next step is to repent for embracing the lies blocking seeing and ask forgiveness of the Lord. Then ask that Holy Spirit restore seeing and/or hearing capacity to you.

Once you have done so, then begin to exercise your seeing and/or hearing capability so that it increases in your life.

I would be remiss if I did not aid you in learning to access the realms of Heaven. In my book, *Engaging the Courts of Heaven*, I teach on the subject of how to access the realms of Heaven. Until you have mastered this concept, it will be challenging for you to engage the Courts effectively.

#### Accessing the Realms of Heaven

A tremendous privilege we share in this time in history is the ability to access the realms of Heaven with ease. Many of us were taught that Heaven is a placed reserved only for after you die. Heaven is much more than a final destination on a journey. It can also here and now be a vital aspect of that journey.

What I am about to share is vital in progressing in the various Courts of Heaven. We can access the Mercy Court (see the next chapter) while planted here on the earth, but to maximize our endeavors in the Courts of Heaven, we need to learn how to operate FROM Heaven.

In teaching on accessing the realms of Heaven, I often point out some simple facts. If you were to tell me you were a citizen of a particular town, but you could tell me little of it from your personal experience, I would have a tendency to doubt the authenticity of your citizenship. I am a citizen of a small town in central North Carolina. I am familiar with the location of the City Hall, Police Station, hospital, local county courthouse, Sheriff's Department, and much more. I know where many sporting events will be held. I know where the parks are. I know many of the stores and restaurants. I am familiar with this small town. Yet, if I were to ask the average believer what they can describe of Heaven from personal experience, the answer will likely be "nothing." They have no personal knowledge of Heaven that they can relate to Me. It does not have to be like that.

#### The Heavens are Open Now

In Matthew 3, Jesus informed us that the Kingdom of Heaven was at hand. You could say, "the Kingdom of Heaven is as close as your hand." Hold your hand up in front of your nose as close as you can. Do not touch your nose. Heaven is closer to you than that. It is not far, far away up in the sky. It is not "over yonder" as some old hymns describe. It is a very present reality separated from us by a very thin membrane, and we can access it by faith. The way to it is straightforward.

When Jesus was baptized in the River Jordan, as he came up out of the water IMMEDIATELY the heavens were opened. He both saw (a dove descending) and heard (a voice coming from Heaven). That one act of Jesus restored our ability to access Heaven. We can experience open Heavens over our lives. We don't have to wait. We can live conscious of the realm of Heaven and live out of that reality!

#### An Exercise of Faith

Everything we do as believers we must do by faith. Accessing the realms of Heaven is done the same way. In Chapter 5, I spoke of how prophetic acts can create realities for us. It is the same with this. You can visualize stepping from one room into another easily. It is like stepping from one place to another. To learn to access the realms of Heaven, you follow the same pattern.

Stand up from where you are now and prepare to work with me. You can experience the realms of Heaven right now! You don't have to wait until you are dressed up in a long box at the local funeral home or your remains fill an urn. You can experience Heaven while you are alive!

Quiet yourself down. Turn off distracting background noises if possible. Prepare to relax and focus. Now, say this with me:

Father, I would like to access the realms of Heaven today. So right now, by faith, I take a step into the realms of Heaven. [As you say that, take a step forward.] Imagine you are going from one place to another in a single step. Once you have done so, pay attention to what you see and hear. You may see very bright lights; you may see a river, a pastoral scene, a garden, or any number of things. You, right now are experiencing a taste of Heaven. You will notice the peace that pervades the atmosphere of Heaven. You might

notice the air seems electric with life. The testimonies I've heard are always amazing and beautiful to hear.

Now spend a few minutes in this place. Remember, Jesus said to enter the Kingdom you must come as a little child. I often coach people to imagine yourself as an 8-year-old with what you are seeing. What would an 8-year-old do? He or she would be inquisitive and ask, 'What is this? What does that do? Where does that go? Can I go here?' If a child saw a river or a lake, what would that child want to do? Most would want to jump in the water.

The variety is infinite. The colors you see are amazing, and the sounds are so beautiful. You can learn to do this on a regular basis. When you access the realms of Heaven, you are home. You were made to experience the beauty that is Heaven.

The reason learning to access the realms of Heaven is crucial to engaging the Courts of Heaven is that much of what we do should be done FROM Heaven. We need to learn to engage Heaven and work from it.

#### Seeing in the Spirit

Many people tell me they can't "see" visually in the spirit. Often they are discounting the ability they do have. They may be discounting their "knower." Every

believer has a "knower" at work within them. This "knower" who is Holy Spirit at work within you helps you perceive things. As you discern whether something is good or evil, He works to guide you more than you may have realized. Most navies that have submarines have a device known as sonar. Sonar gives a submarine "eyes" to see what is in their vicinity. The operator can detect by the ping the sonar gives off what the object is. They can also determine the distance to the object, and if it is another submarine. They can even identify what class of submarine it might be. But, a video camera would be rather useless underwater.

The military has a similar device for above ground situations known as radar. It functions in the same manner. If a pilot were flying through thick cloud cover, the pilot would need to know what is in his path. Radar then becomes his eyes.

Some people function visually. They often see what amounts to pictures or video images when they "see" in the spirit. They may see more detail. Yet one operating by his or her "knower" (their spiritual radar or sonar) can be just as effective as a seer. If you operate more like one with sonar or radar, don't discount what you "see" in that manner. This is how I function and I have been doing this type of work for many years.

I can often detect where an angel is in the room or instead if it is one of the men or women in white linen and not an angel). I can often detect how many beings are present and whether they have something they are to present to someone. I can recognize any number of things, and even though this is not "visual," it is still "seeing." Understanding that operating by your "knower" is as valid as any other type of vision will set your mind at ease. It will help you to realize you have seen much more than you know and you may know much more than some who only sees.

#### **Knowing Your Knower**

Everyone has a "knower." That is a fancy word for the thing inside you that keeps you aware of things going on around you. As you can tell, it's a bit hard to explain, but if I were to ask you, "Don't you often seem to 'know' things?" You would likely tell me, "yes." It's an inward guidance system. We all have a "knower." Even before we came to know Jesus we had a "knower." It is just that now that you know Jesus, your "knower" can work even better because you are learning to cooperate with Heaven.

In the realms of Heaven is all knowledge. Everything one would need to know is available in Heaven. We have to learn how to tap into that knowledge system.

If we have received the baptism in the Holy Spirit and exercise a prayer language, we are tapping into the information system of Heaven. It is one of the purposes of speaking in tongues. Holy Spirit described it to me as "your library card to the information system of Heaven."

When my children were growing up, my oldest daughter was a voracious reader. We lived for several years about a block's distance from the Town Library. This was convenient for her because she didn't have to walk far to find a new book to read. I recall she would come home with a stack of books a foot high so she would have something to read over the weekend. Yes, she would finish the stack over the weekend and then be looking for something else to read. She was using her library card to access the information available from the Town Library. How much more can we access what is within the realms of Heaven by merely using the resources available to us?

Our "knower" knows things that we did not know we did not know. It drops hints, impressions, nudges to us to avoid this thing or that thing or communicates boldly, "Don't go there!" Some call it intuition, but whatever name you use, learn to cooperate with your "knower." Get to know your "knower." It will help you in your journey of faith.

## Chapter 3 Working with the Books

he Bible speaks of scrolls and books in many places. Often these terms are used interchangeably which I will do here. We typically see these books in the Court of Records or Court of Scribes. Sometimes this court will look like a courtroom, but more commonly it appears as a records room like a clerk's office at the county courthouse.

In one setting we were brought into a room that looked like a clerk's office. Someone who appeared as a short, balding man with a green, capless visor and a black band around his shirt sleeve was busy at table recording records and stamping them for the Judge. We saw what was similar to images you may have seen in an old western movie of a telegraph operator or the bank clerk. The images you see are at times comical.

When I express this comical side, some people take affront because they expect Heaven to be very serious and somber. Not at all! Heaven is a place of great joy and a place where you will see some things that make you smile.

If what you see is in the shape of a book, these books often look like the old books you would find in the Deed Vault of your local county courthouse. If you see something in the form of a scroll that is the form it will take—a scroll with a handle on either end. The contents are rolled up and have to be unrolled a section at a time so as to view the contents. When reading a scroll, you don't see all of it at once. You see what is rolled out in front of you. When looking at a book, you do not see all the pages at once. You only see one or two at a time.

Many times you will see something written or stamped on the outside of the scroll or book. I have seen words on various scrolls or books in that court that said: Cleansed, Healed, Free, Approved, Not Guilty, and more; any variety of words describing the contents of the scroll may be seen. Sometimes the words would say, "Ron's Book," or "Ron's Book of Testimony"—any myriad of things.

At other times they manifest as sheets of paper like the papers you would receive from the Clerk of Court's office at your local courthouse. Sometimes you do not "see," but you "sense" or perceive the paperwork in whatever form it happens to be in.

On one occasion my friend saw her book, but could not read what it said. I suggested she ask for understanding of what was written. As soon as she asked, the letters on the page began to morph into English, and she could then read what was written.

On another occasion, the book opened, but the words were not visible. I suggested they take their finger and "read" as a blind person would read the Braille inscribed on a page. As they used their finger and began to read, they instantly had a download of what they were reading. They knew within their spirit what was written in their book.

These papers include the directives of the court relating to your petition in whatever court you have been in. It may be an order of the court releasing angels to minister to your children, or an order releasing funds for a particular situation, or an order authorizing certain things to be done on your behalf. Any number of things can be in these papers.

On many occasions, many scrolls were issued about a court case. The sense was as if someone loaded his or her arms with a stack of firewood. At times the person could even feel the weight of the scrolls on their arms as they carried them.

On still other occasions, the scrolls were too many to carry, and angelic help had to be provided to gather all the scrolls involved.

Sometimes the contents can be read by you. Other times they are read to you. On many occasions, the contents took the form of a video that began to play in front of the person, and they could "see" the contents of their scroll. At other times, it manifested as a series of snapshots that told a story or gave an instruction.

On one foray into the realms of Heaven, my wife saw a genealogy chart on an ancient parchment. She saw pictures of people she recognized and others she did not "know" in the natural, but intuitively she knew who they were. As she viewed this chart, she saw blank spots with no names or images. These were the times when an ancestor did not make it to Heaven. Seeing this chart was both enlightening and sobering at the same time.

At another time, she stepped into Heaven and saw a beautiful pastoral scene. I asked her if she saw anything that stood out to her. She noted a small cabin off in the distance. I suggested she go toward it. As she took a couple of steps forward in the vision, she was immediately in front of it. She looked above the door and saw the words, "Adina's Library." This looked like a small one-room cabin from the outside. She stepped inside and saw a couple of the kind of desks like you would stand up to use. Often these kind are seen in Deed Vaults in courthouses or in some libraries. Her eyes were drawn to a particular book entitled, "Blessings." She laid the book on the desk and opened it. As she did, she began to read of times in her life where she had chosen to bless someone, either by her actions or by her words. She saw events recorded that had been long forgotten. Seeing these things recorded brought tears to her eyes and great joy to her heart. She continued reading until she felt she had learned what she was supposed to see and closed the book.

As she looked on the shelf where she initially saw the books, she was drawn to another one. In it was a listing of every time she used her talents for the glory of God. These times had been recorded. As a gifted prophetic psalmist and minstrel, she had been acutely aware that to use your abilities for any purpose other than for God's glory would result in wood, hay or stubble—not what she wanted from using her skills.

During this time she looked up from reading and noticed that no longer was she in a small one-room cabin, but she was in a place where it was as if the end wall had been removed and the library went as far as she could see. No longer were two desks in the room, but the desks stretched out for a considerable distance. John, the writer of the Gospel of John, closed his record of Jesus' life and ministry with this statement:

<sup>24</sup> This is the disciple who testifies of these things and wrote these things, and we know that his testimony is true. <sup>25</sup> And there are also many other things that Jesus did, which if they were written one by one, I suppose that even the world itself could not contain the books that would be written. Amen. (John 21:24-25)

Suppose, our deeds are recorded in such a fashion that we have not one book, but many books that record our goings and doings. It would be possible within the realms of Heaven. My wife has seen several books as she has accessed Heaven. All are in keeping with the nature and character of our loving Heavenly Father. We need to explore the realms of Heaven and discover the riches of

our inheritance that Paul alluded to in the letter	to	the
Philippians.		

## Chapter 4 What about the Boxes?

In my home, my wife has decorative boxes for storing items in. When you walk into my living room, you will see a decorative plate on the floor next to an end table. Inches from that is another box. Only inches from that box is another box. These boxes contain small items that won't fit on a shelf easily as a book might. Some include photographs or mementos. In nearly every room of our home are decorative boxes of some form or style. In our closet, you will find more boxes. We have lots of boxes. Some of you can probably relate to my plight. I don't live in a warehouse of boxes, but I can safely say we are amply supplied in decorative boxes. Pray for me!!!

When Katherine saw a box on the shelf with some of her books, I was not really surprised. God has infinite variety and purpose in what He does, so why not with boxes?

Particularly in the Court of Records (or Scribes), I have seen these boxes. Some were like file boxes; others

were storage boxes. In the storage box, Katherine was into, were items including the memory sticks with the videos which she could play.

Whenever I am in the courts,
I understand that I am on a divine
assignment. I am not at a local theme
park merely having a good time.
I don't approach the Courts in
this manner, and I don't recommend
you do so either. Respect the setting,
respect the court, and appreciate
the personnel in the courts.

Any number of things can be seen in these boxes. Some items will remind you of a particular event or time in your life. Even in some cases, the boxes contained a Teddy Bear or doll from the person's childhood. As a parent might keep an item for a keepsake, so the Father does for us. Even our tears are kept by the Father.

#### Your Bottle of Tears

You number my wanderings; put my tears into Your bottle; are they not in Your book? (Psalm 56:8)

The tears you have shed are never forgotten. On one occasion the lady I was assisting in the courts saw an earthen-like small jar. She asked what it was and heard

the response, "It contains your tears." Oh, how that blessed her to know that God had kept them. David lamented:

I am weary with my groaning; all night I make my bed swim; I drench my couch with my tears. (Psalm 6:6)

Job had a similar lament.<sup>2</sup>

To know your tears are not forgotten is a comforting aspect of our Heavenly Father.

common experience when in the Court of Records was to see a box containing files within file folders. In one experience, we were directed to a box containing the folders and then led to a particular folder among all the others. It had the word, "Outstanding" on the label of the folder. As we looked inside it, it contained files of outstanding false verdicts against someone. We were directed to take this file to the Court of Appeals to deal with the false verdicts that were still outstanding against this person.

As we stepped out of the Court of Records, we were greeted by our angelic assistant. The angel then led us down the corridor to another room. It was the Court of Appeals. As we entered, we noticed the court was completely set up, and they were waiting for us to arrive. The man walked up to the Judge and handed him the folder. The Judge perused the folder and occasionally nodded and at other times, frowned. The Judge finally

finished, looked up, and asked what the man wanted the court to do for him.

He replied that he wished the court to overturn every false verdict and replace it with a righteous one, provide assistance for his wife about an issue she was dealing with, and provide financial restitution for losses incurred if that was applicable.

The Judge looked back at the folder and began to write. Periodically he would stamp something and put it in a small stack that was growing as he went through the paperwork. After a short time, he was finished. The Judge then looked up and declared, "Petition granted." Thankful we were for what the Judge had just done for us. We then handed him the Requisition Form we had acquired from the Court of Records. By now it had been filled out according to instructions. After handing it over, the Judge reviewed it, then stamped "Approved" on it and handed it to a bailiff standing nearby, as he had done with the paperwork a few moments before.

Knowing we were finished with our task in that court, we stepped out into the corridor where we were met by our guide and noticed that the passageway seemed filled with angels. Much activity and commotion were occurring in the hallway at that time. The angels seemed to be quite joyful and were expressing that to one another.

At other times the file folders contained lists of things the person was to do. In one situation, it included a listing of property the person was to acquire eventually. Whenever we did not understand what to do, we could just ask, and the angelic assistants would gladly direct us, speak to us, or lead us to the next place. Many times what we need to do is ask, "What do I need to do with this?" Typically you will have an immediate impression instructing you what to do, where to go, or be given information about what you are dealing with.

Similar scenarios have occurred as we have ventured through the Courts of Heaven. In another situation, a man's employment had been hampered, and it was due to formal complaints that had been lodged against him. These had not been lodged against him in the earth but had been filed against him in the Courts of Heaven.

We were shown the file containing these complaints and asked what we were to do with them. We were instructed to treat them as false judgments, take them to the Court of Appeals and request they be overturned and replaced with righteous verdicts in the Courts of Heaven.

Over the next few minutes that is what we did. The wife took the complaints within that folder, presented them to the Judge in the appellate court and requested they be removed so that they would no longer speak against the man.

The Judge took the paperwork, marked it "Void" or canceled, handed it to the bailiff, and we were done in that court.

# Chapter 6 Dealing with Warrants

n this particular day, we engaged the Help Desk and were ushered into a courtroom where we saw the Judge on the bench. He had in his hand a stack of warrants. In this particular case, the warrants were outstanding, not because of the sins of the person involved, but instead, these were warrants that had passed down from his forefathers.

[Several scriptures relate to this matter. David lamented in Psalm 69:4:

Those who hate me without a cause are more than the hairs of my head; they are mighty who would destroy me, being my enemies wrongfully; though I have stolen nothing, I still must restore it. (Emphasis mine)

In Isaiah, we read:

Your first father sinned, and your mediators have transgressed against Me. (Isaiah 43:27)

Although we did not commit the sin, the devil, who is a legalist, considers you a legal heir and seeks to exact payment from you. He is not concerned with the details, just in exacting payment.]

We asked what these were and what they involved and immediately we began to see a series of situations, and words detailing the particular sins of the young man's prior generations. We saw names of deeds such as murder, robbery, violence, lying, anger, grave-robbing, and barbarism. We saw a hangman's noose; we saw a young boy being kidnapped; we saw greed, covetousness, thievery, and jealousy. The words Cain and Abel came before us. We saw pillaging and a large bull; we saw a gypsy with a crystal ball; we saw drunkenness and revelry. All sorts of wickedness was presented before us.

We began to repent for the sins we were seeing before us and asked for the blood of Jesus to be applied to the sins to cleanse the bloodline. As we did, the items, words, and images would just fade away. We heard the phrase "the wolf is at the door," and although puzzled by the exact meaning, I repented on behalf of the young man for not wanting to provide for the family. As soon as I did so, the wolf ran away.

We suddenly saw a young boy sinking in deep water. We repented for cooperating with water spirits, and as we did, the water cleared. Finally, we saw the young boy come up out of the water and sit down on the beach. We requested the cancellation of the warrants and saw every one of them stamped "Canceled."

A clerk was taking care of the warrants for the Judge, and when he had finished, he handed us a piece of paper which he instructed us to take to another court. It contained the orders to obtain a new Title Deed for the young man from the Court of Titles & Deeds. Wherein he had been owned by his past on account of the deeds of his ancestors, he was now owned by Jehovah God.

We accessed the Court of Titles & Deeds with the help of our escort and presented the paper we had been given. A new Title Deed was issued for the young man and recorded for us.

We then accessed the Court of Times & Seasons for a correction of the timing of his life. As we stepped into this court, we were aware that it seemed to be winter as we were stepping in, but suddenly it became spring. The atmosphere changed as the season changed. (Of course, it is a Court of Times & SEASONS!)

Behind the Judge, was a Cuckoo Clock as well as two other clocks. As we made the request, the timing of the clocks moved and adjusted. One had been at 3:00, one at 7:50 and one at 11:55. While we watched, all were reset to 12:00.

We stepped out of the Court of Times & Seasons, and I stepped onto the beach where the little boy was still sitting. I called his name, and he got up and came over and hugged me. Together, the group of us stepped back into the courts complex and into the Court of Records.

The young man was separated from us by an angel and taken to a place where he was able to read his Book of Destiny. He was amazed at what he was seeing. He could be heard to exclaim, "I'm supposed to do that!" You could see his jaw dropping as he read and listened to the angel tell him about his purpose-filled life. His eyes lit up, and his countenance changed. Joy filled his heart, and ours as well as we watched this spectacle unfold for this young man who had felt so isolated and purposeless before this moment. The labels he had carried of abandonment, fear, and loneliness came off. The anvil that he had been carrying around that we had not previously noticed fell off his back. He felt lighter, and he looked more luminous than he had before. He could now freely be the young man God intended him to be.

Warrants had been canceled in his life, and old titles removed. Purpose now filled his heart. Oh, the things we will see from this young man's life in the future.

# Chapter 7 Help from the Help Desk

any times we may be puzzled by what we are seeing or experiencing within the Courts of Heaven. It helps to envision the overall complex of the Courts of Heaven as a large mall with the different courts situated on either side of a vast corridor.

It has been my experience to find the Help Desk located in the center of the complex with wings that go in either direction. The Help Desk is available to provide information as we need it about where to go, what to do, and how to go about the many things that need to be done within the courts.

If I did not know what I was looking at, I could ask, and the assistants were so very gracious to make it plain to me. If I did not know where to go, they would direct me, often escorting me to where I needed to go. Once I arrived, I would step into the court. I always found it handy to look above the doorway before stepping through it to see what the signage above the door

displayed. It would generally tell me which court I was entering.

Once inside, another angel would ask if they could help. We would tell them what we needed to do in that court, and they would direct us. They were always helpful and never rude or discourteous. We often were thanked for accessing the courts as they had been underutilized in the past, but were now experiencing much more activity.

If I was given paperwork and needed help, they would offer direction as to what to do. As you would find in many businesses or large companies on the earth that provide an Information Desk, the Courts of Heaven set the pace in quality and courtesy when it comes to helping those who are still learning how to navigate the Courts of Heaven.

The angelic assistants have never been rude or condescending to any question we ever asked. They often chuckle at some of our issues but are never mean. I teach others that to maximize our experience in the realms of Heaven, we need to become as little children. Jesus admonished his disciples saying:

Assuredly, I say to you, 'whoever does not receive the kingdom of God as a little child will by no means enter it.' (Mark 10:15 also Luke 18:17)

Thus, the more childlike we become, the more we can appreciate what we are experiencing in the realms of Heaven. To be childlike is not the same as being childish. I am not advocating the latter. Yet, what does an eight or

nine-year-old child do when he does not understand what he is seeing or hearing? He or she asks questions—lots of them! I have a nine-year-old grandson; I can assure you that is what he does! No question is too dumb. We have limited experience in these courts, so we need to discover how to function in them. The more you access them, the more you learn.

It has been my experience to use the same assistant in various cases in the courts. As mentioned earlier, they are quite friendly, even chatty at times as they ask how your day is going, etc. They want to make your experience as pleasant and productive as possible.

Some may feel overwhelmed by the grandeur of the courts complex, but again, we do not have to be overcome. If we need help, we only need to ask. Remember the promise of Hebrews 4:16:

Let us, therefore, come boldly to the throne of grace that we may obtain mercy and find grace to help in time of need.

Help is always available. If we don't know which court to access, we just ask for directions. We won't be directed to the wrong place. Remember too, that the Mercy Court is our default court—our "go to" court. Many of the most common matters can be handled in the Mercy Court.

The following chart will help you know where to go. It is not complete and will only cover the most commonly accessed courts.

COURT	ISSUE
Mercy	Accusations, basic petitions
Property	Titles & Deeds
Timing Issues	Times & Seasons
Marital	Court of Matrimony
False verdicts	Court of Appeals
Direction	Court of Records
Ownership	Titles & Deeds

In all the books I've written related to the Courts of Heaven, note that the information must remain fluid because new understanding is forever evolving. I know certain things about some courts that I had no clue of three weeks prior. Also, please understand that I am sharing from my experience and the experiences of others whom I know and value. Your experiences may differ, but the adventure continues. Let us ever learn and ever be willing to go farther in our understanding of the Courts of Heaven prayer paradigm. We've only begun to understand it!






#### **MERCY COURT PROCESS**






#### **COURT OF TITLES & DEEDS PROCESS-OTHERS**




