Chapter 1

Upsetting the Apple Cart

The phone call was totally unexpected. Jean, an intermediary for a troubled young woman (whom we will call Debbie) and Carol, a Christian counselor answered only to hear someone speaking with fury in their voice. They were incredibly angry that Carol had been to the Courts of Heaven and received a Permanent Restraining Order against them. They threatened to come to her home in person to kill her since they could no longer astral project themselves from place to place. They had been grounded.

Just prior to this court work, Debbie's owners declared they owned her and astral projected to her where they repeatedly raped her. They did not want to lose their prized possession.

Debbie's Story

The torment was incredible. For years she had suffered physically and emotionally at the hands of her handlers and owners. She was no more than a piece of property to be used as they deemed fit. If they wanted sex, she delivered. Anything they demanded she was forced to perform. The price that had been paid for her was immense—a half million dollars. Having been abused since conception, she had suffered a lifetime of unimaginable horror.

Many reading this may find it hard to believe that someone had been bought like cattle at an auction, but it is true. Multiplied thousands have been traded like livestock. This trade is a far more serious dilemma than most people realize.

Her situation seemed so surreal, yet, it was true. She had been living this nightmare for years. Now her cry was for freedom. As she disclosed these things to Carol, she realized she had found the right person to talk to—one who could truly help her find freedom. She found hope again.

Carol, who only a few months before had discovered the Courts of Heaven prayer paradigm, opted to engage the Courts of Heaven with a close friend assisting her on behalf of Debbie. Since Debbie was considered “property” of another person, a venture into the Court of Titles and Deeds was the first stop in Debbie's journey to freedom.

They entered this court requesting a Transfer of Title Deed (a transfer of ownership) from the “owner” and the other parties involved) unto Jehovah God. After a few moments, the Transfer of Title was complete; the foray into the Courts of Heaven was not yet over though. They still had a few stops to make.

The next stop was the Court of Records (Scribes) to record the transfer of ownership, and then to the Criminal Court to obtain a Permanent Restraining Order against her owners and a number of other pertinent parties. On the scroll pertaining to the restraining order were the instructions that if they violate this Permanent Restraining Order, they will face chains or bondage, imprisonment, or death. This is serious business. One person had already died in a similar scenario by violating one of these orders.

Upon receiving the Permanent Restraining Order, Carol again accessed the Court of Records (Scribes) to get these items recorded. While in that court Carol was handed fifteen scrolls related to this situation which they delivered to the Court of Angels for immediate dispatch on behalf of Debbie.

It was apparent that the angels had done their job (and we’re continuing to do so) as was evidenced by the phone call they had received. Neither Carol (nor her friend) had told anyone about their visit to the Courts of Heaven, but the demons knew and communicated that information to Debbie’s former owners. Their applecart had been upset. Debbie’s story is not unlike the owners of the young slave-

girl with the spirit of divination recorded in the book of Acts.¹ They could no longer benefit as they had from Debbie.

The final act Carol and her friend took was to receive Communion as a means of sealing what had been done for Debbie. In the intervening time, however, Debbie had been tormented. No more torment occurred after receiving Communion. Oh, the power of the blood and body of Jesus.

In the following days attempts were made by her owners to keep her entrapped, but Carol returned to the Courts of Heaven and obtained a Writ of Assistance to enjoin the angels in formally working to bring Debbie into a full measure of freedom. How many more Debbie's are in the earth in similar straits?

Who is the Legitimate Owner?

Satan loves to assume things are to his way of thinking whether they are or not. The ownership of Planet Earth is clearly established in Psalm 24, but he seemed to fail to get the memo.

The earth is the LORD's, and all its fullness, the world and those who dwell therein. (Psalm 24:1) (ASV)

¹ Acts 16:16-19

Many other scriptures attest to the same theme:

Behold, to the LORD your God belong heaven and the highest heavens, the earth and all that is in it. (Deuteronomy 10:14) (ASV)

The heavens are Yours; the earth also is Yours; the world and all it contains, You have founded them. (Psalm 89:11) (ASV)

He blessed him and said, "Blessed be Abram of God Most High, possessor of heaven and earth." (Genesis 14:19) (ASV)

Now then, if you will indeed obey My voice and keep My covenant, then you shall be My own possession among all the peoples, for all the earth is Mine; (Exodus 19:5) (ASV)

For the earth is the Lord's, and all it contains. (1 Corinthians 10:26) (ASV)

Whatever is under the whole heaven is mine. (Job 41:11) (ASV)

¹⁰ *For every beast of the forest is mine, the cattle on a thousand hills. ¹¹ I know every bird of the mountains, and everything that moves in the field is mine. ¹² For the world is mine, and all it contains. (Psalm 50:10-12) (ASV)*

"The silver is mine, and the gold is mine," declares the LORD of hosts. (Haggai 2:8) (ASV)

The Lord God is the rightful owner. It was never surrendered at any time. We are ALL His possession. He has first claim to all of us. Anyone else has only a secondary claim. The enemy and people have laid claim and created false title deeds or liens which must be canceled or satisfied.

If you recall the story when Jesus was in the wilderness and being tempted by the devil; Satan makes a proposition to Jesus when he says,

⁸ Next, the devil took him to the peak of a very high mountain and showed him all the kingdoms of the world and their glory. ⁹ “I will give it all to you,” he said, “if you will kneel down and worship me.” ¹⁰ “Get out of here, Satan,” Jesus told him. “For the Scriptures say, ‘You must worship the LORD your God and serve only him.’” (Matthew 4:8-10)

Satan had laid claim to the kingdoms of the world. He essentially placed a lien on it because of the permission granted by Adam and Eve due to their disobedience. They had been assigned as stewards of the garden and failed in their duty, thus surrendering their rights to it. The fact that Jesus did not dispute with Satan in the wilderness about who owned the kingdoms of the world does not mean that what Satan said was necessarily true. What was not addressed was the fact that the ownership of the planet and all who dwell upon are the property of the Lord (see the scriptures cited heretofore). By our disobedience, we can give ourselves over to Satan to do his pleasure, just

as we can surrender our lives to God and do his pleasure instead.

Paul pointed out that we have the Holy Spirit who is the guarantee (or down payment) for us:

¹³ In Him you also trusted, after you heard the word of truth, the gospel of your salvation; in whom also, having believed, you were sealed with the Holy Spirit of promise, ¹⁴ who is the guarantee of our inheritance until the redemption of the purchased possession, to the praise of His glory. (Ephesians 1:13-14)

False Title Deeds

When a piece of property is purchased, a Title Deed is issued to the rightful owner. In the event you borrowed money to buy the property, the Title Deed will now involve a lienholder meaning that regardless of any claims that may arise concerning that property they will be taken care of first. You cannot sell the property to another person and deliver a clean title to the buy without having first, paid any outstanding debt to the lienholder. Once they are paid, a document called “Satisfaction of Lien” is filed stating that they are no longer a lienholder and have the obligations have been satisfied by the owner of the property. The owner then has clear title to the property and can deliver a clean title to the prospective buyer.

Many situations may have caused false titles to be created concerning our lives. The devil does not mind

issuing false verdicts, so why should he mind developing a false title—a counterfeit title and presume ownership of something or someone.

We have all seen situations where the jilted boyfriend or husband, claims ownership of the girlfriend or wife and says, “If I cannot have you, no one can have you.” They have asserted ownership unlawfully. A wife is not “property”...a wife is a helpmate, a partner to help you fulfill the purposes of God. Guys, that girlfriend is NOT your property. She belongs to the Lord. Girls, that boyfriend is NOT *your* property. He also belongs to the Lord. If these types of situations do not cause false titles to be created by Hell, they at least create liens against the person.

Liens

Liens are claims against a particular property. In the American legal system, when you purchase a particular property, and you pay for it in full not having gotten a loan using the property as collateral, you are given a clear or clean title.

However, if you got a loan to purchase the property that property became the security for the loan. The lender becomes a lien holder. Whether it was land, a house, a vehicle, or any myriad of other items considered real property, the same situation applies. In order to obtain a clear or clean title, the liens must be satisfied. If you borrowed money to purchase the property, then the

money must be repaid (with interest usually) in order for the lienholder to be released from the title.

If you purchased a house having received a loan from the bank, and were able to pay off the loan and proof is provided to the court that you had satisfied the terms of the lien, the courts would then issue a document usually called a Satisfaction of Lien in your behalf releasing your property from that lien. Once the obligations of the lien are met, and it is satisfied, the lienholder no longer has any claim to your property.

Certain things we do can create a situation where a lien is placed upon us where we no longer have a completely free title to do with as we please. Every sin has a consequence and requires a payment in order for that consequence to be released. The blood of Jesus was the price paid for our sins; however, that blood must be applied to that sin in order for the payment to be enacted and the lien to be satisfied.

For even the Son of Man came not to be served but to serve others and to give his life as a ransom for many. (Matthew 20:28) (Italics mine)

A ransom is a price paid to redeem or repurchase something or someone. Our sins created the need for a ransom to be paid to free us from the bondage created. Jesus Christ, via the shedding of his blood, paid the ultimate price so that I could be free from the unpayable price of sin.

Our sin had essentially sold us into servitude. God saw that and sent a remedy:

¹⁹ Don't you realize that your body is the temple of the Holy Spirit, who lives in you and was given to you by God? You do not belong to yourself, ²⁰ for God bought you with a high price. So you must honor God with your body. (1 Corinthians 6:19-20)

As a believer, God is your rightful owner. The devil, however, wants to assert ownership rights in our lives, and often we give him permission to do so. Usually, we do not mean to, but our actions or words create just such a scenario.

The Story of Naboth's Vineyard

In 1 Kings 21:1-16 we have the story of Ahab and Jezebel and their illegal seizure of Naboth's vineyard. The entire story is important, so it follows:

¹ And it came to pass after these things that Naboth the Jezreelite had a vineyard which was in Jezreel, next to the palace of Ahab king of Samaria. ² So Ahab spoke to Naboth, saying, "Give me your vineyard that I may have it for a vegetable garden, because it is near, next to my house; and for it I will give you a vineyard better than it. Or, if it seems good to you, I will give you its worth in money." ³ But Naboth said to Ahab, "The LORD forbid that I should give the inheritance of my fathers to you!"

⁴ So Ahab went into his house sullen and displeased because of the word which Naboth the Jezreelite had spoken to him; for he had said, "I will not give you the inheritance of my fathers." And he lay down on his bed, and turned away his face, and would eat no food.

⁵ But Jezebel his wife came to him, and said to him, "Why is your spirit so sullen that you eat no food?"

⁶ He said to her, "Because I spoke to Naboth the Jezreelite, and said to him, 'Give me your vineyard for money; or else, if it pleases you, I will give you another vineyard for it.' And he answered, 'I will not give you my vineyard.'"

⁷ Then, Jezebel, his wife said to him, "You now exercise authority over Israel! Arise, eat food, and let your heart be cheerful; I will give you the vineyard of Naboth the Jezreelite."⁸ And she wrote letters in Ahab's name, sealed them with his seal, and sent the letters to the elders and the nobles who were dwelling in the city with Naboth.⁹ She wrote in the letters, saying, Proclaim a fast, and seat Naboth with high honor among the people;¹⁰ and seat two men, scoundrels, before him to bear witness against him, saying, You have blasphemed God and the king. Then take him out, and stone him, that he may die.

¹¹ So the men of his city, the elders, and nobles who were inhabitants of his city did as Jezebel had sent to them, as it was written in the letters which she had sent to them.¹² They proclaimed a fast and

seated Naboth with high honor among the people.¹³ And two men, scoundrels, came in and sat before him; and the scoundrels witnessed against him, against Naboth, in the presence of the people, saying, "Naboth has blasphemed God and the king!" Then they took him outside the city and stoned him with stones so that he died.¹⁴ Then they sent to Jezebel, saying, "Naboth has been stoned and is dead."¹⁵ And it came to pass when Jezebel heard that Naboth had been stoned and was dead, that Jezebel said to Ahab, "Arise, take possession of the vineyard of Naboth the Jezreelite, which he refused to give you for money; for Naboth is not alive, but dead."¹⁶ So it was when Ahab heard that Naboth was dead, that Ahab got up and went down to take possession of the vineyard of Naboth the Jezreelite.

In verse 7 Jezebel implies to Ahab that he essentially "owned" Israel and as far as she was concerned Israel and anything in it was his property and he had a right to it. This was a false belief on Jezebel's part but a shared conviction of one from a privileged background as she was. It was this conviction that drove her to conspire against Naboth.

First, she wrote letters in Ahab's name (she forged his signature); in the letter, she instructed the city elders and nobles in Naboth's home town to arrange a gathering where Naboth was to be the "special guest." Finally, she instructed them to arrange for two false witnesses to come and give false testimony against Naboth. They would no

doubt be willing to do this as Naboth represented all they resented as sons of Belial (SOBs)—those dedicated to darkness whose aim was to spread corruption and create the downfall of the nation.

The celebration turned into a Court of Hell for Naboth as these elders and nobles followed the instructions of Queen Jezebel. Courts of Hell do not convene only in Hell. These elders were the judges of their city along with the nobles and were responsible to rightly judge in behalf of the people. Their fear of not obeying the queen induced them to conspire against Naboth resulting in his death by stoning. Jezebel then finalized the deed by confiscating Naboth's property—land that was rightfully his heirs—and gave it to Ahab.

This series of events was the final straw in the downfall of Ahab as Elijah was sent to him to confront him. The kingdom would be ripped from him in a very violent manner. This occurred not long after.

Throughout the Word of God, we can find three particular things that cry out for justice: innocent bloodshed, land that has been illegally seized, and wages that have been defrauded. In this story, we have an example of all three crying out at the same time. Naboth's innocent blood shed, the confiscated property, and the defrauding of money to Naboth's heirs by the confiscation of their vineyard (their livelihood) and the loss of wages that would have resulted from Jezebel's wicked act. Naboth's property also represented his inheritance. He could not sell it or get rid of it in any fashion. It had been

distributed to him from his ancestors, and his duty was to share it with his seed when the time came. The cry for justice from the innocent bloodshed, the land, and the wages was intense. It got the attention of the Just Judge, and he responded by sending Elijah to notify Ahab of the judgment is coming. Each of these items possesses its own judgment or consequence. Ahab had invited them all by allowing Jezebel to act wickedly against an innocent man.

This false title that Ahab now possessed to Naboth's land was an assertion of ownership from its rightful owner. We have the option of getting these false ownership claims rectified in the Courts of Heaven in the Court of Titles and Deeds. Let's continue learning about this.

Chapter 2

Emotional Liens

Often we can allow deep emotions to place liens upon our life. Loneliness, depression, despair, hopelessness, grief, et.al. These emotions can try to own us. They dictate how we feel, what we do, how we respond to people. They can run our lives.

As we inquired of the Lord concerning what liens or false titles were working against us (or whomever we were working in behalf of), we were sometimes surprised at the responses. In one case a young lady was trapped by a lien of loneliness upon her life. We forgave her for embracing the lies the enemy was using against her, blessed her, and released her. As we did freedom came; a sense of peace settled upon us as Holy Spirit witnessed the satisfaction of the lien.

[We will outline the typical procedure we use to bring people to freedom in this court in a later chapter.]

When you consider the ways that grief or worry can impact a person's life it is apparent that it wants to take

over their life. This becomes false ownership or a lien against them that must be satisfied in order to be released. For people having recently experienced a significant loss of a loved one a certain amount of grief is entirely natural, but when it paralyzes that person, and they are still consumed by the loss many months later, it is more than just the normal amount of grief. The lien needs to be satisfied or, if they have given themselves over to grief, they must experience a transfer of title back to the Lord Jehovah.

Stages of False Ownership

It seems that the false ownership scenario is created in stages:

- 1) The event occurs, and normal grief ensues.
- 2) When it is prolonged grief lasting many months or even years and although they may not have surrendered to it, still feel entrapped by it, a lien has been created. The person needs to be forgiven for embracing the grief to this degree, blessed, and released from it, thus satisfying the demands of the lien.
- 3) When they give themselves wholly over to the grief, a false title has been created and a fraudulent transfer of ownership has occurred. This needs to be undone in the Courts of Heaven. We do this by requesting voiding of the counterfeit title and

requesting a Transfer of Title proffering the person to the correct owner—the Lord Jehovah.

Now, whether it is grief or some other emotion, the stages seem to be similar. The degree of surrender to the emotion seems to dictate whether we are looking at a lien or false title. These false titles are essentially false judgments, but since we are operating in the Court of Titles and Deeds, we will get them dealt with in this court.

In one scenario a person had a great sense of longing to see her children and grandchildren. She was unable to remedy the situation from a natural standpoint, so the longing had created a demand upon her soul in the form of a lien. She repented for embracing the lies involved, sought and received forgiveness and the lien was satisfied. The blood of Jesus is always our highest answer to any lien or false title.

A principle we need to understand is this:

*What we focus on
becomes central to our life.*

*What is central to our life
will dictate our future.*

Whether it is the loss of a loved one, homesickness, a longing to be married (if you are single), depression; you name the emotion—if you focus on it long enough, it will consume you. Another way of saying it follows:

*What you feed will live &
what you starve will die.*

What are we feeding? What are we starving? That principle applies to many areas of our lives.

*A major purpose for the Court of Titles
and Deeds is to get proper ownership
issues settled.*

Chapter 3

Ties That Bind

Married couples around the globe have endured dysfunctional relationships without ever knowing the apparent root cause. In one scenario a woman had been married for forty years. As we inquired about outstanding liens or false titles, she immediately had a vision of her mother's hand reaching into her heart. The mother (though long dead) had never released her daughter to be a wife to her husband. She had not approved of the daughter's choice and for whatever reason held onto her daughter's heart for all those years. Once we were able to identify this issue and deal with it in the Court of Titles and Deeds incredible freedom came. This hold upon her heart was now broken, and she was free to be her husband's wife. How many women have suffered the same type of thing? Freedom, however, is simple to obtain in the Courts of Heaven!

While dealing with this same family, we began working on behalf of the husband. When we inquired as before about outstanding liens or false titles, again a vision

was given showing the hands of all his siblings holding on to his heart. This would indicate that the man's family had a continual hold upon his heart interfering with his ability to truly be a husband to his wife. We are familiar with the passage where Jesus points out:

⁴ And He answered and said to them, "Have you not read that He who made them at the beginning 'Made them male and female,' ⁵ and said, 'For this reason a man shall leave his father and mother and be joined to his wife, and the two shall become one flesh,'? ⁶ So then, they are no longer two but one flesh. Therefore what God has joined together, let not man separate." (Matthew 19:4-6)

Again, how many couples have never been released from family ties that keep them from having a fulfilling marriage? Whether you agree with their choice of a mate or not, is not necessarily your business. You have a responsibility to not hold on to those God said to release.

Soul Ties

Soul ties can create liens or false titles that must be released. When emotionally you give yourself to another person you create a soul tie that can have wonderful consequences in your life or may result in very negative consequences. When negative consequences are the result, freedom must be sought and obtained. Again, you will from this court, repent, seek forgiveness for invoking the soul tie in an ungodly manner and gain forgiveness

allowing the lien to be satisfied or the false title eliminated.

I Love You with All My Heart

Although this is a lovely sentiment it can, in the wrong setting be set up against a person's life. They have created an allegiance and giving of ownership over to another that may not be the person God has intended for them to give their heart to. Upon a breakup, in the relationship, the depth of the emotional trauma inflicted will likely become apparent. Again, repentance is required for giving your heart to the wrong person, seek and obtain forgiveness, forgive the other party for anything they may have done that is sin in this matter and bless and release them.

You're Mine

This declaration may be subconsciously saying, "You're my possession. I own you," or "she's mine, and no one else can have her." If that is the underlying intent—to create an ownership scenario, particularly if they say, "you'll always be mine." then a lien or false title is likely to be involved. This is particularly true if the declaration is coming from a narcissistic individual or one who is controlling. Some control in a passive-aggressive manner, but regardless of how it is demonstrated, control is still control.

A recent illustration came very close to home and made the national news. The lady who cut our hair for several years experienced a tremendous tragedy. Her pregnant daughter was murdered (along with their two small children). The wife had just told her husband that she wanted to separate from him. He was not willing to positively deal with that scenario, and the end result was the murder of four lives (she was also pregnant at the time of the murder). If he could not have her, then neither could anyone else.

Broken Engagements

When an engagement is broken off invariably, soul ties are in play, but possibly something a little further. In Jewish culture, engagement was a much deeper relationship than what we have in our culture. However, Satan does not want to argue over the details; he wants to usurp false ownership of the parties involved.

In paternalistic societies, this would likely be his claim that the former bride-to-be was the property of the man and therefore a false title is involved and a Transfer of Title is needed to free her from those legal restraints. In maternal societies where the man would take on the woman's identity, the reverse may occur. Transfer of Title (ownership) is required to execute freedom for them.

Parental Demands

In cases where the parents have demanded the child marry a particular person liens or false titles may also be involved. These demands of ownership may also be coming from the other party's parents or grandparents. Parents are often guilty of living their life through their children, and marriage is one of the avenues that this occurs. Simply inquire in the court as to the existence of outstanding liens or false titles and follow the procedure for freedom.

Many years ago I heard the story of a family whose children never married. When the father was on his deathbed, he made each child promise never to marry, but stay single and take care of their mother. This demand created a false title on each of these children. It is doubtful that it was the perfect will of God for each of these children to never marry. As a result of this misguided demand, destinies were altered, and children that should have been born were never able to be conceived. Parents, be careful what you demand.

Consequences of Intercourse

When sexual intercourse is involved, it deepens the issue. You have given yourself wholly to another and if they are not your mate, or are no longer your mate, then that soul tie, the false title needs to be removed from your life. If you were involved in sexual intercourse or illicit sexual activity outside of the bonds of male to female

marriage, then you have created the scenario whereby you are dealing with liens and or false titles. The behavior must be repented of, and forgiveness sought and gained. Also, forgive the other party(ies), bless them, and release them. Remember too, that when it comes to sexual sin is involved, in order to come clean; you must confess it to another living human being.² You are likely to have multiple liens or false titles in the event of sexual immorality. Deal with these as thoroughly as possible within the Court of Titles & Deeds.

Paul, the apostle, expands on this in the first letter to the Corinthians. Corinth was a crossroads city. It was a center for commerce from every direction. Not only did various goods pass through the city, but also every kind of wickedness. Although the believers had been redeemed from all these wicked deeds, they were being tempted to return. Paul firmly lays out the consequences for those participating in these unrighteous acts:

⁹ Do you not know that the unrighteous will not inherit the kingdom of God? Do not be deceived. Neither fornicators, nor idolaters, nor adulterers, nor homosexuals, nor sodomites, ¹⁰ nor thieves, nor covetous, nor drunkards, nor revilers, nor extortioners will inherit the kingdom of God. ¹¹ And such were some of you. But you were washed, but you were sanctified, but you were justified in the

² Confess your trespasses to one another, and pray for one another, that you may be healed. The effective, fervent prayer of a righteous man avails much. (James 5:16)

name of the Lord Jesus and by the Spirit of our God.

¹² All things are lawful for me, but all things are not helpful. All things are lawful for me, but I will not be brought under the power of any. ¹³ Foods for the stomach and the stomach for foods, but God will destroy both it and them. Now the body is not for sexual immorality but for the Lord, and the Lord for the body. (1 Corinthians 6:9-13)

By their surrender to these lifestyles, the enemy was laying claim to them—body, soul, and spirit. They had experienced a Transfer of Title, but not in a good way. Only through repentance could they be brought back and inherit the kingdom of God which had been their original aim. They needed a Transfer of Title back to Jehovah and cancellation of every lien against them. They can find this in the Court of Titles and Deeds.

Chapter 4

Bondage of a Religious Flavor

People the world over have seen the excesses of some spiritual leaders over their flocks. Rather than feeding their flocks they are devouring them by their behavior and creating false ownership scenarios whereby the people are enslaved to what should be a godly thing but is not.

The last place we should be susceptible to evil agendas and actions should be within the church, but just as the Jewish people throughout history, they have suffered at the hands of unrighteous leaders. They have contended with the ultra-religious Pharisees, Sadducees, and Scribes. Unfortunately, it is not different today. We have leaders acting as if they are themselves, God. They have their reward here. They will have none in Heaven supposing they get to Heaven.

Jesus warned us of the leaven of the Pharisees. Though we may not officially have Pharisees, we still do in many arenas unofficially. They create all kinds of hoops for us to

jump through in order to please God. They want us to buy their latest teaching series and support their latest project or pay for a good prophetic word. We have criticized certain politicians for their “pay to play” schemes, but we are as guilty as they. We give preferred seats to the strongest givers and premium prophetic words to our greatest supporters. As James tells us in James 2, to show partiality in that way is a sin.

We create victims within the church. We induce them to make covenants, vows, and oaths to us and to prove their undying allegiance by their faithful giving. Then they may lay hands on us and impart something to us—however, what is imparted may be something we do not really need. The allegiances (when out of balance) create liens and false titles that must be removed from our lives and families.

Laying Claim to the Flock

Some pastors lay claim to the flock under their care and refer to them as “their” flock. Some mean much more than as an identifier. Some attempt to take ownership. If you have been under this kind of leader, I expect you will find in your inquiry in the Court of Titles and Deeds that you do indeed, have an outstanding lien or false title with which you need to deal and get released from.

*Unhealthy leaders
create unhealthy followers.*

Allegiance to the Man of God

Some leaders have even demanded that their parishioners lay on the ground so their feet would not have to touch “unholy” ground. Such demands are sickening and totally out of context with the whole of scripture. Others want you to always depend upon “their” anointing to get your miracle. Others want you to hang on to every word they speak. These bondages are not freeing in any measure.

*The demanded use of titles is a flag of
an unhealthy environment.*

If you are involved with a church that demands that you refer to the leader by a title such as pastor, apostle, or bishop (or whatever title is demanded) they are creating a false ownership system. The key word is demanded. To call someone by a title should be an act of courtesy and respect, and not done out of fear. The leader should be understood that he may not be treated on the same level as your good friend and fishing buddy Bubba, but if the structure unequivocally demands that titles be used in every instance—run!

Jesus gave us a guideline in Matthew 23:8:

*But you, do not be called “Rabbi”; for one is your
Teacher, the Christ, and you are all brethren.*

Prophetic Bondages

Uttered prophetic words with the intent to lay claim on a person or their anointing is problematic. Many lives have been taken off course due to the false hopes these false words invoked in their lives. The ensuing liens or false titles need to be released so the recipient can live free from those false words.

Faulty Church Structures

Some church structures apart from the leader create false ownership structures. If you are involved with a church such as this, do a checkup on yourself to see if any outstanding liens or false titles have been created against your life. If so, you need to reconsider your involvement with that ministry.

*Unhealthy churches can never produce
healthy parishioners.*

Chapter 5

Medical Diagnoses

How many people become owned by a doctor's diagnosis of a person's condition? When the prognosis is "terminal" it immediately seeks to "own" that person's life. If we are talking about "The Big C" it certainly wants to take over your life. It comes complete with a package of fear, dread, and a host of other carpetbaggers. The expectation of chemo and radiation are enough to make the strongest heart among us struggle to stay strong.

It is crucial that these ownership situations be recognized so we can step over into freedom and remove our names from the list of those owned by "The Big C" and back to the list of those belonging wholly to the Lord.

Any "incurable" or chronic disease or condition will seek to own the patient. Whether they embrace that false ownership or not is their decision, yet to embrace the ownership of a condition is to also embrace the consequences of it. An arena to explore is how liens and

false titles may be impacting our ability to receive healing and restoration.

Casualty Covenants

We are often tricked into embracing false ownership. One such way is through casualty covenants. Holy Spirit explained it to me this way:

Suppose you were hearing someone testify of how God healed them of some disease and in the midst of his or her testimony, they are sharing what their symptoms were. As we nod in understanding hearing this wonderful testimony we may find ourselves thinking, “That sounds like what I have,” or, “I’ve had those symptoms too!” In so doing we may come to an agreement that what we are hearing is what we have experienced the symptoms of. We have allowed a lien or false title to be enacted in our life and may find ourselves being diagnosed with the same disease the person testified of being healed from. It is very subtle, but also very effective on the part of the enemy.

If we have come into a casualty covenant like this, we need to repent and request a Satisfaction of the Lien or a Transfer of Title back to the Lord Jehovah Raphe—the Lord, our healer.

A casualty covenant was in play within my relatives a few years ago. A great uncle by marriage died on a specific date in September one year. Not long afterward his son announced to his family that he felt he would die about that time of the year. He was all too correct in his

prediction. Just a couple of years later he died almost to the day his father died on.

It continues. His mother, my great aunt, declared she would die on the same day too! And just a few short years later she died on the same date her husband had died on. I have seen the tombstone testifying to the casualty covenants the son, and his mother had made. Once they made that covenant they, in essence, surrendered title to their lives over to a spirit of death and he carried out their wishes.

Be aware of the power of casualty covenants to enact liens or false titles in our lives and in the lives of those we love.

Chapter 6

Modern Day Slavery

The uptick in kidnappings of children and young people over the last couple of years is alarming. It has been revealed that very high-level witches and Satanists are committed to a minimum of one human sacrifice every hour of EVERY day. That is 24 lives sacrificed daily to create blood trades so that those offering the sacrifices can increase their devilish power.

One per hour is 168 per week, over 700 per month and over 8,700 lives sacrificed per year. This is reaching epidemic proportions. Some are kidnapped for purposes of human sacrifices, while others are kidnapped to become sex slaves. Gender is not the issue. Recent efforts have come to the forefront in trying to make pedophilia “normal” behavior. It is being referred to as someone who “prefers younger persons.” These are your babies we are talking about, your grandchildren, your next door neighbor’s child. Not only has a claim been made in the natural, but one has also been made in the realm of the spirit.

Globally it is estimated that more than 4.5 million people are victims of sex-trafficking. In the United States, it has a major economic impact as an underground economy with an estimated \$39 million impact in Denver, Colorado, but an astounding \$290 million impact in Atlanta, Georgia.

The church has been asleep at the switch with this issue but is now beginning to awaken. The strategies in this book will be important tools to gain victims of sex-trafficking their freedom. As our foes are first supernatural in nature, we must address that arena first. As we do, our impact and efforts can spill over to bring about needed changes in the natural arena. Remember the story of Debbie at the beginning of this book. As the false ownership issue was dealt with in the courts, freedom could begin to be realized in the natural arena. So it will be with many of these future delivered captives as these false claims of ownership are rescinded in the Courts of Heaven by the Just Judge.

Freeing Nations and People Groups

Entire tribal peoples the world over are under false claims of ownership hindering their forward progress for them as a people and affecting their contributions to the world. Over the last two years, I have spent several weeks in the Indian state of Nagaland. The Nagas are a beautiful people with wonderful contributions to make to the nations of men. They are particularly a very musical

people, and wonderful sounds are coming forth from the hills and valleys of Nagaland.

At the end of World War II, the British relinquished control of India and Nagaland which had been its own land. They had been promised by the British that they would be allowed to formulate their own nation separate from any other. In the larger scheme of things, the British reneged on their promise of independence and forced them to become a part of the newly formed independent nation of India. This was in spite of the invaluable assistance rendered by the Nagas toward the British during World War II. It was in Kohima, the capital of Nagaland that one of the most decisive battles of World War II was fought. The Japanese needed the resources of India in order to survive and advanced toward India from Southeast Asia through Nagaland. The battleground was Kohima and the Nagas, before, during, and after the battle provided tremendous amounts of assistance to the British and Indians in reconnaissance of the Japanese, guiding the British and Indian armies through the dense jungles, and providing labor and food to help in the effort to defeat the Japanese.

This decision on the part of Britain had dire consequences for the Nagas. It was very short-sighted on the part of the British. The Nagas facial features are entirely unlike the balance of the Indian population. Nagas have oriental features as opposed to the very European facial structure of the majority of Indians. The British culture taught the Indians how to behave as a superior people group. When the British were in control

of India, they were the superior people, and everyone else was subservient to them. With the British out of the way, the Indians took on that attitude and thus behaved toward the Nagas the way the British had formerly behaved with them. Deep racial divides were created between the Indians and Nagas.

Additionally, Hindu culture teaches that any tribal person is less than a dog. The Nagas were a tribal people, so this belief gave permission to the Indians (and in particular to the occupying Indian Army) to do with the Nagas as they desired. The next sixty years were spent in a civil war between India and Nagaland with the Indian Army going to great lengths to destroy the Nagas. History records the mass destruction of tribes and villages, and gang rapes of the Naga women by entire troops of Indian Army soldiers. Thousands of lives were lost as a result. Only in recent years have the Nagas and Indians come to a cease-fire.

Oppressive dictators often declare their ownership of the people of their nation. We see that in North Korea, China, Cuba, and many other countries. Where ever you have an oppressive dictator, you have false titles in play. We need to begin effective courtroom work on behalf of the people of these nations.

Racism

In America, racism has been rearing its ugly head and causing much strife and division. It is recognized that

throughout history whites have done horrific things to other races. Depending upon where you start, the same can be said about the dominant race on that continent. In the subcontinent of India, as just mentioned, the Indians have oppressed the Nagas. In South Africa, the blacks are oppressing the whites. In their history, the whites oppressed the blacks during apartheid. However, two wrongs never make a right. Is it possible that false claims of ownership are at work creating and maintaining these divides? I believe the answer is yes. We need to deal with these false titles and liens and get rightful ownership restored. In no culture are the whites to own the blacks, or the blacks to own the whites, the Indians to own the Orientals among them, and so on.

The earth is the Lord's and the fullness thereof; the people and all they that dwell therein. (Psalm 24:1)

Let us work to restore the peoples of the earth to their rightful owner—the Lord God Jehovah.

Chapter 7

The Court of Titles and Deeds

Author's Note: This chapter is also in my book, Engaging the Courts of Heaven. It will tell the story of our introduction to this particular court. Enjoy!

Do you have a property situation that needs to be dealt with in this court? Do you have land that will not sell? Do you know of a property that seems cursed? Do you know of an area where nothing seems to be successful on that particular site? Are you considering buying a piece of property? Do you know of someone who seems to be “owned” by the devil or one of his kids?

Should you consider going to the Court of Titles and Deeds to know the status of any property you are considering? What needs to be dealt with before buying? Will it be a good investment? Should I go forward, or not?

Having been going to the Courts of Heaven for about four years, I was familiar with the Mercy Court. Within my heart, I knew the Courts of Heaven contained so much more to see and experience. When a friend asked me about going to the Courts of Heaven to petition about two properties she owned, I agreed to assist her. Although I was not sure how to handle properties, I trusted the Judge and Seven Spirits of God to lead us both. About a month later I traveled to her home where we stepped into the Courts of Heaven. At that time we gave the Just Judge her petitions.

The court opened in the usual way of asking everyone to be present and the blood to speak a word. After only a few minutes I noticed something was different about this court. Its walls were different. Small drawers lined the walls very much like deposit boxes in a bank. As I asked the Judge where we were, he said, “The Court of Titles and Deeds.” I did not know such a place existed, but okay; I loved new things and treasures in Heaven.

It was then I proceeded to ask for more revelation. Two angels guarded each drawer. We brought one of the two properties to the attention of the Judge. As we gave the address, an angel went to a specific drawer and pulled out a rolled paper and took it to the Judge. A funny thing

happened. As the Judge unrolled the scroll, the land depicted on the paper became alive. It was like watching a movie. It played out every day on that land from the beginning as if in fast forward. We watched as people and special events had held on that property. We heard and saw the sights and sounds of rejoicing and celebrations. It was beautiful. Flowers were everywhere. We watched for a long while and then asked for more revelation.

As soon as we asked for more revelation, everything changed. The land became dark, and many men appeared shackled in chains singing an old hymn. I wondered what had happened. We had asked for revelation about anything holding the land captive. We could tell by the clothes and chains it was definitely during the slave trading era of the United States. As we continued to watch the vision, some were being beaten and sold into slavery. Most, if not all, had suffered mistreatment and now did not know their fate. Many were suffering from malnutrition and were weak from the long journey. We could feel the anguish and heartbreak of these people. We could also sense the unrighteous deeds that were done on that property. My friend began to repent on behalf of the landowner for allowing such tragedies to happen on that property. It seemed, they would bring the slaves from the ships and sell them at that place. We then felt impressed to ask the Judge for the release of every slave that had been chained. We also requested they be released from the hatred and unforgiveness in their hearts due to such treatment. We then repented for their families allowing the hate to go on down into future generations. Soon after

that we heard and saw the chains falling off the prisoners; they were free! It was amazing to observe, and we were very much feeling their freedom in ourselves.

As we asked for more revelation, we began to see that the land was alive and beautiful again. All the slaves were gone, and it appeared as a pretty sunny meadow. The families from the former place in time had been set free. The land was set free. As we watched, the Judge rolled up the paper and stamped it, "Approved." Then he had the angel return the document to the proper drawer for safe keeping. My friend knew in her heart that now the land was hers and she could do with it as the Lord deemed for her family.

A few months later; we decided to take the second piece of property into the courts. As we entered the Courtroom, we could tell that we were once again in Court of Title and Deeds. The small drawers were everywhere, so we proceeded to usher everyone in and ask for the Judge to open the Court. We gave an angel the address of the property. Again an angel went to a drawer, brought out a rolled up paper, and presented it to the Judge. We asked for revelation for this property because it was in a different state. Soon after the document was rolled out on the table, the land came to life again. It showed the history of the property and a movie began to play very much like in the prior court setting. Everyone in the Courtroom watched the celebrations, weddings, babies being born, and the lifetime of this property.

We asked for the Seven Spirits of God to guide us and lead us to the curses that might be here as well. I learned that because someone gives you property it is not yours until the Just Judge says it is. We then asked what was holding it. I began to see a woman burying gold coins into the ground in several places and wondered what that meant. Was she trying to save money for her family? A lot of people would hide their fortunes in the ground rather than putting them in a bank. After asking the question, I sensed “no.” This was something else. I then saw my friend and her grandson going around the property digging up coins. I told her what I was seeing, and I asked my friend what she thought that meant? Had she or her family buried money or gold coins anywhere on the land? She said no.

As we continued, we felt that the coins being placed in the ground were not right. They would indeed begin to look for them in the natural. I then had a brief picture of my friend receiving the answer about what all this meant. We asked the Judge and felt like that was all for now about this property. We then saw a picture of her daughter running all over the property with stakes very much like the movie *Far and Away*. She was claiming all the land for their family. It was so exciting! Even though we didn’t understand about the coins, we felt the property would be released for my friend. We asked for a continuance and left the courtroom.

Two weeks later my friend received an email from her sister-in-law. The sister-in-law disclosed she had met with a medium who told her to place coins on the land, in the

ground. Once she did that the property would sell. My friend was shocked. A medium had cursed the area, and her sister-in-law had agreed to it. Her sister-in-law would not tell her where the coins were buried. So my friend asked for revelation about where the coins were. She knew now that what we saw in court was correct and the coins were linked to darkness and curses.

The woman went everywhere on the property with a metal detector. They only found some pennies but felt such a relief to know that the Judge was breaking that agreement by revealing this to her. After removing the coins, they discovered such a sense of peace that it was done. She called me and told me the whole story and was so blessed that the Courts of Titles and Deeds had brought great revelation and freedom for her land, but had also increased her faith. These courtrooms are real and will bring answers to us if we believe and engage them.

This court is not limited to merely the ownership issues of lands and houses but also can extend to the ownership of people. Some people have literally been purchased as a possession of others. We often think of the sex-slave trade, but it extends further than that alone.

When someone has upon them a claim of ownership that is not the Lord, a Transfer of Title may be required to get them free and restored to his or her rightful owner. In Psalm 24:1, the Lord lays claim to the earth and all who dwell in it.

The earth is the Lord's, and all its fullness, the world and those who dwell therein.

Therefore, every inhabitant of this planet can rightfully be claimed as the property of the Lord of Hosts. This concept extends beyond this as well. Some (as a result of witchcraft, sorcery, and the like) have had their souls fragmented and scattered to the far parts of the universe—to the distant stars, planets, and constellations. Since Jehovah God is the creator of all, EVERYTHING belongs to Him—regardless of where it is. The request for a Transfer of Title or cancellation of any false title or lien against someone's person or property needs to be requested. The blood of Jesus ransomed EVERY human that has ever lived.³ Then seek the restoration of every fragmented part of their soul to be brought back to them, then in the Court of Times and Seasons, request that their whole being is brought into alignment with the timing and purposes of God.

Do you have a property situation that needs to be dealt with in this court? Do you have land that will not sell? Do you know of a property that seems cursed? Do you know of an area where nothing seems to be successful on that particular site? Are you considering buying a piece of property? Should you consider going to the courts to know

the status of that property? What needs to be dealt with before buying? Will it be a good investment?

To apply this to what we have discovered recently in this court, simply access the court and make the inquiry about any outstanding liens or false titles affecting the property, then respond accordingly. You can use the QuickGuide in the next chapter as a tool for a head start.

Chapter 8

QuickGuide for the Court of Titles & Deeds

This chapter will guide you through a typical procedure for bringing someone to freedom from outstanding liens or false titles. Although I hesitate to produce this because some will make this a hard and fast method, that is not my intent. I have found that if I can provide you a loose guide that it will help you learn the basics until you are able to do this on your own. When using any of the QuickGuides, I produce (see www.courtsofheaven.net for additional resources) they are only jump starters.

We step into the realms of Heaven (see Chapter 11 for how to do this).

We ask permission to access the Court of Titles and Deeds and ask:

*Are any outstanding false titles or liens active
against _____'s life?*

Await the answer; it is typically a “yes” or “no.”

What do these involve?

Await a description, word, or picture. Often it will be only a word or two or a simple image.

The person(s) responsible created bondage to the person we are in the court for. The offending party has sinned against them, and we must forgive them (John 20:23⁴). At this point we do the following:

*Your honor, we choose to forgive _____. We **forgive** them, we **bless** them,⁵ and we **release**⁶ them from this sin and its penalties.*

If the issue was a sin committed, then:

Your honor I repent for _____ and ask your forgiveness. I ask that the blood of Jesus cover this sin now.

If you have embraced a lie and it caused this lien or false title to come into play, then:

⁴ John 20:23 If you forgive the sins of any, they are forgiven them; if you retain the sins of any, they are retained.

⁵ Luke 6:27-28 But I say to you who hear: Love your enemies; do good to those who hate you, ²⁸ bless those who curse you, and pray for those who spitefully use you.

⁶ Luke 4:18 The Spirit of the Lord [is] upon Me, because He has anointed Me [the Anointed One, the Messiah] to preach the good news (the Gospel) to the poor; He has sent Me to announce release to the captives and recovery of sight to the blind, to send forth as delivered those who are oppressed [who are downtrodden, bruised, crushed, and broken down by calamity]. (AMP)

Your honor, I repent for embracing the lie that brought this situation into my life. I ask for your forgiveness and ask that this situation be remedied in my life.

Often you will sense a release. Once you feel this portion is complete, ask the following question:

Are any other false titles or liens active against this person?

Again, await the answer and follow the procedure in the previous paragraphs. Finally, you will ask:

Are any other false titles or liens active against this person?

[Typically I will limit the number of false titles or liens that we are dealing with to possibly 5 or 6 at a time. We will deal with them and then return to continue the query.]

And you will get no response. At that point, make your request.

Your honor, I request that every false title be invalidated and every lien be marked Satisfied that has been against _____'s life.

As you observe the Just Judge, you may see him pouring through papers and signing or marking them in some way. He may stamp them and hand them off to a bailiff for distribution by the angels in the Court of Angels.

[In the event the Just Judge does not hand the paperwork to the bailiff, then we will step into the Court of Scribes and receive the paperwork, then deliver it to the Court of Angels for distribution.]

[You will often find that Holy Spirit has already hinted that He will be dealing with a particular issue by bringing it to their mind in the days immediately preceding the court session.]

We are not finished yet, however. Whenever someone (or some entity) has placed a lien or enacted a false title, it invariably creates situations where their life has been thrown off track. They may feel as if their life is “off-schedule.” We want that corrected, and God has wonderfully provided the means to make that happen...via the Court of Times and Seasons. We will cover that procedure shortly, but first, we need to cover a variation of the steps we generally take in this court.

Chapter 9

Correcting Time

The Lord in his incredible wisdom has provided a means to get our lives on track. Often we get thrown off-track by situations, sicknesses, traumas, and events—and yes, by sin. When that occurs, we need that loss of time corrected. For that, we access the Court of Times and Seasons. Within this court, lost years can be erased, and we can get our lives in synchronization with God’s timing for us. At other times, we have gotten ahead of God’s timing and need our “clock” turned back to get in sync with God’s timetable for our lives.

Certain things in our lives have specific points in time in which they are supposed to happen. When interferences to that set time come into our lives, it can create a cascading effect of missed opportunities, missed relationships, and missed blessings. Much like the troubles, one can face if they miss their airline flight and their trip had connecting flights. We miss one flight, and it causes us to miss the next flight and so on.

On a recent trip with a team to India, weather in the New York area was delaying our departure from Charlotte, North Carolina. We were told the trip was being delayed by an hour or so; then when that time came and went, we were told another targeted time. That came and went. All the while our layover time was disintegrating a moment at a time. We had an international connection to make and the time for its departure was fast approaching. Finally, we were allowed to get on the plane for our flight. Then, a while later we were made to disembark the aircraft. They announced the flight was canceled. Our window of time to make the trip to Newark, New Jersey was gone.

Now we had to make arrangements for another flight to our final destination. We booked with another airline, but the flight was scheduled to leave the next day. We had to arrange a hotel to stay overnight. Meanwhile, our luggage was still on the plane. That original flight eventually did take off to Newark...complete with our entire luggage. So now we are heading to a hotel for an overnight stay with no luggage. Fortunately for me I had a change of clothes in my carry-on bag, but the other team members did not.

Missing the first flight caused us to miss the second flight. The scheduled pick up for us in New Delhi was missed as well. This one event—originally a weather delay—caused a series of events.

Yes, we did arrive a day later in which our scheduled flight recovery day disappeared, and we immediately had

to begin our seminar with no time to recover—all without our luggage too! Four days later our luggage arrived. Hallelujah! Right timing is important. Some situations have specific windows of time in which to happen. We must be on track to make the connection.

In other situations, we are ahead of the timing of the Lord. One of the strategies of the enemy is to push us to do things before either we, or others, or other things are ready. To be ahead of time again can result in negative repercussions. Many times, ministry assignments you may have are co-dependent. Others are to play a vital part, but they haven't arrived at that particular point in time, or the resources needed have yet to arrive, or the venue is not ready or available. When Solomon wrote, "there is a time for every purpose under Heaven," he was saying far more than we realize. Often those times are precise with little leeway for the intersection of all the pieces.

You may say, "But can't God just shift things around and make it happen?" Possibly, but should He? We sometimes want him to bail us out and excuse our disobedience or lack of sensitivity to what He is doing. Just as an earthly father should not always bail their children out of situations, so our Heavenly Father does similarly and does not bail us out of some situations. We need to learn the lesson of full obedience.

The "process" we follow to get timings readjusted is simple—wonderfully simple. We will outline it here and illustrate it with a few examples from our experiences.

We ask permission to enter the Court of Times and Seasons, and upon receiving permission, we step in. You may be aware of the many clocks in the room, or of the sound of the ticking of clocks. It is as if you have entered the shop of a Master Clock Repairer. I have sensed the tick-tock sounds, the ticking sounds of all types of clocks...even clocks that are linear in shape and not round as is typical.

We announce,

We are here in regard to a readjustment of time for

We ask that the timing of their life be synchronized with the timing of the Lord.

We watch and listen.

At this point, the Lord will have angels begin working on adjusting a clock relating to the person involved. Just observe and wait for a signal of finality—the clock clicking into place, or aligning to the 12 o'clock position, or something similar. You may hear, “It’s done!”

An example:

In one of my early forays into this court, we were aware of the many clocks but were drawn to one particular Grandfather Clock. As we watched it, we noticed a procession of angels marching in cadence in military formation. They came close to where we were standing and stopped. One of the angels stepped out of formation, walked over to the Grandfather clock and opened the door on the face of the clock. He then took his

finger and gently moved the minute hand back a few minutes. He closed the door on the face of the clock and then opened the long door at the bottom where the weights and chains are for rewinding the clock. He pulled on the chains to rewind the clock, closed the door, stepped back into formation, and the angels left. Immediately my friend heard, “She’s on schedule now!”

On another occasion we were in this court, only the scene was slightly different. We saw a clock, and once we had asked for the readjustment of time for this person, we saw the hands spinning furiously ahead. This person’s life had been seriously impacted by some poor decisions years ago, and they had gotten off-track with the timing of the Lord. After spinning rapidly for a few moments, the hands began to slow down and finally got to the 12 o’clock marker, and we heard a loud click. They were now settled into their right timing.

I mentioned a clock that appeared linear. We stepped into the court on behalf of a woman and saw this clock laying on a surface. This clock had a series of gears and bars (I don’t know how else to describe it). Suddenly a group of angels appeared with all kinds of tools and began prying and pushing and pulling on some of the parts. One angel came with a large hammer and began to bang on a part. It was as if the parts of the clock had rusted and could no longer move freely. After several swings with the hammer, a part broke free of the rust and slid into place. Another part was not quite in alignment, so he took his hammer and pounded it like a mechanic trying to nudge a part into its proper place. After a few minutes of watching

this rather comical scene, the parts were freed up and came into sync with one another. The clock began to work properly again. In this woman's life a traumatic event had occurred several years before, and in that arena of her life, she had felt stuck. This visit to the Court of Times and Seasons resulted in her becoming "un-stuck" from this event and could now move ahead freely.

In another scenario, the clock raced backward and stopped. In still another, it ran forward. Often the illustration of clocks hands racing around is a good illustration of what is happening in the spirit. We have to remember that the arena of the spirit is outside of time. Time is for our benefit, so we know to rest our bodies and souls. It gives order to our lives and helps us keep our lives in order.

In all these illustrations we had first been to the Court of Titles and Deeds to get the liens, and false titles took care of. It is wonderful to see the infinite variety of ways the Lord readjusts peoples timing.

Once we have listened for what the Lord is doing in the court, we wait. For one lady she heard the clock click loudly at 12:00—signifying the synchronization of the life and the timing was complete. Whether you hear, see or just "know" follow the peace that will accompany the situation. You will simply have a sense that what you requested has been done.

Once the syncing is complete, we thank the court for helping with this issue and exit. However, we are not done just yet. We still have somewhere else to go.

Chapter 10

What Do I Do Next?

Now that we are in a new place and our ownership issues have been fixed, and we are now perfectly set into the timing of the Lord, we need to know what we are to do next. We have not been in this place before—it is entirely new, and the Lord has provided a magnificent solution.

We can access the Court of Records (Scribes) and ask to see the books concerning where we are right now. We will walk through this in a few moments, but the following information will illustrate it beautifully.

In order to help us learn the Court System of Heaven, the Just Judge has provided a straightforward means of aiding us is a Help Desk. As we are learning to maneuver in the courts, we can just step up to the help desk and describe the issue to the attendant. Then ask, “Where should I go to deal with this?”

Often they (or another angel) will come forth and walk you down the corridor to the appropriate court. Once you

arrive at that court, another angel will be available to assist you.

As I explained this scenario recently to Katherine, she immediately began to engage the Help Desk. She explained her situation and asked for assistance. The angel took her by the hand and escorted her down a large corridor. The ceiling was extremely high, and large rooms were on either side of the corridor. The angel brought her to a place on the right side, and she could see lots of books in the room. I asked her to look above the door for the sign that would tell her where she was. It read “Court of Records.” She stepped in, and another angel asked, “May I help you?” Again, she explained that she needed to see her book for where she was right now. The angel escorted her down an aisle and stopped at a shelf with some books and a large box. Katherine knew this was information for her. She took the box down from the shelf and saw in it what appeared to be USB sticks like you would use with a computer. She could merely touch it, and a video would begin to play. She saw that it had a Fast Forward button, a Rewind button, and a Play button. She could also pause the video to get a closer look at something or someone in the video. As she played a particular video, she recognized someone and knew instinctively she was to meet with them and share some things concerning the Courts of Heaven. She had been hesitant to share things before because she felt she lacked sufficient understanding, but with the experiences she had this particular day (we had been doing a number of things in the courts on this day),

she felt more competent to share her experiences and about the Help Desk.

When she felt she had seen what she needed to see, the angel took the box and put it back on the shelf. They walked back outside and whereupon the original escort was waiting for her.

Previously I shared about the clock that moved forward very rapidly for a long period of time. That involved a man who had made some poor decisions years before that had dramatically affected his life and his family. In working with his wife in the courts, we accessed his book concerning the time in his life when the events first occurred. We had already been in the Court of Titles and Deeds and got proper ownership re-established in his life and were now requesting to see his book for where he was now. As his wife saw his book, she saw pages and pages of negative events being erased. She had a knowing that even events where they (as a family) should have had great times of joy, those times were going to be restored. In his case, the books were being erased all the way back to the time of the first wrong decision and being re-written for his life and his family. The joy that came forth from the knowing the Lord was erasing the past and granting a new future was immense. Only the Lord can delete our history and give us new futures. He can make situations that had been bad as if they had never existed.

The implications for this occurring in people's lives are immense. Your past does not have to dictate your future. It is as if he took a video of your life and cut out the bad

parts and re-rendered the video in such a way you don't even have memories of the bad times, or if you can recall them, the sting or pain in your heart they formerly caused is gone.

¹⁸ Do not remember the former things, nor consider the things of old. ¹⁹ Behold, I will do a new thing, now it shall spring forth; shall you not know it? I will even make a road in the wilderness and rivers in the desert. (Isaiah 43:18-19)

Then He who sat on the throne said, "Behold, I make all things new." (Revelation 21:5)

He can place you exactly where you need to be at precisely the right time so you can move forward with your life.

Redeeming (buying back) the time, because the days are evil. (Ephesians 5:16)*

Walk in wisdom toward those who are outside, redeeming (buying back) the time. (Colossians 4:5)*

*The word translated "redeeming" means "to rescue from losses," or "to buy back.") The Lord is able to cause that to be in our lives.

On another occasion, we were given access to someone's box and in it were file folders. One was marked "Outstanding." We felt instructed to take it out of the box. We were instructed to take it to the Court of Appeals because it contained some false judgments that needed to

be dealt with by that person. In addition, we were told to take out a Requisition Form. It was a requisition for finances, and it had the current date written on it. We were instructed to complete it and submit it with the “Outstanding” folder in the Court of Appeals.

We completed our work in the Court of Records and took the “Outstanding” folder with us and were escorted to the Court of Appeals.

We found the court ready for our appearance. The man with the folder walked up to the judge’s bench and handed the folder to the judge. He opened it and began to read through it. He looked up and asked what they wanted the court to do about the items in the folder. They requested that the false verdicts would be overturned and replaced with righteous verdicts in their behalf that restitution would be made where appropriate, and that help would be given to the man’s wife concerning a situation.

The judge nodded and said, “Petition granted.” We handed him the requisition form also and thanked him for his assistance. He handed the papers off to the bailiff for recording and dispatch by the angels, and we left the courtroom.

In all these events we were aware that we were working within the realms of Heaven. In the next chapter, I will talk about learning to access these heavenly realms in order to maximize your work in the Courts of Heaven.

Chapter 11

Accessing the Realms of Heaven

Author's Note: This chapter is from my book Engaging the Courts of Heaven. It is essential that we understand how to access Heaven as we operate in the various Courts of Heaven. This chapter will help you to engage more fully in the Courts of Heaven.

Atremendous privilege we share in this time in history is the ability to access the realms of Heaven with ease. Many of us were taught that Heaven is only for after you die. Heaven is much more than a final destination on a journey, but also can be a vital aspect of that journey.

What I am about to share is vital in progressing in the various Courts of Heaven. We can access the Mercy Court (see the next chapter) while fully planted here on the earth, but to maximize our endeavors in the Courts of Heaven, we need to learn how to operate FROM Heaven.

In teaching on accessing the realms of Heaven, I often point out some simple facts. If you were to tell me you were a citizen of a particular town, but you could tell me little of it from your personal experience, I would have a tendency to doubt the authenticity of your citizenship. I am a citizen of a small town in central North Carolina. I am familiar with the location of the City Hall, Police Station, hospital, local county courthouse, Sheriff's Department and much more. I know where many sporting events will be held. I know where the parks are. I know many of the stores and restaurants. I am familiar with this small town. Yet, if I were to ask the average believer what they can describe of Heaven from personal experience, the answer will likely be—nothing. They have no personal knowledge of Heaven that they can relate to Me. It does not have to be like that.

In Matthew 3, Jesus informed us that the Kingdom of Heaven was at hand. You could say, “The Kingdom of Heaven is as close as your hand.” Hold your hand up in front of your nose as close as you could. Do not touch your nose. Heaven is closer to you than that. It is not far, far away up in the sky. It is not “over yonder” as some old hymns describe. It is a very present reality separated from us by a very thin membrane—and we can access it by faith. It is very simple.

When Jesus was baptized in the River Jordan, as he came up out of the water IMMEDIATELY the heavens were opened. He both saw (a dove) and heard (a voice coming from Heaven). That one act of Jesus restored our ability to access Heaven. We can experience open Heavens over our

life. We don't have to wait. We can live conscious of the realm of Heaven and live out of that reality!

Everything we do as believers we must do by faith. Accessing the realms of Heaven is done the same way. In Chapter 5, I spoke of how prophetic acts can create realities for us. It is the same with this. You can visualize stepping from one room into another easily. It is like stepping from one place to another. To learn to access the realms of Heaven, you will follow the same pattern.

Stand up from where you are now and prepare to work with me. You can experience the realms of Heaven right now! You don't have to wait until you are dressed up in a long box at the local funeral home or decorating an urn. You can experience Heaven while you are alive!

Quiet yourself down. Turn off distracting background noises if possible. Prepare to relax and focus. Now, say this with me:

Father, I would like to access the realms of Heaven today. So right now, by faith, I take a step into the realms of Heaven. [As you say that, take a step forward.] Imagine you are going from one place to another in a single step. Once you have done so, pay attention to what you see and hear. You may see very bright lights; you may see a river, a pastoral scene, a garden—any number of things. You, right now are experiencing a taste of Heaven. You will notice the peace that pervades the atmosphere of Heaven. You might notice the air

seems electric with life. The testimonies I've heard are always amazing and beautiful to hear.

Now spend a few minutes in this place. Remember, Jesus said to enter the Kingdom you must come as a little child. I often coach people to imagine yourself as an 8-year-old with what you are seeing. What would an 8-year-old do? He or she would be inquisitive and ask, "What is this? What does that do? Where does that go? Can I go here?" If a child saw a river or a lake, what would that child want to do? Most would want to jump in the water.

The variety is infinite. The colors—amazing! The sounds are so beautiful. You can learn to do this on a regular basis. When you access the realms of Heaven, you are home. You were made to experience the beauty that is Heaven.

The reason learning to access the realms of Heaven is crucial to engage the Courts of Heaven. Much of what we do is done FROM Heaven, so we need to learn to engage Heaven and work from it.

Many people tell me they can't "see" visually in the spirit. Often they are discounting the ability they do have. They may be discounting their "knower." Every believer has a "knower" at work within them. This "knower" who is Holy Spirit at work within you helps you perceive things. Whether something is good or evil, He works to guide you more than you may have realized. Most navies that have submarines have a device known as sonar. Sonar gives a submarine "eyes" to see what is in their

vicinity. They can detect by the ping of sonar gives off what the object is. They can determine the distance to the object, and if it is another submarine. They can even identify what class of submarine it might be. But, a video camera would be rather useless underwater.

The military has a similar device for above ground situations known as radar. It functions in the same manner. If a pilot were flying through thick cloud cover, the pilot would need to know what is in his path. Radar becomes his eyes.

Some people function visually. They often see what amounts to pictures or video images when they “see” in the spirit. They may see more detail. Yet one operating by his or her “knower” (their spiritual radar or sonar) can be just as effective as a seer. If you operate more like sonar/radar, don’t discount what you “see” in that manner. It is how I function and I have been doing this type of work for many years.

I can often detect where an angel is in the room (or if it is one of the men or women in white linen and not an angel). I can often detect how many are present and whether they have something they are to present to someone. I can detect any number of things, and even though it is not “visual,” it is still “seeing.” Understanding that operating by your knower is as valid as any other type of vision will set your mind at ease. It will help you to realize you have seen much more than you know and you may know much more than some who only see.

As you practice accessing the realms of Heaven you are beginning a wonderful adventure that will bless your life in amazing ways. Enjoy the journey!

Chapter 12

The Court of Records

or

Court of Scribes

Author's note: Chapter 12 and 13 are modified from my book, Engaging the Courts of Heaven.

Now that you have the decision from the judge, what do you do next? Once a decision is rendered, you need the resulting paperwork. The solution is simple. The Courts of Heaven has a Court of Records wherein records of court proceedings are recorded and kept. It also contains the records of your life...everything you are to do, everything you have done, every word you have spoken is on record here. Throughout this book I will use these terms interchangeably. The angels will make those papers available to you. (In the American court system we have a Clerk of Courts office performing similar functions.). As I enter I will say something like:

I ask permission to enter the Court of Scribes today.

You will likely have a sense that it OK to proceed. As you step into the Court of Records (often these “papers” will be in the form of scrolls). You just ask for a copy of the paperwork from your case to be given to you. I usually say something like this:

I have come seeking the scroll(s) of the verdict just received in the Court of Titles and Deeds (or whatever court you were in).

Hold out your hands as if to receive this scroll or book. You may sense (or see) a scroll. It often takes the form of a scroll or a book. You can read it, but now that you have the paperwork you need to engage the next court. You need to get angels activated to carry out the instructions mandated in those scrolls. We will discuss that shortly, but first, let us examine the ways the verdicts manifest.

As I mentioned they often take the shape of a scroll or a book. These books often look like the old books you would find in the Deed Vault of your local county courthouse. If in the shape of a scroll, understand that both terms: scrolls and books are often used in the Bible. Many times you will see something written or stamped on the outside of the scroll. I have words on various scrolls or books in that court: Cleansed, Healed, Free, Approved, Not Guilty, and more; any variety of words describing the contents of the scroll.

At other times they manifest as sheets of paper. Often like the papers you would receive from the Clerk of Court’s

office. Sometimes you do not “see” but sense or perceive the paperwork in whatever form it happens to be in.

These papers include the directives of the court relating to your petition in the Mercy Court. It may be an order of the court releasing angels to minister to your children, or an order releasing funds for a particular situation, or authorizing certain things be done in your behalf. Any number of things can be in these papers.

On many occasions, many scrolls were issued about a court case. The sense was as if someone loaded his or her arms with a stack of firewood. At times the person could feel the weight of the scrolls on their arms as they carried them.

Yet, having the orders is one thing. Seeing the orders or instructions are carried out, is a different matter. For that, we are going to need angelic help, and with that, we will now proceed to the Court of Angels.

On occasion the Judge will hand the paperwork directly to an angel serving as a bailiff who takes the paperwork to the Court of Records and to for dispatch by the angels. The rule of thumb I follow is that if I don’t see the Judge hand the paperwork to an angel, then I proceed to the Court of Records to receive the scrolls.

If I do see the Judge hand off the paperwork to an angel, I know that I am done, I thank the court for hearing the case and exit.

Chapter 13

The Court of Angels

Upon receiving the paperwork from the Court of Scribes, it is now time to get the verdict enforced. This is where angelic help occurs.

In Hebrews 1:14 we read: “Are they [angels] not all ministering spirits sent forth to minister for those who will inherit salvation?” (That’s us!). The angels are ready and waiting to work on our behalf. As you go through this process, imagine yourself being in a place like I am describing. Imagine yourself handing out the papers or orders to the angels or having them take them from your hands. These prophetic acts create spiritual and natural realities. Do not despise these prophetic acts; they have great power and can do mighty things in your life.

Once you have stepped out of the Court of Scribes, you step into the Court of Angels. The Courts of Heaven complex is like an enormous building with a broad hallway. Off to each side are the various courts. It is easy

for us to imagine stepping out of one court and into another down the hall. Usually, I say something like this:

I request permission to enter the Court of Angels this day.

As we step in, you will often sense a lot of activity in the room. The angels are collecting papers/scrolls from others in the court. They are being dispatched to where ever they need to go. You will announce something like this:

I have received a ruling from the Mercy Court (or whatever court was involved), and I need angels who will carry out these orders.

Angels will step up to receive the orders (it may be one or two angels or a large number of angels. These angels will have all kinds of appearances and be of all sizes. Some look very warlike, others very “normal.” At that point, they will go forth to carry out the instructions that you received from the Court of Scribes.

Once completed, you will notice that even though you “gave away” the scrolls, you still have a copy with you. Take this copy and fold it into your heart. I may say:

I receive this scroll into my heart right now.

I imagine holding this scroll and pressing it to my chest. I am receiving the verdict granted by the Father in the court a short while ago. You will be able to recall what is in that paperwork at later times as you need to. You can

rest assured that the Father has his angels working on your behalf.

With our operations usually complete in this court we exit the court. You may express your thanks for access to the Courts of Heaven.

Once verdicts are rendered from any of the other courts you will usually need to access the Court of Scribes. Then make your way to the Court of Angels following the same process described in the Mercy Court QuickGuide or the Process Chart (available from www.courtsofheaven.net). Remember to be thankful to our Heavenly Father for this tool given to us. We can access and enjoy the realms of Heaven.

We also have experienced some exceptions to this rule where the judge, simply hands the paperwork to the bailiff who takes care of the dispatch to the angels. Those issues are left to the discretion of the judge. It is my practice that if the paperwork has not been delivered to a bailiff, then I will step into the Court of Scribes to receive it, then into the Court of Angels for dispatch.

I step into the realms of Heaven.

I ask permission to access the Court of Titles and Deeds and ask:

Are any outstanding false titles or liens active against my life?

Await the answer. Typically a “yes” or “no.”

What do these involve?

Await a description, word, or picture. Often it will be only a word or two or a simple image.

The person(s) responsible created bondage to the person we are in the court for. The offending party has sinned against them, and we must forgive them (John 20:23⁷). At this point we do the following:

*Your honor, we choose to forgive _____. We **forgive** them, we **bless** them,⁸ and we **release**⁹ them from this sin and its penalties.*

If the issue was a sin committed, then:

Your honor I repent for _____ and ask your forgiveness. I ask that the blood of Jesus cover this sin now.

If you have embraced a lie and it caused this lien or false title to come into play, then:

Your honor, I repent for embracing the lie that brought this situation into my life. I ask for your forgiveness and ask that this situation is remedied in my life.

⁷ John 20:23 If you forgive the sins of any, they are forgiven them; if you retain the sins of any, they are retained.

⁸ Luke 6:27-28 But I say to you who hear: Love your enemies; do good to those who hate you, ²⁸ bless those who curse you, and pray for those who spitefully use you.

⁹ Luke 4:18 The Spirit of the Lord [is] upon Me, because He has anointed Me [the Anointed One, the Messiah] to preach the good news (the Gospel) to the poor; He has sent Me to announce release to the captives and recovery of sight to the blind, to send forth as delivered those who are oppressed [who are downtrodden, bruised, crushed, and broken down by calamity]. (AMP)

Often you will sense a release. Once you feel this portion is complete, ask the following question:

Are any other false titles or liens active against me?

Again, await the answer and follow the procedure in the previous paragraphs. Finally, you will ask:

Are any other false titles or liens active against me?

[Typically I will limit the number of false titles or liens that we are dealing with to possibly 5 or 6 at a time. We will deal with them and then return to continue the query.]

And you will get no response. At that point, make your request.

Your honor, I request that every false title by invalidated and every lien be marked Satisfied that has been against my life.

As you observe the Just Judge, you may see him pouring through papers and signing or marking them in some way. He may stamp them and hand them off to a bailiff for distribution by the angels in the Court of Angels.

[In the event the Just Judge does not hand the paperwork to the bailiff, then we will step into the Court of Scribes and receive the paperwork, then deliver it to the Court of Angels for distribution.]

[You will often find that Holy Spirit has already hinted that He will be dealing with a particular issue by bringing

it to their mind in the days immediately preceding the court session.]

Accessing the Court of Times and Seasons

We ask permission to enter the Court of Times and Seasons, and upon receiving permission, we step in.

You may be aware of the many clocks in the room, or of the sound of the ticking of clocks.

We announce,

We are here in regard to a readjustment of time for my life.

We ask that the timing of my life be synchronized with the timing of the Lord.

We watch and listen.

At this point, the Lord will have angels begin working on adjusting a clock relating to the person involved. Just observe and wait for a signal of finality—the clock clicking into place, or aligning to the 12 o'clock position, or something similar. You may hear, “It’s done!”

With that complete, we now access the Court of Records (or Court of Records)

Court of Records

Upon entering the Court of Records, we make the following request:

I am requesting the records for my life for where I am right now.

If you are in a position of authority in someone's life, you have the ability to go to the courts on their behalf. If they are not under your authority (as in a child to a parent), then you usually need their express permission to pray for them. You can simply ask if you have their permission to pray for them. You don't need to tell them you are going to step into Heaven and go to court for them. They probably don't need to know that. At times the Lord will have you interceding for someone for whom you don't have specific permission or authority over. In those situations, if possible, get the cooperation of someone who does have their permission or who is in an authority situation over their life and work with them to bring forth freedom.

Court of Titles and Deeds

Step into the realms of Heaven.

We ask permission to access the Court of Titles and Deeds and ask:

Are any outstanding false titles or liens active against _____'s life?

Await the answer. Typically a “yes” or “no.”

What do these involve?

Await a description, word, or picture. Often it will be only a word or two or a simple image.

The person(s) responsible created bondage to the person we are in the court for. The offending party has sinned against them, and we must forgive them (John 20:23¹⁰). At this point we do the following:

Your honor, we choose to forgive _____. We **forgive** them, we **bless** them,¹¹ and we **release**¹² them from this sin and its penalties.*

¹⁰ John 20:23 If you forgive the sins of any, they are forgiven them; if you retain the sins of any, they are retained.

¹¹ Luke 6:27-28 But I say to you who hear: Love your enemies; do good to those who hate you, ²⁸ bless those who curse you, and pray for those who spitefully use you.

¹² Luke 4:18 The Spirit of the Lord [is] upon Me, because He has anointed Me [the Anointed One, the Messiah] to preach the good news (the Gospel) to the poor; He has sent Me to announce release to the captives and recovery of sight

*whoever sinned against them

If the issue was a sin committed, then:

Your honor I repent for _____ and ask your forgiveness. I ask that the blood of Jesus cover this sin now.

If they have embraced a lie and it caused this lien or false title to come into play, then:

Your honor, I repent for _____ embracing the lie that brought this situation into their life. I ask for your forgiveness and ask that this situation be remedied in their life.

Often you will sense a release. Once you feel this portion is complete, ask the following question:

Are any other false titles or liens active against _____?

Again, await the answer and follow the procedure in the previous paragraphs. Finally, you will ask:

Are any other false titles or liens active against _____?

[Typically I will limit the number of false titles or liens that we are dealing with to possibly 5 or 6 at

to the blind, to send forth as delivered those who are oppressed [who are downtrodden, bruised, crushed, and broken down by calamity]. (AMP)

a time. We will deal with them and then return to continue the query.]

And you will get no response. At that point, make your request.

Your honor, I request that every false title be invalidated and every lien be marked Satisfied that has been against _____'s life.

As you observe the Just Judge, you may see him pouring through papers and signing or marking them in some way. He may stamp them and hand them off to a bailiff for distribution by the angels in the Court of Angels.

[In the event the Just Judge does not hand the paperwork to the bailiff, then we will step into the Court of Scribes and receive the paperwork, then deliver it to the Court of Angels for distribution.]

[You will often find that Holy Spirit has already hinted that He will be dealing with a particular issue by bringing it to their mind in the days immediately preceding the court session.]

Accessing the Court of Times and Seasons

We ask permission to enter the Court of Times and Seasons, and upon receiving permission, we step in.

You may be aware of the many clocks in the room, or of the sound of the ticking of clocks.

We announce,

We are here in regard to a readjustment of time for

_____.

*We ask that the timing of their life be synchronized
with the timing of the Lord.*

We watch and listen.

At this point, the Lord will have angels begin working on adjusting a clock relating to the person involved. Just observe and wait for a signal of finality—the clock clicking into place, or aligning to the 12 o'clock position, or something similar. You may hear, “It’s done!”

With that complete, we now access the Court of Records (or Court of Records)

Upon entering the Court of Records, we make the following request:

*I am requesting the records for _____’s life for
