END OF SPECIAL ADMINISTRATION

The Waanyi Native Title Aboriginal Corporation RNTBC (ICN 7448) (**the corporation**) was placed under special administration from 15 April 2024 to 18 October 2024 under division 487 of the *Corporations (Aboriginal and Torres Strait Islander) Act 2006* (**CATSI Act**). The special administration was extended until 31 January 2025 and again to 28 February 2025.

I advise that the special administration will end at 11:59 pm (ADST) on Friday, 14 February 2025 and after this time the control of the corporation's affairs will rest with the directors who have been appointed by the special administrator using his powers under subsection 499-5(3)(d) of the CATSI Act.

The directors appointed by the special administrator are:

- Brett Ingram (Independent director)
- Sheryl Hedges (Independent director).

I understand that special administrator has already provided a full report to the corporation in relation to the various matters dealt with during the period of the special administration and information about the corporation's current operating environment.

The Registrar will be monitoring the corporation closely over the next 12 months to ensure it properly transitions back to normal operations.

The corporation will be issued a determination made under subsection 336-1(1) and notice under subsection 453-5(1) of the CATSI Act which will set out in detail the reports and information that are required to be lodged to the Registrar. This will be issued to the corporation in due course.

I ask that the directors carry out their functions and exercise their powers with full care and diligence and in the best interests of the corporation.
