\*Replacement of Completion Paper: There will be a \$30 fee to replace any completion documents/certificates.

\*NSF Fee: There will be a \$35 fee for any dishonored check that is returned by a bank or financial institution.

☐ Students taking the **Drivers Manual/Re-Examination class** are required to complete 36 hours of the course if they have never taken drivers ed. **Students 18 and older** are required to do a minimum of 8-hours for the *Re-Examination class*. Students under 18 may take the eight (8) hour course if they have previously completed driver's education and provide proof of completion (DEC-1: pink or green certificate).

☐ Students under the age of 18 are required to complete a State Approved **Driver's Education Program** and also hold their *Learner's Permit* for 9 months in order to receive their temporary driver's license (**DTS-B**).

**The Driver's Education Program entails three (3) parts:** 36-hours of *Driver's Education (Classroom or Online)*, a 90-minute *Parent/Teen class* (as required by Virginia Code "22.1-205(A)" and 14 sessions of in-car instruction for the *Behind The Wheel Program* (7x50min of Driving & 7x50min of Observation), with other students in the car. Only 2 periods of instruction (Driving & Observation) are given during each appointment. The *Behind The Wheel* instructions are given in a dual-control vehicle which is equipped with a brake pedal on the (passenger) side for instructor use, restraint systems, extra rear view mirrors and a roof top sign. Adequate insurance coverage is carried for this vehicle and all who use or ride in it.

In the event of a scheduled lesson where only one student attends the session, I give Veterans Driving Academy LLC. instructors permission to have my son/daughter receive one-on-one driver training with an instructor.

Any student taking 36 hours of ***Driver's Education Online***, acknowledges that they MUST first complete the 90-minute Parent/Teen class before taking the final test, per the Virginia DMV. Also they MUST complete the course within nine (9) months of registration. And there will be **NO** refund after starting the online course.

**Students 18 and older** who obtained a learners permit and have held it for at least 60 days before taking the *Final Road Test* at the DMV, in order to get their drivers license, are not required to attend a Driving Training School. However, if students would like to waive the 60-day waiting period, they are required to do the ***Adult Waiver Program*** and complete the State Approved ***Driver's Education Program*** (with the exception of the 90-min Parent/Teen class) in order to receive a ***DTS-D*** form.

**\*Cancellation Policy:** Any Driving Instruction/Behind the Wheel appointment requires at least a ***24-hour notice*** beforehand. A notice is defined as the customer calls their instructor and either speaking to them directly or leaving them voicemail in addition to having sent a text message. The instructor needs to confirm that they have received your notice in adequate time. If the requirement is not met, the 1<sup>st</sup> time will be a courtesy warning from the instructor. However, the 2<sup>nd</sup> time it happens, the offending customer will be fined a \$30.00 cancellation fee. The cancellation fee MUST be paid before the start of the next lesson. There is no fee charged for unavoidable absenteeism or extreme emergency, and the remaining parts of the program will be rescheduled between the instructor and the student.

**\*Refund Policy: Veterans Driving Academy LLC.** will refund all the fees for unforeseen reasons within 30 days of signing the contract, if we are unable or willing to perform our part of the contract within a reasonable time period (30 days). This does **NOT** apply to ***Driver's Education Online***. The refund itself will be a prorated, per diem refund. If an instructor completed sessions, they will be paid for their time spent and sessions/lessons given (estimated by **Veterans Driving Academy LLC.**), and made any time after 10 days of receiving the request. Absolutely no refunds after 3 appointments of Behind The Wheel. The request for refund must be submitted in writing (email to: [shane.k.bellis@gmail.com](mailto:shane.k.bellis@gmail.com)).

**\*Liabilities:** Students (over 18 years of age)/Parents/Legal Guardians will be held liable for any willful (or intentional) destruction of school property (automobile, books, office equipment, building, etc.) caused by the student.
