Agreement



The following is an agreement that all parents are required to sign prior to joining the program. This helps establish clear expectations for all involved. By signing this agreement, I confirm support of my child's commitment to become a participant of MathFit.

1. I acknowledge that any deposit and/or fees paid are non-refundable. If we change our mind and decide not to honor our commitment to the program, I understand that this deposit will not be returned. I also understand that if we leave the program before the end date, no fees already paid will be refunded.
2. I commit to making sure my child is present and on time. Results heavily depend on attendance.
3. I will be sure that my child is properly equipped to participate fully. This includes proper clothing, footwear and mindset.
4. I will be sure that my child is properly hydrated and fueled for participation.
5. I will be respectful to staff and/or other participants.
6. I will trust my child's instructors. My job as a parent is to support my child. While not easy, I will let go and allow my child to perform, succeed, and fail.
7. I will refrain from teaching over the instructor. I know that providing potentially conflicting messages during a game can be confusing to my child and my interactions may contribute negatively to his ability to focus. If there is something I believe my child needs to know, I will talk to him about that or work on that situation at another time. Whether he/she remembers these things during a demonstration is not my responsibility. I will allow him to learn and fail.
8. I will be a role model for my child regarding good sportsmanship, work ethic, and resilience. These things start with the adults, and the children will behave accordingly. We will take pride in how we carry ourselves and treat others.
9. I will provide encouragement and support for my child as they learn new skills and concepts. My child needs to hear my positive encouragement.
10. I will support the instructor's message. While I will not always agree with the instructors, I also understand that contradicting that message is counterproductive.
11. I will help nurture a positive environment on and off the field. I will do my best to keep a positive tone as I realize my reactions impact my child, other parents, and the team.
12. I will refrain from public complaints about instructing and other participants with parents. While I will not always agree with instructors, I know these reactions do not help.

13. If there are disagreements about how my child is used, I will have my child schedule a time to discuss this with instructors. If after my child discusses his role with instructors and questions remain, I can schedule a time to discuss this with the instructor.

14. I understand that pictures and/or videos of my child may be taken and posted on the Padres' social media page to promote our organization and accomplishments; individual names and spotlights will not be used.

I will do everything make this a positive experience for my child. I will do my best to follow these agreements. I will not neglect nor ignore these agreements. Depending on the severity and frequency of infractions, I understand that my actions may impact the standing of my child on this team. If my child is removed as a result of rule violations from him/her or their family, I understand that a refund of fees will not be issued. I understand these rules.
