

MI3CD Democrats Caucus Meeting Minutes

February 22, 2025

- I. Call to Order 1pm
 - A. Temporary Chair Gary Stark, as the designee of Congresswoman Hillary Scholten, called the meeting to order.
 - B. Gary Stark appointed Chris Herweyer to serve as temporary Secretary for the caucus meeting.
- II. Credentials Report
 - A. Gary Stark closed credentialing at 1:05pm
 - B. Chris Herweyer reported that 57 delegates were credentialed for this caucus meeting with 40 coming from Kent County, 14 from Muskegon County, and 3 from Ottawa County.
- III. Rules Report
 - A. Gary Stark gave the rules report as described on the MI3CD website.
- IV. Election of Officers
 - A. Chair As the only candidate to file, Donna Secor Pennington was elected Chair of the MI3CD Democrats by acclamation and assumed the gavel for the remainder of the caucus meeting.
 - B. Vice Chair As the only candidate to file, Gary Stark was elected Vice Chair by acclamation.
 - C. Secretary Nominations opened. Chris Herweyer was nominated for Secretary. Nominations closed. Chris Herweyer was elected Secretary by acclamation.
 - D. Treasurer Nominations opened. Richard Williamson was nominated for Treasurer. Nominations closed. Richard Williamson was elected Treasurer by acclamation.
 - E. At this point in the meeting, Mark Totten, former US Attorney for the Western District of Michigan and 2014 Democratic nominee for Michigan Attorney General, was given the opportunity to address the caucus meeting.
